4. APPLICATION FOR A VARIATION OF A PREMISES LICENCE IN RESPECT OF: THE LION HOTEL, HIGH STREET, LEINTWARDINE, SY7 0JZ - LICENSING ACT 2003	3 - 8

Proposed New Conditions offered for normal day to day operation and for events of 300 people

- a) The maximum capacity for any event shall not exceed 300 which includes staff, performers and all persons
- b) There will only be a maximum of 6 events per annum of less than 300 people.
- c) Each 24 hour period will form one of the 6 events.
- d) All events will be restricted to the 24 hour period.
- e) The terminal hour for licensable activities shall still apply for conclusion of the event.
- f) Live Amplified Music shall cease at 2300 hours in the outside area.
- g) Recorded Music will cease at 01:00hrs.
- h) No amplified public address system shall be used after 00:00hrs (including that used by any DJ) unless in the event of an emergency

Proposed Conditions offered for events of more than 301 people

- i) The maximum capacity for any event shall not exceed 1200 which includes staff, performers and all persons
- j) There shall be no more than 6 events per annum of more than 301 people.
- k) Each 24 hour period will form one of the 6 events. The license shall be restricted to no more than 2 such events on consecutive days in any calendar year.
- l) The terminal hour for licensable activities shall still apply for conclusion of the event

Suggested by Licensing

Proposed New Conditions offered for normal day to day operation and for events of 300 people

- a) The maximum capacity for any event shall not exceed 300 which includes staff, performers and all persons
- b) The licence is restricted to only 6 days per annum for events of less than 300 people. (A day is defined as any 24 hour period)
- c) No event shall last for more than 24 hours.
- d) The terminal hour for licensable activities shall still apply for conclusion of the event.
- e) Live Amplified Music shall cease at 2300 hours in the outside area.
- f) Recorded Music will cease at 01:00hrs.
- g) No amplified public address system shall be used after 00:00hrs (including that used by any DJ) unless in the event of an emergency

Proposed Conditions offered for events of more than 301 people

- h) The maximum capacity for any event shall not exceed 1200 which includes staff, performers and all persons
- i) The licence is restricted to only 6 days per annum for events of more than 301 people. (A day is defined as any 24 hour period)
- j) Each 24 hour period will form one of the 6 events.
- k) The licence shall be restricted to two events per calendar year, of a period not exceeding 48 hours (2 days). All other events will be restricted to the 24 hour period.
- l) The terminal hour for licensable activities shall still apply for conclusion of the event.
