Thank you for your email with respect to the licensing application for the lion at Leintwardine. We have had a look at this and also discussed it with Ian Connelly when he was in earlier this week in connection with other events.

We consider that any event would need an extensive traffic management scheme, provided by a traffic management company to give pedestrians a safe route from the parking field to the venue and vice versa. There would also need to be management/signage for vehicles in and out of the parking field.

Subject: Licensing Application for the Lion, Leintwardine

Good afternoon Fiona

I have been on a site visit with Cllr's Greenhow, Seldon and Swinglehurst to The Lion Hotel, Leintwardine this morning. The Lion have made application for a premises licence to hold events of up to 2000, although they are likely to amend this to 1200 people.

One of the issues the Cllr's have is in relation to where will people park. This question has been asked of the applicant who has said that they park vehicles in a field on the opposite side of the river.

The Cllr's are concerned in respect of this proposal. I have to concur with them about this. My concerns is that exiting the field there is no view to the south along the A4113. In fact you have to be in the road before you can see. Whilst in a 30 mph speed limit it is only 10 metres inside. My other concern is that to get to the pub you have to cross the bridge. On the side of the bridge closest to the field and pub there is no footway.

I have attached some google maps to show where the entrance is etc.

The members have asked me to contact Highways and get their opinion concerning the use of the field proposed for parking, particularly in relation to public safety.

The matter is back before committee on 14th February.

Can you or someone assist them?
