They have invited 14 Morris teams to attend the event (teams will be coming from Lancashire, Northampton Shire, Birmingham, Wales as well as local sides). There will be dance displays from 11.00am around Ledbury including under the Market House, in the vicinity of the Masters House and at the Talbot Hotel. The owners of the Barn have offered to be open on that date to provide refreshments for the teams and a place for music making. The teams will be in Ledbury throughout the day and will be going home late afternoon. It will be beneficial for the visiting teams to have refreshments at the Barn and will be a most beneficial support for our visitors.

I write in support of The Barn group and its' proprietors.

Upon my first visit to the Barn I was struck by its' sympathetic restoration, both external and internal, incorporating pleasing sculpture into the structure of the building and displaying strikingly beautiful, local art. The welcoming, informal atmosphere clearly appealed to varied members of the public, the proprietors, Lynn and Robin, were friendly and helpful, and the live music was of high quality, with sound engineer oversight. Upstairs offers a quiet, comfortable seating area on one side and a good view of the musicians on the other side. As a full time wheelchair user I was particularly pleased to find the ground floor fully accessible, spacious and with an ample disabled toilet. (I am not aware of any other music venue in Ledbury offering such facilities and few, if any, licensed premises). Upon exiting the building, the proprietors advised patrons to respect local residents by avoiding raised voices. As a local resident in the area (since 1985), an OAP, mother, ex-licensee and former university academic, I feel sure that the Barn has wide appeal to both local and tourist visitors and I very much hope it will remain as an asset to the area for years to come.
