STATEMENT of TRUTH – James ROGERS

I am James ROGERS and I am the Director of Claypitt Ltd trading as Redbank Events.

I am aware that there were a number of events and parties taking place in the area of Holme Lacy on the night of 27th July 2019. None of us know for certain where the noise reported by the complainant came from, whether it was Redbank, another venue or party in the area happening that night.

We have been shown no independent evidence to support the allegation. In my opinion neither do the EHO possess any evidence, as by their own admission they did not follow up the noise complaint at the time.


Just as importantly, we have never been made aware of any noise complaint until we made this application over a year later.

We have been shown no information or evidence from the EHO to demonstrate that firstly a noise disturbance occurred on that night, and secondly if it had been investigated or substantiated and correctly attributed to our event.

In my opinion there are a number of possibilities as to where the noise could have emanated from as we have highlighted and in the absence of that evidence any alleged noise complaint should not be attributed to Redbank. In my opinion it is unsubstantiated and unproven, and therefore should be disregarded.

Amended Conditions

The applicant has reflected upon the representations from the public made in respect of this application, and has also benefitted from a site visit from Ms J O'MAHONY from Herefordshire Council Environmental Health where the application was discussed in very great detail.

As a result of these developments, the applicant seeks to amend the application in the following terms.

1. Terminal Hours for ALL Licensable Activities to be reduced to 23:00hrs Mon – Sun.
2. Seasonal Variation in be included to allow the Terminal Hour for Sale of Alcohol, Late Night Refreshment and Live & Recorded Music to be extended to 01:00hrs for one event per year (Friday, Saturday and Sunday) to allow for an Annual Cider Festival on a moveable date, and subject to a Noise Management Plan agreed with EHO (which has already been submitted).
