	the Local Development Framework submission; and  3. Delegated authority be given to the Leader of the Council, in consultation with the relevant Cabinet

Reasons for the Decision:	To afford an opportunity for the implications of the changing legislative context to be fully considered, and to enable further consultation, including a community poll, to be undertaken. Linked to the changes in the LDF timetable, to provide for the continuation of the existing LTP2 to be adopted as an interim LTP3 in the meantime.
Options Considered:	The current planning policies of the Council are set out in the 2007 Unitary Development Plan, which runs to 2011. Whilst these policies have been "saved" and will continue in force until replaced, new planning policies are required to influence and control development for the next plan period – currently to 2026. The LDF will set out these new policies and is a statutory requirement, with no alternative to its preparation.
