unlikely that this would result in a better deal for Herefordshire. The only alternative Bidder on the framework has already withdrawn from the Borders Broadband procurement for commercial reasons. The Authority could decide not to pursue a contract at this time with the Bidder, waiting for commercial NGA deployment to occur in the market towns (timescale unknown) and piecemeal development by wireless / satellite providers delivering USC to rural areas. If this course of action is pursued the county would not receive the BDUK financial support. The Authority could re-run the procurement based on a different type of project e.g. subsidised wireless to deliver USC to areas where USC speeds cannot be accessed. This would not be considered an NGA deployment by the EU and as such would not be State Aid compliant as an investment into NGA due to issues of scale and open As a result, the BDUK funding would be access. withdrawn.
