This approach cannot be realised without significant capital investment from Council funding. This position is regarded as no longer sustainable and an alternative approach is needed. | |
| | The Council has committed itself to a major redevelopment on the Edgar Street grid Hereford. This can potentially include a new Library and One Stop Shop (INFO in Herefordshire). Significant work will be required to ensure any plan is coterminus with the overall Edgar Street development. | |
| Options Considered: | 1. Maintain existing provision at Broad Street. This is not sustainable and retention of the current service in the long term will have a significant detrimental effect. The Council's public assessment is likely to be significantly affected in respect of its Cultural Services provision.
