586. QUESTIONS FROM MEMBERS OF THE PUBLIC

587. MINUTES

George Salmon drew the Partnership's attention to Minute 570 (**MERRY-GO-ROUND NURSERY**), and reported that he had received a briefing note from Nikki Ovel, on her strategy following a serious fire at Merry-Go-round Nursery. He said that he would circulate the note to all childcare settings.

AGREED: that the minutes of the meeting held on 09 March 2006 be approved as a correct record and signed by the chairman.

588. CHILDREN AND YOUNG PEOPLE'S PLAN

Sue Fiennes updated members on progress made with the Herefordshire Children and Young Peoples' Plan (C&YPP). The Key points were:

- The C&YPP had been adopted by partner organisations and the C&YPP Board, and also by Cabinet in March 2006. All Herefordshire Councillors now had a copy, and it was to be considered at full Council on 12 May 2006.
- On Page 33 of the Plan, under the title "Where do you want to be?", the EYDCP was mentioned; therefore the partnership's status would be addressed.
- It was important now to improve Public understanding of the work of the C&YPP, and EYDCP, and to recruit the help of the Council's Communications Dept to help promote it.
- The Extended Schools model presented a considerable challenge, and it was important for the Schools Sector to work with its Early Years colleagues. Recently both sectors had been invited to discuss budgetary issues, so that Extended Schools became more of a joint endeavour. Weobley High School was an example of best practice, and how the model could work well, and she hoped to roll out a similar strategy for models elsewhere in Herefordshire.
- The "rural environment" presented a unique and ongoing challenge for Herefordshire. It would be necessary to find creative ways to manage the rural areas, and deciding how to deliver the C&YPP in rural areas was a fundamental part of the action plan to be developed.
- Klaus Wedell pointed out that the DfES was aware of the creativity and lateral thinking needed in Herefordshire, and it put the county very much in the "front line" with developing a rural strategy.
- Sue Fiennes emphasised that any suggestions from the EYDCP would be welcomed at any time.

589. NURSERY EDUCATION FUNDING: EXTENSION TO 38 WEEKS

George Salmon reported that, following the meeting held on 09 March 2006, Karen Beadman had contacted all Private, Voluntary and Independent Early Years providers. A number of them had also visited her to discuss the issues surrounding the forthcoming increase in Nursery Education Funding from 33 weeks to 38 weeks per year. Over 70% had expressed a preference for the profile option based on a variable number of weeks per term. As a result, this was the option that the Council would implement from the Autumn Term 2006.

590. FINANCIAL REPORT 2005/06 AND 2006/07

Ros Hatherill presented budgets for 2005/06 and 2006/07. She circulated detailed information on the current budget to the end of the financial year April 2006, the planned Budget for 2006/07 (which included Transformation Funding), and the Revenue and Capital Budgets for Children's' Centres for the 2 year financial period 2006/07 – 2007/08.

AGREED That the planned budget as laid out for:

- Part A where the current budget is, at the end of the Financial Year March 2006;
- Part B The Planned Budget for 2006/07, including the Transformation Fund;
- Part C The Planned Revenue and Capital Budget for Children's' Centres, for 2006 2008.

591. THE ROLE AND FUNCTION OF THE EYDCP

The Partnership considered a brief report from Klaus Wedell and Ros Hatherill about the continuing role of the EYDCP, and its wider role within the Herefordshire Children and Young People's Plan. This included parts of the EYDCP constitution which it had become necessary to revise, in order to bring it up-to-date with current developments, guidance and legislation. Sue Fiennes emphasised that, in her opinion, the EYDCP should continue regardless of any shifts in legislation and guidance arising from the Herefordshire C&YPP. It was possible that the EYDCP would take on a monitoring role, and would act as an interface between Herefordshire Council and other organisations in the Private, Voluntary and Independent sectors.

Klaus Wedell asked members to consider the EYDCP's role in terms of function, membership, and meeting arrangements. They formed discussion groups, and made the following key points:

Group 1

• Function: Need to emphasise consultative role;

A means of disseminating information/marketing tool. Can use parish newsletters for this, and Herefordshire Matters and Core News;

Reporting role to the Children and Young People's Board/Children's trust. EYDCP could reform any split decisions on particular issues;

Not technically a decision-making body, so we need to look at what we should be making decisions about.

• Membership: Should we have a single Rep from Children and Young People's Directorate?

Parent representation is becoming more important. In particular, in October, will be Service Advisory Groups. It will be important to have one Rep from each Parental Advisory Group;

If a Rep does not attend regularly, we need to have a mechanism to request a replacement.

• Arrangements Earlier meeting time might be better. Variety of venues is helpful to some who are not Hereford-based.

Group 2

• Function: Ensuring quality outcomes for children;

Consultative Role;

Examining processes;

Sharing information. This is a 2-way process between Partnership and all involved organisations;

Link to the Children and Young People's Partnership Board;

Is it time to change the name of EYDCP to make it more appropriate to its function?

- Membership Must re-instate the representation that has tailed off, and ensure that people are replaced when they leave.
- Arrangements Agenda length is currently prohibiting. Should consider only having one major item. Should also be a wider variety of contributors – maybe a "theme" for every meeting;

Group 3

- Function Methods of review are we doing things the best way? Some terminology in reports needs reviewing – for example the EYDCP "agrees" Nursery Education Grant, but in reality, it can only "acknowledge" because the decision is taken by another group.
- Membership Parental representation required from Children's Centres; Must ensure that Reps are representing their members properly;

• Arrangements It is insufficient merely to advertise the dates and times of meetings – instead, EYDCP needs to feed more information to the public about what is happening at meetings and in Children and Young People's Directorate in general.

AGREED: that:

- (i) the above comments be considered in discussion with Sue Fiennes, in order to update the function, membership, and meeting arrangements of the EYDCP; and
- (ii) any changes to the EYDCP constitution be notified to and approved by Council where necessary.

592. CHILDMINDING SUB-GROUP

Alison Murphy reported on a proposal to adopt the existing Childminding Steering Group as a formal Sub-Group of the EYDCP. The steering group had been set up in 2001/02, to support the partnership between the EYDCP and the National Childminding Association (NCMA). Since its inception, its membership had grown, training and development had increased, and the Childminding Team's range of work and professional services had expanded to such an extent that there was merit in making the steering group a formal sub-group of the EYDCP. This would ensure that it had strong reporting lines to both the EYDCP and the Policy and Finance Sub-Group.

In addition, members also felt that the group's membership should be further expanded to take account of the Children's Centres and Extended Schools agenda, and to reflect the diversity of the EYDCP.

AGREED: That

- (i) the Childminding Steering Group becomes a formal Sub-Group of the EYDCP, with membership reflecting the diversity of services represented; and
- (ii) the EYDCP notes the considerable achievements of the Childminding Team and of Herefordshire's childminders in general (evidenced by OFSTED reports), the growth in the Network, and the significant rise in the take-up of professional development and qualification training.

593. REQUEST FOR RECEIPT OF NURSERY EDUCATION FUND

Sue Peasgood reported on two requests for receipt of Nursery Education Funding (NEF), from Putson Pre-School Nursery and Little Acorns. Both settings had been registered by OFSTED, were fully operational and had agreed to the terms and conditions required for the funding. Little Acorns was an existing Neighbourhood Nursery which had expanded to a new full day care provision; Putson Pre-School was a completely new setting.

Bryan Twitty pointed out that, in general, the EYDCP was not the approving

body for NEF funding; rather, its role was to acknowledge that the settings in question had agreed to abide by the rules and policies set out by the EYDCP. Sheila Dunsford said that the EYDCP had the power to agree to withdraw NEF under certain circumstances, however (when a setting became inadequate), and that a paper on this subject would be issued in due course.

AGREED: that:

- (i) Putson Pre-School and Little Acorns new provision be included in the Herefordshire Directory of Providers in order to receive Nursery Education Funding from September 2006; and
- (ii) The EYDCP considers the paper on NEF funding at a future meeting.

594. TRANSFORMATION FUND

Alison Murphy provided information on the Transformation Fund and its implications for Herefordshire's childcare workforce. The fund was new, and had been allocated from the Government to assist long-term transformation of the quality of childcare without compromising its affordability. The Fund was to be spent on Early Years provision. The Fund would be available until 2008 initially, to establish approaches to workforce development, and to help inform future policy decisions. Specifically, the Fund would support the transformation of quality in early years settings by:

- Establishing training routes for a new graduate-level status of "Early Years Professional";
- Providing finance for staff wishing to train as Early Years Professionals;
- Supporting progress towards the Government's objective of having an Early Years Professional in all full daycare settings by 2015;
- Boosting the qualifications of staff in Private, Voluntary and Independent settings (particularly by achieving more Level 3 Qualifications and training more staff to work with children with disabilities SEN.

The funding allocation for Herefordshire was $\pounds 187,559$. Alison Murphy had asked the DfES to clarify its rationale, particularly because it wanted to assess Herefordshire's spend as early as September 2006, and she was concerned that this would give a false picture because most early years activity only started in September.

In addition, Alison Murphy reported that Herefordshire was piloting an Early Years Professional Status scheme, and there was a consultation about this in the Council's website.

Members noted that there would be a further report on the Transformation Fund after the allocations had begun.

AGREED: that:

(i) the EYDCP acknowledges the new, ringfenced funding stream, called the Transformation Fund, which aims to raise the quality of Early Years provision; and

(ii) a progress report on the Transformation Fund be considered at a future EYDCP meeting.

595. EARLY YEARS FOUNDATION STAGE

Sue Peasgood reported on a public consultation for the proposed Early Years Foundation Stage (EYFS). The new EYFS would cover the period from birth to the end of the academic year in which children become 5 years old. It would bring together the current "Birth to Three Matters Framework", the "Curriculum Guidance to the Foundation Stage", and elements of the "National Standards for Under 8s Daycare and Childminding". It would thereby create a single framework set in the context of Every Child Matters.

Alongside these proposals, there would also be a review of the National Literacy and Numeracy Foundation Stages. The aim of the proposed changes was to deliver improved outcomes for all children across every area of learning and development. There would be a continued emphasis on high quality interactive play, and on the Early Learning Goals.

The consultation would take place during summer 2006, up until 28 July. Comments could be made through the DfES website, or by telephoning the DfES on a dedicated number. Sue emphasised the importance of expressing views on the proposals, and said that she would write to all settings and schools to alert them to the consultation.

Following the consultation, training for the new EYFS would begin in 2007, and it would become statutory in September 2008.

AGREED: that the EYDCP notes the introduction of the proposed Early Years Foundation Stage, and notes the importance of EYDCP members and Herefordshire early years practitioners responding to the formal consultation during summer 2006.

596. QUARTERLY CHILDCARE REPORT

The Partnership noted progress made against childcare targets in the Two-Year Plan (2004-2006), for disadvantaged and non-disadvantaged wards. The report covered Period 4 of 2005/06, and indicated that the targets set at the beginning of the period would be met.

During the course of the 2-year period, the DfES had removed the stipulation, and funding constraints, placed on the EYDCP regarding place creation within disadvantaged areas. This meant that the available funding could then be used to support settings anywhere in Herefordshire. The definition of a disadvantaged area also changed, and "Super Output Areas" became the new measure; a move that significantly altered area boundaries. These two factors combined made the tracking of disadvantaged areas irrelevant.

Bryan Twitty reported that only the total overall number of places created was now tracked. This had to be offset against the number of closed places

in order to get the true picture of how many new places had been created. He added that there was no longer a national requirement to report the ratio of places closed to places opened.

AGREED: that:

- (i) the progress made with targets over the period 2004-2006, be noted, and
- (ii) it be noted that the EYDCP has no set targets for the forthcoming period, other than the creation of Children's Centre childcare.

REVIEW OF THE EYDCP BOARD'S DEVELOPMENT

CYPD Children and Young Peoples Directorate
EYDCPB Early Years Development and Childcare Partnership Board
CYPP Children and Young Peoples Plan
CYPB Children and Young Peoples Board
CCLPG The Children's Centre Locality Partnership Groups

BACKGROUND:

The creation of the Children' and Young Peoples Directorate (CYPD) prompts a review of the infrastructure, which supports it and this includes a review of the place the EYDCP Board (EYDCPB) within it. The EYDCPB and its constitution was originally established under the Sure Start legislation, and at the two last meetings of the EYDCPB, its role and function was discussed in relation to the Herefordshire Children's and Young People's Plan (CYPP).

Herefordshire Council has established three services within the CYPD to operate under a Children's and Young People's Board (CYPB). There is a proposal to set up an Executive Arm and a Children's Trust Office. The Early Years and Childcare Service, incorporating Children's Centres and the Extended Schools Programme, form part of the Integrated Services and Inclusion Service. Each of the Children's Centres will set up a partnership group of service providers and users for their locality, which will also encompass extended services activities (Extended Schools)

EYDCPB DEVELOPMENT ISSUES:

The development of the EYDCPB remit needs to be considered in relation to role and function of the:

- CYPB
- The Children's Centre Locality Partnership Groups (CCLPG)

This paper offers suggestions about how the development of the EYDCPBs remit can be conceptualised in the new administrative context of the Children's Directorate and the development of Children's Centres and Extended Services.

The inter-relationship of the EYDCPB and the CYPB:

The EYDCPB will need to continue to serve the following roles and functions in connection with the Authority's Early Years (EY) and Extended Services (ES), which includes extended schools administration:

- enabling the interface between the local authority and the public, private and voluntary providers
- the agencies and bodies involved in EY and ES provision (eg: OFSTED, LSC, NCMA etc)

- providing a forum for the detailed consideration of the development and implementation of national and county-wide policy and practice, including the CCLPGs
- facilitating the democratic involvement of the larger constituency of EY providers and users (Potential 'Refreshment' of EYDCPB membership to be fully representative, together with written specifications of roles)
- providing feedback about the implementation of national policies and county-wide policies to the CYPB
- delegated oversight of the implementation of quality, workforce development and information
- The overall management of the demand and supply of childcare places, provision and services, enabling sufficiency for Herefordshire
- Financial accounting, policies and funding opportunities

The inter-relationship of the EYDCPB and the CCLPGs in connection with the EY and ES administration:

- supporting county-wide consistency in policy and practice in the context of the above functions,
- providing a forum for the county-wide consideration of local concerns
- representing the CCLPGs to the CYPB, the agencies and bodies involved in EY and ES provision (eg: Ofsted, LSC, NCMA etc

ORGANISATIONAL ASPECTS OF THE EPB AND THE EY AND (ES) ADMINISTRATION:

The EYDCPB will report to the CYPB.

The Head of the Integrated Services and Inclusion Service will be a member of the CYPB, and will facilitate the EYDCPB's communication with it.

There will be a link between the EY and ES administration and the Executive Arm.

Operational considerations:

Decision-making:

- in general, the EYDCPB will deal pro-actively with consultation about proposed national and Local Authority implementation of policy and practice.
- in order to avoid excessive time spent by individuals in attending meetings, consideration needs to be given to:
 - the frequency of EYDCPB meetings,
 - o effective ongoing briefing of members,
 - arrangements for urgent decision making between EYDCPB meetings
 - arrangements to ensure that EYDCPB representative members can communicate with their constituents
 - effective interaction with the EY and ES administrative infrastructure.
 - appropriate public dissemination of the EYDCPB's deliberations etc.

The potential of electronic communication needs to be explored

Constitutional specifications:

Representation on the EYDCPB needs to be considered, to include:

- EY and ES provider groupings
- County-wide Agencies involved in EY and ES provision including schools
- National etc agencies involved in EY and ES work (including OFSTED)
- The Local Authority EY and ES administration
- Herefordshire councillors

Arrangements need to be decided about: Representation of the EYDCPB on the EY and ES administrative infrastructure The appointment of a chair and deputy chair.

Servicing of the EYDCPB:

Effective secretarial services to EYDCPB support for the dissemination of the EYDCPB's deliberations.

Nursery Education Funding (NEF) – Cross Border, Monmouthshire, Reciprocal Agreement

Purpose:

To inform the Partnership of contact with Herefordshire parents wishing to receive NEF in a Monmouthshire nursery provision and confirmed arrangements with Monmouthshire Children's Services.

Background:

The EYDCP was contacted in May 2006, both in writing and by telephone by several parents of children eligible for NEF, attending the nursery department of the Haberdashers Redcap School in Hereford. A formal announcement had been made several weeks previously that the school was to close at the end of the summer term 2006.

These parents had chosen to secure places for their children at Haberdashers Agincourt School in Monmouth, a sister Haberdashers, fee paying provision. Previously no reciprocal NEF arrangement had been secured with Monmouthshire.

Discussions were held with officers from Monmouthshire and an agreement was concluded for reciprocal funding for 3 year olds. The 4 year old scenario is more complex in that as Wales is technically a different country and is governed by the Welsh Assembly and not the DfES. The admissions policy in schools is significantly different in that **ALL** 4 year olds are offered a fulltime place in school.

The outcome from this is that in Wales and therefore within Monmouthshire, 4 year old funding is not available and therefore a reciprocal arrangement cannot be secured.

Conclusions:

The Partnership is asked to note:

- 1. Reciprocal funding with Monmouthshire is available for three olds, for those parents, living in Herefordshire. and requesting that their 3 year old children attend a cross border. Monmouthshire setting and those parents living in Monmouthshire requesting a 3 year old placement for their children in a Herefordshire setting. This will be monitored, but it is envisaged that this will only involve a handful of children either way.
- 2. Reciprocal funding can only be in place with Monmouthshire for 3 year olds, because of the differences in admissions policy and the offer of school placement for all 4 year olds.

3. The monies for NEF are grant funded by the DfES and therefore are drawn down against names and numbers of children attending settings. To fund 4 year old Herefordshire children in Monmouthshire, Agincourt, Haberdashers school will result in:

a. Double funding - If parents choose to send their 4 year old children to Agincourt, then they will expect to pay the school fees, as it is their choice to send them to an independent setting in Wales

b. The Children's & Young Peoples Directorate within Herefordshire identifying and having to find funding from another source to cover the costs of 5–21/2 hour sessions (equivalent NEF Rate) for each child attending Agincourt. (For the queries that we had 3 children, then this would amount to approx £3000.00 for two terms).

4. Letters of explanation have been sent to the three families who initially contacted EYDCP.

Facilitating the Childcare Market and Securing Sufficiency

Purpose:

To inform the Partnership of the Childcare Sufficiency Assessments, draft guidance and regulations for Local Authorities to support them in carrying out their duty to assess the sufficiency of childcare

Background:

A consultation document was launched by the DfES on 14th August 2006 (attached for information)

This consultation seeks the views on the Local Authority duty to set out in section 11 of the Childcare Act to conduct an assessment of the sufficiency of childcare in their area.

It is anticipated that local authorities carrying out an assessment of sufficiency of childcare within their area as a first step to securing sufficient childcare.

The process will give local authorities the evidence and information they will need, working in partnership with childcare providers and others, to facilitate and shape a childcare market that is sufficient, flexible, sustainable and responsive to parents needs.

The duty to assess the sufficiency of childcare will commence from April 2007.

A free 2 day facilitated pilot strategic workshop has been secured with 4 Children for Herefordshire on 14 November 2006 and 1 December 2006.
