1. APOLOGIES FOR ABSENCE

Apologies were received from Mrs S Catlow-Hawkins, Mrs A Daniel and Mrs E James.

2. NAMED SUBSTITUTES (IF ANY)

None.

3. MINUTES

The Minutes of the Meeting held on the 21 November were approved and signed as a correct record.

4. RESPONSE TO WRITTEN PUBLIC QUESTIONS (IF ANY)

There were no written public questions.

5. PROGRESS REPORT ON THE NEW AGREED SYLLABUS FOR RE

The RE Consultant provided the Conference with an update on progress on the Agreed Syllabus Review. The following points were made:

- That there would be an exemplar unit available for secondary schools at the launch of the syllabus. All units would be finalised within the next twelve months
- That the launches for both the Primary and Secondary schools would be held at Whitecross School in Hereford

Resolved: That the update be noted.

6. 2015/16 SACRE BUDGET UPDATE

It was noted that there was a standstill budget for SACRE for 2015/16 of £5k, which made it difficult to hold more than two meetings a year. It also meant that there was a shortfall for the introduction of the new RE Syllabus, but that funds would be made available from allocated budgets and the sale of the syllabus.

Resolved: That the report be noted

7. RELIGIOUS STUDIES EXAMINATION RESULTS 2014

SACRE received a report on the Religious Studies exam results 2014. It was noted that:

- The number of entries for GCE A level Religious Studies in the county had been lower than the previous year with 76 in 2014 compared to 95 in 2013. This was reflected in the number of entries for GCE AS level Religious Studies in the county which had been 16 in 2014 compared to 26 in 2013 (19 in 2012; 25 in 2011; 18 in 2010).
- Of this year's full A level entries, 100% achieved grade E or above, compared to 99.8% nationally. The AS course saw 100% of learners achieve grade A*-E, compared to 86.4% nationally. Hereford Sixth Form College was the only centre to offer this qualification. The percentage of A*-A grades at A level and A-B grades at AS level in the county outperformed the national figure.

Resolved: the Religious Studies A level examination results for 2014 be noted.

8. UPDATE ON ANY NEW INITIATIVES OR NEWS IN RELIGIOUS EDUCATION

SACRE received a report on new initiatives or news in religious education. The RE Consultant highlighted the following areas:

- That the consultation process around changes to A levels had received a good level of feedback, but that received from schools had been higher for religious studies than for any other subject. A large number of responses were part of a campaign by the British Humanist Association.
- Based on the draft proposals, there would be no limited changes at to the GCSE criteria. As a result of the consultation, significant changes had been made to the A level criteria, enabling schools to continue teaching philosophy and ethics alongside the study of religion
- There had been a reintroduction by the Department of bursaries for those training as RE teachers.
- That World Peace Day would be celebrated at Hereford Cathedral on 20 September.


Actions you will take to follow up from this conference

- Organise staff meetings to relay the information; review resources t support new syllabus
- Review and update action plan for RE
- Lots of new staff/NQTs starting in Sept so will need to plan training with Head. 12 steps very useful!
- Review timetabling for RE, long-term plan for mixed age classes, Consider SoW redraft in school or purchase?
- Will review whole school two year rolling programme and adjust for new syllabus. Will support NQT and staff with changes and resource requirements.

Suggestions/requests for future support in Herefordshire



Chairman's Foreword

It will be good to be working more closely with Worcestershire SACRE now that we are following the same syllabus and teachers from our two counties will have more opportunities to meet. Finally, I want to thank all our Herefordshire RE teachers for their hard work during the year and giving RE the high profile it deserves in our schools. We must never lose sight of the importance of RE in our changing world, however limited our resources

1 Herefordshire SACRE Annual Report 2014-2015

The Standing Advisory Council on Religious Education (SACRE) is a statutory body set up to advise the Local Authority on matters related to religious education and collective worship. Its members are drawn from teachers, Local Authority representatives including Councillors, faith representatives from the Church of England and a range of Christian denominations, and representatives from other religious groups represented in the region.

SACRE's key functions include monitoring the provision and quality of RE, and providing advice and support on the effective teaching of RE in accordance with the agreed syllabus. This includes advice on methods of teaching, choice of teaching material and provision of teacher training. This is primarily done through the review and implementation of the locally agreed syllabus, a process which is required every five years. This is followed by on-going monitoring of its effectiveness in the light of changing national education policy.

SACRE is grateful to Herefordshire County Council for its continuing support, but notes that in the current reduction in funding across the Council, SACRE has not been spared. SACRE endeavours to offer maximum support to schools through its use of conferences and network meetings. However, it has had to reduce the number of SACRE meetings from three to two, replacing one with a meeting of a 'strategy group', who undertake to prepare reports or undertake research to move the business of SACRE forward.

SACRE were grateful for the support of Bonnie Griffiths during 2014-2015, School Improvement Advisor, who was the LA officer on SACRE.

Herefordshire SACRE met twice in 2014-2015. The minutes of these meetings are available from David Penrose, Clerk to SACRE (dpenrose@herefordshire.gov.uk).

2 Supporting RE in Herefordshire

The key activities of SACRE over the period 2014-15 have focused on maintaining support for teachers through the development of a revised agreed syllabus for RE, launched in summer 2015. The SACRE meeting in November 2014 made the decision to bring forward the review of the agreed syllabus to 2015 instead of the expected 2016 renewal date. This was in the light of the changes to the National Curriculum and the parallel Review of Religious Education produced by the RE Council of England and Wales in October 2013, and the national move to remove assessment levels.

SACRE opted to purchase the 'model' syllabus from RE Today Services. The advantages of this are that it was being developed through 2014-2015, allowing Herefordshire SACRE and Herefordshire teachers some input into its development; Worcestershire SACRE have also opted for this syllabus, allowing the possibility of cross-county CPD, increasing the options for teachers to attend network meetings and conferences.

The 2016 syllabus builds on the 2006-2011 syllabus by making use of key questions, constructed around the broad strands of 'Believing, Expressing, Living' that is at the heart of the 2011 syllabus, and following 'threads' of questions through the year groups, as a form of spiral curriculum. It offers a clear planning process to support teachers in developing excellent RE, making use of the unit outlines. These outlines give helpful recommended content for each key question, as well as clear outcomes, banded as 'emerging, expected and exceeding' to reflect the current move towards 'mastery' learning and assessment. The individual unit outcomes build towards end of key stage outcomes derived from the RE Council's 2013 *Curriculum Framework for RE in England*, offering the best available nationally comparable measure of achievement.

The syllabus offers both systematic and thematic units of study, and is flexible in its approach to assessment, allowing schools to use their own methods in relation to assessing progress towards the end of key stage outcomes.

SACRE commented on the draft syllabus in the March meeting, offered guidance on the introductory pages, and the Chair provided the Foreword. The syllabus was printed and launched in the summer term, with schools who were unable to attend receiving a copy in the post, with an accompanying letter from the School Improvement Advisor.

3 SACRE Primary RE Conference to introduce the new Agreed Syllabus: 2 June 2015

Introducing the new Herefordshire Agreed Syllabus 2015: Whitecross School, Hereford.

67 delegates attended the primary launch conference at Whitecross School. 56 feedback forms were received and 80% of those rated the conference as excellent, and 20% as good.

The conference was delivered by Stephen Pett and Fiona Moss from RE Today Services. Session one was on 'Planning great RE using the new syllabus', offering an introduction to the changes and supporting teachers to make sense of how to use it effectively. The second session focused on ideas and strategies for excellent teaching and learning that unpack the unit questions, and the afternoon session looked at how to support pupils in making progress in RE.

Comments from head teachers, teachers and other delegates about the value of the conference included:

- Great, thanks. Loved the two people delivering it
- Always a delight to spend an entire day on RE!
- Very informative and useful as RE co-ordinator
- Lots to take in but clearly presented. Like the way staging planning was suggested. Suggesting activities relating to the key questions was very useful really enjoyed KS1 story lesson.
- Great resources and examples of teaching activities
- Well organised and a very good venue. Plenty of space and breaks and interesting sessions. Timing worked well too.
- Always good to spend time devoted to one (of many) subjects. Good to network too. Good resources provided.

Teachers also commented on their initial response to the new syllabus:

- Looks simple and easy to use. We are excited about delivering it.
- I really like it! Think it is easy to use and will be easier to implement, particularly splitting lower and upper KS2.
- Clearly laid out; like the way key questions are related to learning outcomes/suggested content. As an early years teacher I like the terminology used for assessment
- Detailed and clearly laid out love the colour coding. Glad to see principal religions mapped to different year groups.
- Appears to be simplified and straightforward but at the same time allows for more depth to be studied in each section.
- Well thought through logical and accessible.

Many teachers commented on how they were planning to implement the syllabus in their schools. They also suggested ideas for future support, prominent among which was the desire for a county list of contacts from within faith communities, for visits to school and to places of worship.

SACRE are grateful to Whitecross Hereford High School for hosting the conference.

4 Secondary RE Conference: 15 June 2015

Introducing the new Herefordshire Agreed Syllabus 2015: Whitecross School, Hereford

12 delegates attended, and 92% of these rated the day excellent, and 8% as good. Sessions introduced the syllabus and explored its implications for planning at KS3 and supporting learning at KS4, looking at methods of assessment after the removal of levels, and trying out some teaching and learning ideas.

Teachers commented on the value of the conference:

- Thank you very helpful and informative use of lesson ideas
- It's always good to get together with other RE teachers to share ideas. The teaching resources are excellent and it is useful to actually take part in the activities
- I enjoyed the session regarding taxonomies
- Very well run/presented by Stephen

Their feedback on the revised syllabus included the following comments:

- Helpful to see the overview and changes
- Excellent like the assessment system
- The syllabus is 'user-friendly', the new questions are interesting and will engage students. It will be good to see the resources when they go online.
- I think that the revised learning outcomes are excellent
- Nice to see modern content
- Excellent syllabus makes sense
- Key questions have greater clarity for a non-specialist!

Once again, SACRE are grateful to Whitecross Hereford High School for hosting the conference.

SACRE has been unable to monitor quality of teaching in Herefordshire this year. Ways of monitoring will be considered by SACRE in 2015-2016 as part of the monitoring of the impact of the revised agreed syllabus.

8 Future support for RE

On-going support for teachers, developing their ability to plan, using the new agreed syllabus planning steps, and for improving teaching and learning in RE, is planned for 2015-2016, including:

- Annual SACRE conference for primary teachers, focusing on ideas for teaching and learning, based on the new syllabus, including planning, assessment and deeper learning in four religions, in partnership with Worcestershire SACRE.
- Annual SACRE secondary conference, in partnership with Worcestershire SACRE, focusing on supporting pupils in deepening their understanding of religion, in preparation for the revised GCSE specifications, and ways of developing assessment and planning for progress.
- School Survey to assess impact and value of revised agreed syllabus.

9 Other matters:

SACRE considered several pertinent issues over the year, including:

- The on-going impact of wide—ranging cuts to the Council and the implications for how much support SACRE can realistically offer to schools
- The national consultation on reform of GCSE and A-level Religious Studies.
- The exam results for GCSE (full and short course), AS and A-level Religious Studies in Herefordshire, in relation to continuing discussion on the impact of Government policy on the provision of RE, including the English Baccalaureate. SACRE considered the proposed reform to GCSE and A-level Religious Studies, and members of SACRE contributed to the national consultation on this.

Herefordshire SACRE Item 11 National RE News

1 Full course GCSE Religious Studies entries rise, but number of schools with no RS students at all is increasing

The number of pupils in England and Wales taking GCSE Religious Studies full course has risen again this year, up 5.3% against 2014 to 283,756. This echoes the increase in A Level entries, which are up 6.5% this year compared with 2014.

However the removal of short courses from Department for Education (DfE) performance tables is having a serious and negative impact on the number of pupils choosing to take RS at GCSE level, with an increasing number of schools having no pupils at all taking the subject.

DfE performance tables do not take account of results in short courses. The GCSE short course RS, which had been very popular in the past and provided a reward for schools who provided RE for all, has suffered as a result. The short course is delivered at GCSE standard but covers half the content of a full course and is therefore worth half a GCSE. Changes in entries for short courses have a disproportionately significant impact on RS: almost two thirds of all short course GCSEs taken in England and Wales are in RS.

The damage to take-up of the RS GCSE short course comes at a time when RS is otherwise a subject growing in popularity and when the government is rightly emphasising the importance for young people to have knowledge and understanding of religions and non-religious beliefs. In addition, reforms to GCSE RS make it an increasingly attractive and rigorous subject, while increasing numbers of pupils are carrying RS on to A-level.

The key outcomes for Religious Education in England and Wales at KS4 in 2015 are as follows:

- There were 283,756 entries for the full course in GCSE RS, a rise of 5.3% from 2014 (269,494)
- There were 86,679 entries for the short course in GCSE RS, a decline of 26.8% from 2014 (118,481)
- There were 370,435 entries for GCSE RS (combined short and full courses), a decline of 4.5% from 2014 (387,915)
- In 2014 there were 1,197 schools making no entries for any RS qualification; a rise from 268 in 2010.
- 29.6% of entries for the full course in GCSE RS were awarded an A or an A*
- 11.8% of entries for the short course in GCSE RS were awarded an A or an A*

When RS GCSE entries in England over the past four years are compared to those in Wales (where the EBacc and the average point score at GCSE have not been adopted as school performance measures), the following patterns emerge:

England

Take up of the GCSE RS short course has fallen from 211,269 in 2012 to 68,890 in 2015 (-67.3%) GCSE RS full course entries in England have increased from 216,182 in 2012 to 271,917 in 2015 (25.7%)

Wales

Short course GCSE RS entries have declined slightly from 19,182 in 2012 to 17,789 in 2015 (-7.3%) RS GCSE full course entries have increased from 10,409 in 2012 to 11,839 in 2015 (13.7%)

Overall this means that compared with 2012 over 85,000 fewer pupils in England will complete key stage 4 this year having not gaining a qualification in Religious Studies (a drop of 20.3%).

This echoes research by the National Association of Teachers of RE (published in November 2013) that found that a third of community schools and over a third of academies without a religious character are still failing to meet their legal or contractual agreements to provide religious education for this key age group.

2 New report on the place and future of RE

The result of an extended research project and the Westminster Faith Debates, a report called *A New Settlement: Religion and Belief in Schools* was launched in July. Written by Professor Linda Woodhead and The Right Honourable Charles Clarke.

4 GCSE and A-level Specifications

Below is a timeline of the process for the specifications for the new Religious Studies GCSE and A-level. *Please note that these dates may be subject to change.*

- **3 August 2015** Awarding organisations submit draft specifications, sample assessment material and assessment strategy to Ofqual for accreditation.
- **7-10 September 2015** Ofqual panels of subject experts review awarding organisations' submissions.
- 1 October 2015 Ofqual decision on the accreditation of specifications.
- **8-9 October 2015** Ofqual inform AOs of their decision on accreditation. AOs then make any necessary changes and submit revised specification and assessment material for re-accreditation.
- Late Autumn 2015 Accredited specifications submitted to schools to allow teachers enough time to prepare for first teaching in September 2016.
- **September 2016 -** First teaching of new RS GCSE specifications in schools

5 RE for REAL – report from Goldsmiths College

What should young people leave school knowing about religion and belief?

This is the question posed by a new national study of teaching and learning about religion and belief in schools in England. Conducted by the Faiths and Civil Society Unit at Goldsmiths, University of London, and funded by the Culham St Gabriel's Trust. Researchers asked 330 people - employers and teachers, students, and parents in 19 schools what they think should be the purpose, content, benefits and structure of teaching and learning in this area - whether inside or outside RE itself.
