The Public's Rights to Information and Attendance at Meetings

YOU HAVE A RIGHT TO: -

- Attend all Council, Cabinet, Committee and Sub-Committee meetings unless the business to be transacted would disclose 'confidential' or 'exempt' information.
- Inspect agenda and public reports at least five clear days before the date of the meeting.
- Inspect minutes of the Council and all Committees and Sub-Committees and written statements of decisions taken by the Cabinet or individual Cabinet Members for up to six years following a meeting.
- Inspect background papers used in the preparation of public reports for a period of up to four years from the date of the meeting. (A list of the background papers to a report is given at the end of each report). A background paper is a document on which the officer has relied in writing the report and which otherwise is not available to the public.
- Access to a public register stating the names, addresses and wards of all Councillors with details of the membership of Cabinet and of all Committees and Sub-Committees.
- Have a reasonable number of copies of agenda and reports (relating to items to be considered in public) made available to the public attending meetings of the Council, Cabinet, Committees and Sub-Committees.
- Have access to a list specifying those powers on which the Council have delegated decision making to their officers identifying the officers concerned by title.
- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.

Public Transport Links

 The Shire Hall is a few minutes walking distance from both bus stations located in the town centre of Hereford.

Recording of meetings

- Anyone is welcome to record public meetings of the council using whatever, nondisruptive, methods you think are suitable. Please note that the meeting chairman has the discretion to halt any recording for a number of reasons including disruption caused by the recording, or the nature of the business being conducted. Recording should end when the meeting ends, if the meeting is adjourned, or if the public and press are excluded in accordance with lawful requirements.
- Anyone filming a meeting is asked to focus only on those actively participating.
- If, as a member of the public, you do not wish to be filmed please make a member of the governance team aware.

Purpose

To admit Sascha Kindred as an honorary freeman of the County.

Recommendation(s)

THAT: in accordance with Section 249(5) of the Local Government Act 1972

Sascha Kindred be admitted as an honorary freeman of the County of Herefordshire, in recognition of his eminent services to the county.

Alternative options

1 Not to admit Sacha Kindred as an honorary freeman of the County.

Reasons for recommendations

In recognition of the outstanding contribution that Sascha Kindred has made to swimming in general and to the Paralympic Games in particular, and in recognising the major successes, medals and world records that he has achieved, especially in the 2016 Paralympic Games by winning a gold medal and breaking the world record for the men's 200 metre swimming medley. This council wishes to afford him the greatest honour it has in its power to bestow on any individual resident, namely admit Sascha Kindred to be honorary freeman of the county.

His achievements in Paralympic, world, european and other championships over the past two decades have attracted national and international acclaim, bringing honour and credit on him, his family and connection to the county of Herefordshire where he lives and has rendered eminent service.

Key considerations

- At Council on September 30, 2016, the chairman of the council proposed that Sascha Kindred, OBE be conferred as an honorary freeman of the county of Herefordshire District noting the following key considerations:
 - World class sporting achievements: In September 2016, in the Paralympic Games in Rio de Janeiro, Sascha Kindred of Herefordshire had won a gold medal for the 200m men's individual medley in swimming and broke the world record in doing so.
 - Sustained sporting endeavour: Since competing in his first Paralympic Games in 1996 in Sascha Kindred has accumulated a total of 62 major championship medals, including 7 golds at Paralympic Games, 11 golds at World Championships, and 14 golds at European Championships.
 - Recognition from the British constitutional monarchy: In the Queen's new year Honours list of 2009, he had been awarded the Order of the Most Excellent Order of the British Empire for his sporting achievements.
 - A sporting ambassador in the county: In the 2016 Paralympic Games, Sascha was the only Herefordshire resident Paralympian winner. Sascha had carried out his main training at Leominster swimming pool whilst being a member of Hereford swimming club, making it a cross-county issue.
 - Rendering eminent service: to make anyone an honorary freeman or free woman of the county, Council had to be satisfied that he or she was a person of distinction and they had rendered eminent service to the area.
 - This motion was passed and now a special meeting is convened to bestow this honour. A vote will be required by not less than two-thirds of the members voting to admit Sascha Kindred
 - An honorary freeman may attend and take part in such civic ceremonies as the council may from time to time decide.

Community impact

The council should be proud of its contribution to supporting Sascha's achievements. Since coming to Herefordshire, Sascha has carried out his main training at Leominster swimming pool whilst being a member of Hereford swimming club.

Equality duty

This decision demonstrates how the council recognises the contribution that Sascha has made to sport and in particular to disability sport and how through his example he has promoted opportunities and fostered good relations within the community of Herefordshire.

Financial implications

7 There are negligible costs of conferring the honour and of providing a scroll. These costs will be met from existing revenue budgets.

Legal implications

- The ability to confer this honour is provided under Local Government Act 1972 ("the Act") section249 (5) of which enables the council to admit;
 - (a) persons of distinction and
 - (b) persons who have, in the opinion of the authority, rendered eminent services to that place or area to be honorary freemen or honorary freewomen of the place or area for which it is the authority.
- The power is exercisable by resolution of the relevant authority. The resolution by council following the debate on the motion on 30 September 2016 does not meet the requirements of the Act. The resolution must be passed at a meeting of the relevant authority which is specially convened for the purpose and where notice of the object of the meeting has been given; and by not less than two-thirds of the members who vote on it.

Risk management

There are no foreseen risks in taking this decision. Sascha Kindred is a hugely popular local figure and an internationally recognised sportsman. There has been very positive and widespread interest by the written press, television and other media seeking to cover this award to Sascha. This award follows similar awards made by other local authorities celebrating the success and achievements of their own local Olympic and Paralympic sportsmen and women.
