- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.

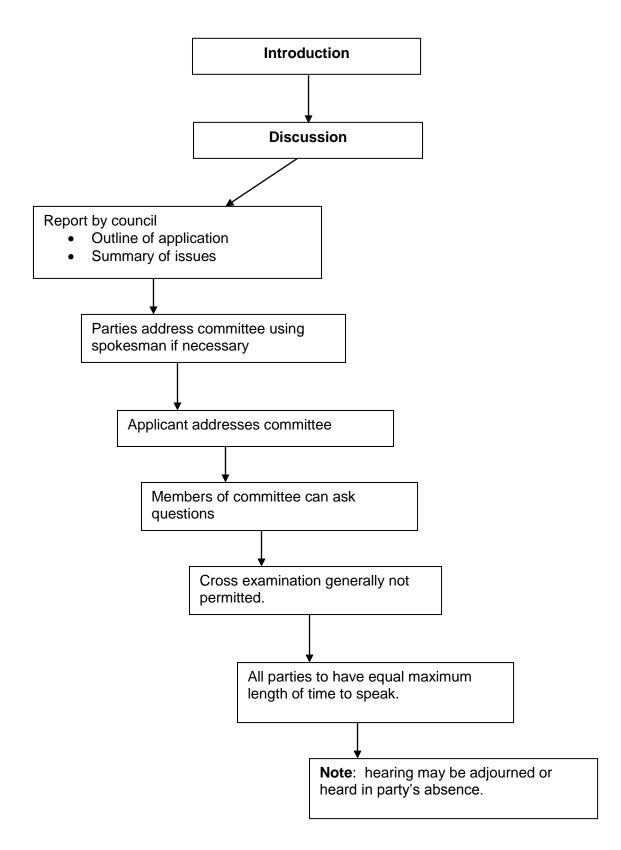

To consider an application for a variation of a premises licence in respect of Munchies, 59 Commercial Road, Hereford. HR1 2BP.

## Recommendation

## THAT:

The sub committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- The steps that are appropriate to promote the licensing objectives,
- The representations (including supporting information) presented by all parties,
- The guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- The Herefordshire Council statement of licensing policy 2015 2020.

## Options

- 1. There are a number of options open to the Sub-Committee:
  - (a) To modify the times applied for
  - (b) to modify the conditions of the licence;

- (c) to reject the whole or part of the application;
- (d) and for this purpose the conditions of the licence are modified if any of them are altered or omitted or any new condition is added.

## **Reasons for Recommendations**

2. Ensures compliance with the Licensing Act 2003.

## **Key Considerations**

## Licence application

- 3. The application (appendix 1) for a variation of the premises licence has received representation and is brought before the committee for determination.
- 4. The details of the application are:

## Summary of Application

5. The application requests a variation to the premises licence to allow the following licensable activities, during the hours shown as follows:

Late night refreshment (indoors): Monday –Sunday 23:00-05:00

## **Premises History**

6. On 3 August 2016 the premises licence was varied to allow:

Late Night Refreshment Monday–Sunday 23:00 – 03:30

7. On 4 August 2017 an application to transfer the licence into the name of Hereford Munchies Limited was received.

## **Current Licence**

8. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

Late Night Refreshement Monday-Sunday 23:00 – 03:30

## Summary of Representations

9. One (1) representation (appendix 3) has been received from the responsible authorities (West Mercia Police). The representation stated they objected to the application.

## **Community Impact**

10. Any decision is unlikely to have any significant effect of the local community.

## **Equality duty**

- 11. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 12. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.
- 13. There are not considered to be any equalities implications arising from this report.

## Financial implications

14. There are unlikely to be any financial implications for the authority at this time.

## Legal Implications

- 15. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the council's own statement of licensing policy.
- 16. The options available to the licensing authority on considering this application under the Licensing Act 2003 are set out in section 1 of this report.
- 17. This premises is in Commercial Road, Hereford and are therefore subject to the special cumulative impact policy contained in the Herefordshire Council Statement of Licensing Policy 2015-2020 that provides:
  - **A10** The effect of the Cumulative Impact Policy is that it creates a rebuttable presumption that application within the cumulative impact area will normally be refused: -

1. Where relevant representations are received against any:

New applications for Premises Licences, Club Premises Certificates or Provisional Statement, or Variation applications for an existing Premises Licences or Club Premises Certificates

- 2. Where the police have issued an objection notice in respect of a Temporary Event Notice
- A11 However, this Policy will not prevent applications in the above areas. Each case will be decided on its own merits, but applicants will have to comprehensively demonstrate in their application that it will not add to existing problems in the area.
- 18. The application should be considered in the context of this policy as well as the other matters outlined in this Report in the determination of this application.
- 19. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.
- 20. In this case it was summed up that: -

A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.

- 21. Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions. It should be noted that hearsay evidence is admissible in the context of making decisions on licensing matters.,
- 22. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:

'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.

23. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

## Right of Appeal

24. There is a right of appeal to the Magistrates Court within 21 days of being notified in writing of the decision

## Risk Management

25. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21 days of being notified of the decision in writing.

LICENSING OBJECTIVES

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b,c,d,e)

List here steps you will take to promote all four licensing objectives together.

To promote all four licensing objectives, the business will ensure that all staff members are aware of the objectives and aware how to fulfill them. All staff members would be trained and a manual covering the objectives would be clearly placed within the premises for staff members to refer to as and when needed.

b) The prevention of crime and disorder

The Premises has its own CCTV which has been installed to the specifications and recommendations of the local police. Images will be retained for 31 days as has been requested under the current conditions. CCTV will also be recording at all times the premises are open for licensable activity with times and dates visible and accurate.

CCTV will be correctly maintained and any failure of the CCTV unit will be reported to the local police immediately. Door supervisors are to be provided as indicated within the application on a risk assessed basis with required times at busy periods and on Fridays and Saturday nights at set times. A register of Door Supervisors will be kept on the premises, as in line with the current conditions attached to the premises.

## c) Public safety

For Public Safety, all staff members shall be in clothing that will be clearly identifiable. All electrical/ Gas services shall be tested at least once a year and signed off by a competent person whose name is shown within the Local Authority Building Control Part P Competent Persons Register.

Maintenance, Repair and Cleanliness shall be monitored on a daily basis. The premises must be cleaned regularly and prior closing the business the premises must be left in a clean state, especially outside. The Premises will also ensure that there is sufficient lighting to enable customers to move around safely.

## d) The prevention of public nuisance

Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to the premises requesting

the public to respect the needs of local residents and to leave the premises and the area quietly.

Adequate waste containers shall be located in the premises. Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to the premises requesting the public to respect the area and ensure that litter is disposed of properly and in appropriate litter bins.

The staff will also ensure that the area immediately outside the premises is regularly checked for litter during operating hours and that any litter found is disposed of appropriately.

e) The protection of children from harm

Staff will monitor customers coming in and out of the premises. Under age children or those assessed to be vulnerable would be reported to the authorities where appropriate.

#### NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.

West Mercia Police are in receipt of an application to vary the premises licence for a premises called Munchies, Commercial Road, Hereford. This premises is licensed for late night refreshment and is licensed to operate until 0330hrs. The application is to extend these hours to the maximum of 0500hrs.

West Mercia Police OBJECT to this application.

The location of this premises is within an area that forms part of the special cumulative impact policy contained in the licensing policy of Herefordshire Council. The reasons for this policy are contained with the council licensing policy and the rationale for having such a policy is contained with the guidance issued under S182 of the Licensing Act 2003.

The grounds for the police objection will be supplied in greater detail if this matter progresses to a licensing hearing, however at this time the police stance is as follows (not exclusively) :

1.To grant these extend hours will undermine the special policy and therefore will impact in a negative way with regards to the promotion of the licensing objectives and in particular that of the prevention of crime and disorder.

2. There is recent recorded history of non compliance of the current licensing conditions which have resulted in verbal interventions and a written warning by the Licensing Authority. These failures have had a direct impact on police crime investigation and therefore undermine the licensing objectives.

3. The location of the premises is near to a number of other licensed late night refreshment venues who have staggered closing times in order to allow gradual dispersal of members of the public frequenting the area. The change of hours undermine the licensing objectives and likely result in numbers remaining in the area with the potential of crime, disorder and nuisance.

4. Whilst the applicant has recognised the need for the special policy, he has failed in the opinion of West Mercia Police to show what further steps could be applied to promote the licensing objectives and not undermine the special policy.

As indicated additional information to support the police objection will be supplied in a timely manner if this matter progresses to a licensing hearing.
