

### **Purpose**

To consider an application for a review of a premise licence in respect of Ruby Chinese Takeaway, 23 Union Street, Hereford. HR1 2BT called by Police Sergeant 3456 Reynolds of West Mercia Police.

### Recommendation

### THAT:

The sub-committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- the steps that are appropriate to promote the licensing objectives,
- the representations (including supporting information) presented by all parties,
- the guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- the Herefordshire Council Statement of Licensing Policy 2015 2020.

# **Options**

- 1. There are a number of option open to the committee in relation to the review:
  - The modification of the conditions of the premises licence;
  - The exclusion of any licensable activities from the scope of the licence;
  - The removal of the designated premises supervisor from the licence;
  - The suspension of the licence for a period not exceeding 3 months; and
  - The revocation of the licence
- 2. Where the authority takes a step mentioned in bullet point 1 and 2 above it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3. Alternatively it is open to the licensing authority to determine that no action is required to promote the licensing objectives or issue an informal warning in writing to the licence holder and/or to recommend improvement within a specified period of time.

### **Reasons for Recommendations**

4. Ensures compliance with the Licensing Act 2003.

- 5. The licensing authority must take into account any relevant representations made. Relevant representations are those that:
  - relate to one or more of the licensing objectives;
  - have not been withdrawn; and
  - are made by the premises licence holder, a responsible authority or an interested party

- 7. The application for the review is attached (appendix 1)
- 8. Copies of the application were sent to the premise licence holder and responsible authorities.
- 9. In brief West Mercia Police's grounds for the review are:

The premises were subject to a visit from multiple agencies and four (4) persons were found to be working at the premises were in the UK with no right to stay or work.

10. This matter is being heard beyond the normal 20 working days due to an adjournment from 30 May 2018 to allow an interpreter for the applicant.

### **Premises History**

11. The premises was first licensed in February 2006 as a Chinese takeaway for late night refreshment. Since it has been licensed, there have been no changes.

### **Current Licence**

12. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

### Late Night Refreshment:

Monday – Wednesday; 23:00- 00:00 Thursday – Sunday; 23:00- 01:30

Non Standard Hours: None

13. The licence is also subject to a number of conditions.

### <u>Circumstances leading to the review</u>

- 14. As part of a pre-planned operation a joint Multi Agency Targeted Enforcement (MATE) took place on Saturday 07 April 2018.
- 15. At 1910 hrs West Mercia Police in partnership with officers from the UK Border and Immigration Agency, Hereford & Worcester Fire Service, Herefordshire Environmental Health (Food) and Herefordshire Council Houses of Multi-Occupancy attended the Ruby Chinese Takeaway.
- 16. The premises were open to the public. Four members of staff working in the kitchens were detained as individuals who had no right to be in the UK and no right to work in the UK. All those detained are Chinese nationals (Three males and one female)

  The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.
- 17. As a result, this review was launched.

# **Summary of Representations**

- 18. No accepted representations have been received from other responsible authorities or members of the public.
- 19. One comment was received from Hereford Town Council (Appendix 3).
- 20. A statement from the UK Border Agency in connection with the enforcement visit is attached at Appendix 4

# **Community Impact**

21. Any decision is unlikely to have any impact on the local community.

# **Equality duty**

- 22. There are no equality issues in relation to the content of this report.
- 23. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 24. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

# **Financial implications**

25. There are unlikely to be any financial implications for the council at this time.

# **Legal Implications**

- 26. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 27. The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 28. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.
- 29. In this case it was summed up that: -
  - A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.
- 30. Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 31. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:

- 'Licensing authorities should only impose conditions which are necessary and 32. proportionate for the promotion for licensing objectives'.
- 33. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

# **Right of Appeal**

34. Schedule 5 gives a right of appeal which states:

> An appeal may be made within 21 days to the Magistrates Court by the police or any person who has made a relevant representation and also by the premises licence holder once notified of the licensing authority's decision.

35. The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or until the appeal is disposed of.

### Risk Management

36. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21days of being notified of the decision in writing.

This is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.

As part of a pre planned operation a joint Multi Agency Targeted Enforcement (MATE) took place on Saturday 07 April 2018.

At 1910hrs West Mercia Police in partnership with officers from the UK Border and Immigration Agency, Hereford & Worcester Fire Service, Herefordshire Environmental Health (Food) and Herefordshire Council Houses of Multi-Occupancy attended the Ruby Chinese Takeaway.

The premises was open to the public. Four members of staff working in the kitchens were detained as individuals who had no right to be in the UK and not right to work in the UK. All those detained are Chinese nationals (Three males and one female)

The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.

Additionally it was established that these same persons were living on the premises in rooms which were deemed unsafe and failing to meet required standards. This resulted in an enforcement notice being issued by the Fire Service and a prohibition notice issued by the council HMO to prevent individuals living in the first floor accommodation and under a staircase at the rear of the premises near to food preparation areas.

The owner of the premises a Mr TRAN who is also the premises licence holder was working at the public counter of the premises. All four detained were staff members working in the kitchen area.

This premises is a well established business and is licensed to provide late night refreshment 7 days a week – some until midnight and at weekends until 0130hrs.

The view of West Mercia Police is that the premises licence for the Ruby Chinese Takeaway should be revoked.

### **Purpose**

To consider an application for a review of a premise licence in respect of Munchies, 59 Commercial Road, Hereford. HR1 2BD called by Police Sergeant 3456 Reynolds of West Mercia Police

### Recommendation

#### THAT:

The sub committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- The steps that are appropriate to promote the licensing objectives,
- The representations (including supporting information) presented by all parties,
- The Guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- The Herefordshire Council Statement of Licensing Policy 2015 2020.

# **Options**

- 1. There are a number of options open to the committee in relation to the review:
  - The modification of the conditions of the premises licence;
  - The exclusion of any licensable activities from the scope of the licence;
  - The removal of the designated premises supervisor from the licence;
  - The suspension of the licence for a period not exceeding 3 months; and
  - The revocation of the licence
- 2. Where the authority takes a step mentioned in bullet point 1 and 2 above it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3. Alternatively it is open to the licensing authority to determine that no action is required to promote the licensing objectives or issue an informal warning in writing to the licence holder and/or to recommend improvement within a specified period of time.

### **Reasons for Recommendations**

4. Ensures compliance with the Licensing Act 2003.

- 5. The licensing authority must take into account any relevant representations made. Relevant representations are those that:
  - relate to one or more of the licensing objectives;
  - have not been withdrawn; and
  - are made by the premises licence holder, a responsible authority or an interested party

- 7. The application for the review is attached (appendix 1).
- 8. Copies of the application were sent to the premise licence holder and responsible authorities.
- 9. In brief West Mercia Police's grounds for the review are:

The premises were subject to a visit from multiple agencies and one (1) persons were found to be working at the premises are were in the UK illegally.

### **Premises History**

- 10. The premises were first licensed in June 2013 as a takeaway for late night refreshment. Since it has been licensed, there have been the following changes:
- 11. 11 September 2015 a transfer application was submitted to change the licence holder from Khalid Faisal to Ardalan Ghafour.
- 12. 26 September 2015 a variation was submitted to remove both (or at least one) of the two door staff between 22:30 01:30 Friday & Saturday nights, this application was later withdrawn by the applicant.
- 13. 5 July 2016 a variation was submitted to extend late night refreshment Monday-Sunday: 23:00 03:30 and to amend the conditions relating to door staff from 22:00 start time to 01:00 start time which was granted.
- 14. 31 July 2017 the licensing authority wrote to the licence holder with regards to breach of conditions of their licence.
- 15. 4 August 2017 a transfer application was submitted to change the licence holder from Ardalan Ghafour to Hereford Munchies Limited.
- 16. 14 September 2017 a variation was submitted for late night refreshment (indoors): Monday-Sunday 23:00-05:00. During the consultation period this was amended to Friday, Saturday and Sunday before bank holidays until 0430 hrs only. Objections were received from responsible authorities and the matter was brought to committee. The decision of the committee was that the application was to be refused.

### **Current Licence**

17. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

**Late Night Refreshment**:

Monday-Sunday: 23:00 - 03:30

Non Standard Hours: None

18. The licence is also subject to a number of conditions.

# Circumstances leading to the review

- 19. As part of a joint partnership an operation took place on Saturday 28 April 2018.
- 20. At 21:55 hrs officers from the UK Border and Immigration Agency, supported by officers from West Mercia Police, attended the premises known as Munchies as a result of intelligence that a person with no right to be in the UK or to work in the UK was employed at the premises.
- 21. One male was working in the premises behind the service counter, he was detained at the premises as it was established that he was in the country illegally. The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.

- 22. A statement from the UK Border Agency in connection with the enforcement visit is attached at appendix 3.
- 23. As a result, this review was launched.

# **Summary of Representations**

24. No representations have been received from other responsible authorities or members of the public.

# **Community Impact**

25. Any decision is unlikely to have any impact on the local community.

# **Equality duty**

- 26. There are no equality issues in relation to the content of this report.
- 27. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 28. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

# Financial implications

29. There are unlikely to be any financial implications for the authority at this time.

# **Legal Implications**

- 30. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 31. The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 32. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.

33. In this case it was summed up that: -

A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.

- 34. Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 35. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:
  - 'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.
- 36. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

## **Right of Appeal**

37. Schedule 5 gives a right of appeal which states:

An appeal may be made within 21 days to the Magistrates Court by the police or any person who has made a relevant representation and also by the premises licence holder once notified of the licensing authority's decision.

38. The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or until the appeal is disposed of.

# Risk Management

39. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21 days of being notified of the decision in writing.

Munchies, 59 Commercial Road, Hereford is a fast food take-away located within the city centre area of Hereford and within an area covered by the special cumulative impact policy of Herefordshire Council Licensing Authority.

Munchies is licensed to provide hot food until 0330hrs.

The premises is licensed in the name of Hereford Munchies Ltd., with a postal address of 59A Commercial Road, Hereford – a slight difference to the address of the premises as stated on the premises licence.

At 2155hrs on Saturday 28 April 2018, officers from the UK Border and Immigration Agency supported by officers from West Mercia Police attended the premises as a result of intelligence that a person with right to be in the UK or to work in the UK was actually working at the premises.

One male was detained at the premises – this male aged 27 was from Afghanistan – was working in the premises behind the service counter. It was established that the male was in the country illegally and was classed as a Port Absconder. At the time of being detained the male had a large amount of cash - £1240 – in his possession. This was seized by the Immigration officers as the male was unable to account for it.

A civil penalty notice was issued on the manager of the premises – a Hiwa KARIM. Mr KARIM stated that the owner of the premises was a Rahroz AMIN.

The employment of illegal immigrants is a criminal offence. Guidance issued under the Licensing Act 2003 states that is a criminal activity which should be treated particularly seriously and that even in the first instance consideration should be given to revoke the premises licence.

West Mercia Police are of the view that the premises licence holder has failed to undertake all necessary legal checks to ensure that this employee – and others – have a legal right to be in the UK and/or be employed in the UK. This undermines the licensing objective of the prevention of crime and disorder.

Based on this significant failure by the premises licence holder, West Mercia Police feel that this matter is so serious that the premises licence for Munchies should be REVOKED.

Additional information to support this application will be provided if this matter progresses to a licensing sub-committee regulatory hearing.

#### **CONDITIONS**

1. CCTV will be provided in the form of a recordable system, capable of providing pictures of EVIDENTIAL QUALITY in all lighting conditions particularly facial recognition. Cameras shall encompass all ingress and egress to the premises. Equipment MUST be maintained in good working order, be correctly time and date stamped, recordings MUST be kept in date order, numbered sequentially and kept for a period of 31 days and handed to Police on demand (provided that the police will allow reasonable time for the recording to be obtained in the event that the request for recordings is made at a time when the premises are closed. equipment and tapes/discs shall be kept in a secure environment under the control of the DPS or other responsible named individual. In the event of technical failure of the CCTV equipment the Premises Licence holder/DPS MUST report the failure to the Police on contact number **0300 333 3000** immediately.

- 2. The Premises Licence Holder shall maintain a register of Door Supervisors which will be kept on the premises showing the names and addresses of the Door Supervisors, their badge numbers and shall be signed by the Door Supervisors as they commence and conclude duty. The register shall be made available on demand for inspection by an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or the police or an authority Officer of the SIA.
- 3. An incident log must be kept at the premises, and made immediately available on request to an 'authorised person' (as defined by Section 13 of the Licensing Act 2003), an authorised Herefordshire Trading Standards Officer or the Police, which must record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received
  - (d) any incidents of disorder
  - (e) seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system
  - (g) any visit by a relevant authority or emergency service
- 4. Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exists to the premises requesting the public to respect the needs of local residents and to leave the premises quietly.
- 5. Adequate refuge containers shall be located in the premises. Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exists to the premises requesting the public to respect the area and ensure that litter is disposed of properly and in appropriate litter bins.
- 6. The Premises Licence holder will ensure that the area immediately outside the premises is regularly checked for litter during operating hours and that any litter found is disposed of appropriately
- 7. All staff shall wear clothing which identifies them as members of staff of the premises.
- 8. The Premises Licence Holder and staff will not permit alcohol to be consumed on the premises.
- 9. The premises will be served by no less than three tills with staff to operate same at peak times (11:00 pm 1:30 am Friday, Saturday and Sunday before Bank Holiday Monday) of service to ensure a fast throughput of customers.
