The Seven Principles of Public Life

(Nolan Principles)

1. Selflessness

Holders of public office should act solely in terms of the public interest.

2. Integrity

Holders of public office must avoid placing themselves under any obligation to people or organisations that might try inappropriately to influence them in their work. They should not act or take decisions in order to gain financial or other material benefits for themselves, their family, or their friends. They must declare and resolve any interests and relationships.

3. Objectivity

Holders of public office must act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias.

4. Accountability

Holders of public office are accountable to the public for their decisions and actions and must submit themselves to the scrutiny necessary to ensure this.

5. Openness

Holders of public office should act and take decisions in an open and transparent manner. Information should not be withheld from the public unless there are clear and lawful reasons for so doing.

6. Honesty

Holders of public office should be truthful.

7. Leadership

Holders of public office should exhibit these principles in their own behaviour and treat others with respect. They should actively promote and robustly support the principles and challenge poor behaviour wherever it occurs.

50. WELCOME AND THOUGHT FOR THE DAY

The Chair welcomed members to the meeting.

Geoff Sallis delivered the thought for the day.

51. **APOLOGIES FOR ABSENCE**

Apologies were received from Lou Barker, Stewart Debenham, and Alison Naylor.

52. NAMED SUBSTITUTES (IF ANY)

Rebecca Bowen substituted for Alison Naylor. Fiona Williams substituted for Stewart Debenham.

53. MINUTES

The minutes of the meeting of 18th November 2022 were unanimously approved.

54. **RESPONSE TO WRITTEN PUBLIC QUESTIONS (IF ANY)**

No questions were received from members of the public.

55. SACRE BUDGET ISSUES

The Chair noted that RE Today won the contract to be the RE advisor from September onwards.

Stephen Pett noted that RE Today applied and won the contract for three years with a possible rollover for the fourth and fifth years rather than having to formally bid again.

The Chair was extremely pleased that RE Today are continuing and commented that the quality of work is very high. The Chair was not informed that RE Today won the contract.

Cllr John Stone thanked Stephen Pett for the work that he and RE Today do.

The Chair noted that she had spoken with John Coleman (Democratic Services Manager) and told the board that SACRE would need to put forward a business case to receive more funding. The Chair confirmed that a new business case would be advanced and asked members for cooperation to help put a business case forward and be ready to be voted on at the next meeting.

Mark Harrington stated that he would support the process.

Geoff Sallis noted that he would also be happy to support the process to put forward a business case.

Mark Harrington reported that he attended NASACRE and noted that budgets across the country were underfunded and discussions were ongoing with government to address declining budgets.

Action: Mark Harrington and Geoff Sallis to assist with business case.

56. SACRE CONSTITUTION CHANGES

The Chair discussed the terms of reference in the Herefordshire Council constitution on SACRE and proposed that 'one free church representative nominated by Churches Together in Herefordshire' be changed to put one representative of the other Christian churches in the county.

Mark Harrington requested that denomination be put rather than churches.

Cllr John Stone agreed that denomination be used instead of churches.

Ruth Stanier noted that Quakers were mentioned twice in the constitution as they are listed separately and belong to Churches together. It was requested that Quakers be only listed once.

57. ADVICE REGARDING NEXT RE SYLLABUS

Stephen Pett explained the situation relating to the next RE syllabus.

- 1. It was explained that a local authority reviews its agreed syllabus every 5 years where SACRE raises that and then an agreed syllabus conference is held, a separate committee, to look at and put together a syllabus and recommend it to the local authority to adopt.
- 2. For the last two agreed syllabuses for Herefordshire, there was a license for an RE Today sllabus in which a license fee is paid per school to allow the use of the syllabus and this represents a more cost effective approach than spending the money on trying to develop a bespoke syllabus.

- 3. Currently, RE Today is working on a revision the current syllabus to build on the current practice and the idea would be to effectively keep the core of the syllabus the same, but to add adaptations, development, some additional elements that might emphasize more about world views, more about Ofsted's ideas of ways of knowing, and the idea of looking at different disciplines as well.
- 4. There is work being done between RE Today and another local authority on a more radical development of a syllabus which represents a bigger step change.
- 5. Stephen Pett summarised that the options are for Herefordshire to stick with what it currently has, whether it has a revision to the current syllabus, or whether it goes to a more slightly radical change.
- 6. There are also other options available which are not RE Today's syllabus which if the board wanted to view, then these could be presented as such options as well.

The Chair asked what the price difference of the different models were.

Stephen Pett pointed out that there is a licensing arrangement per school and they were the same when the different syllabus offerings were presented last time.

The Chair asked what the best method of being able to decide which syllabus is the one to go with.

Stephen Pett noted that updates would be provided at each stage and if discussions are had in the autumn and from Spring 2024, there will be draft options. The final decision will need to be made in Spring 2025 for a summer launch for a September start and there will be examples and example units to look at during this timeline.

Ruth Stanier asked whether it was already established which aspect of the syllabus is going to be changed and which are going to stay the same.

Stephen Pett responded that this was ongoing.

The Chair asked if a bespoke syllabus were chosen, how much it would roughly cost.

Stephen Pett responded that it would depend on how the board would want to create a new syllabus as it would involve teacher groups and the extent of the change that is wanted. Given the challenge of acquiring funding, it would cost more to create a bespoke syllabus because it would need to get teachers together and working parties would be needed, for example.

Cllr John Stone noted that financially, it would be better off going with the suggestions provided by Stephen Pett, on behalf of RE Today.

The Chair asked Tracy Westlake for her thoughts on the next RE syllabus from a teacher's perspective.

Tracy Westlake commented that a bespoke syllabus would require a lot of people who have a lot of time and that this may not be realistic at the moment because people are so stretched. Instead, it was thought that to have something be put together by professionals from across the UK would represent a more realistic option.

Jonathan Nicholas asked if the license fee would be a one-off payment or an annual payment, and whether understanding Christianity would still be part of the syllabus provided by RE Today.

Stephen Pett confirmed that it would be a one-off payment for the five years and that the revision of the current syllabus would continue to have a large number of the understanding Christianity units within it.

Mark Harrington asked if a Westhill award application would be considered in the future where SACREs are funded to put a piece of work together with several produced videos using local faith leaders as a resource for their schools and use that money that way.

The Chair noted that if it was for something other than the actual syllabus, we could.

Stephen Pett added that Shropshire SACRE has a resource which is about local faith community representatives, which was funded through the Westhill grant.

The board agreed and approved that the next syllabus is a revised version of the current syllabus and not a bespoke one.

58. WHAT CAN I DO FOR SACRE

The Chair asked members if they could consider what they could do to help support the board going forward, including the previously discussed issue of SACRE budget issues.

Cllr John Stone commented that he was more than prepared to at least one thing a year to help support the Chair and SACRE.

Peter Fawcett asked the Chair if she could let members know when she needed help that this would be useful as members could then contribute when necessary.

59. **RE CONFERENCES**

Stephen Pett gave a brief overview of the conferences held in 2023. The principal points included:

- 1. On the 22nd June, the secondary conference was held and 30 teachers attended including four Herefordshire teachers.
- 2. It was a good opportunity for teachers to meet up and share ideas as well as be given training.
- 3. In terms of feedback, the overall value of the conference was rated as 100% excellent.

The Chair noted that the conference was very interesting and that it was fast-paced and relevant to teenage children.

Cllr John Stone stated how pleasing it was that there were four Herefordshire teachers at the conference and that other members of SACRE are encouraged to attend to mix with the teachers who attend and hear about what is going on in the classroom as well.

The Chair reported that Stephen Pett was not in attendance at the primary conference due to illness and that feedback for the conference was not available. However, all the feedback was either excellent or good. The Chair asked Tracy Westlake for her thoughts on the conference.

Tracy Westlake commented that the conference was a great opportunity to get together and share ideas ranging from early years to year six.

Mark Harrington noted that there were good discussions regarding many different world views, covering a diversity of different faiths worldwide and thinking through how that's reflected and whether this is reflected properly, particularly in representing lived experience around the world.

The Chair asked members what they would like to see in the conferences for next year.

Mark Harrington responded that there are several very small schools that have mixed age classes, and it would be useful to think about how the curriculum can fit such classes.

Tracy Westlake noted she would be happy to share ideas on that point.

The Chair pointed out that if a workshop on Buddhism as the focus next year could be held that would be good as she could be involved with it.

Tracy Westlake added that multidisciplinary RE received positive feedback and suggested if this could be repeated at a conference next year.

The Chair asked for an update on the special needs conference opportunity because there was funding to hold one. It was asked if one could be held either in the summer or in the autumn next year.

Stephen Pett responded that RE Today would look into it.

The Chair commented that Tracy Westlake offered Black Marston School next summer to run a special needs conference, meaning that the venue was gifted for this specific use.

Action: Stephen Pett to look into the opportunity of holding a special needs conference next year.

60. NATIONAL SACRE UPDATES

Stephen Pett noted that there were no National SACRE updates to report to the board at this meeting.

Mark Harrington asked if there was training of being a SACRE member.

The Chair responded that National SACRE have started doing a training programme on Zoom and she would look at the pricing for these training sessions and pass on information to members by e-mail. The Chair asked Rebecca Bowen if money is ring-fenced for training, does that mean that that money can be used at any time over the next several years.

Rebecca Bowen answered that she could speak to Malcolm Green to find out and feed back to the Chair.

Action: Rebecca Bowen to contact Malcolm Green about whether finances for training is ring-fenced and whether this can be used at any time over the next several years.

61. NATIONAL RE UPDATES

Stephen Pett presented a newsletter for SACRE to members and recommended the RE Hubs website in which the focus of the RE Hubs is to try and coordinate things that are going on in the region and to make it accessible to teachers and schools to see where things are happening and what's going on.

Geoff Sallis added that the Humanist UK and Future Learn websites are good resources for those interested in learning more about humanism.

The Chair asked members where they have resources if they could pass details onto Tracy Westlake who can also pass them onto other teachers.

62. REPORT TIMINGS

The Chair asked Stephen Pett which reports are needed to be produced and at what time of the year they need to be worked on and then to which meeting they must be brought to SACRE.

Stephen Pett noted that the annual report, which must go to the DFE and National SACRE at the end of December. Therefore, this needs to be put together and approved at the November SACRE meeting before submission.

The Chair asked if any members were involved in education, whether they could send in a paragraph or a couple of pictures to add to the report.

The Chair also requested if an item on the next meeting's agenda could be added to look at feedback from schools on worship.

Mark Harrington agreed that it would be useful to know how many schools have withdrawals from worship and should be able to know from the questionnaires sent out to schools.

The Chair asked Rebecca Bowen if the school's officer sends out any information regarding to RE.

Rebecca Bowen answered that a standard newsletter is sent out to schools fortnightly which encapsulate any updates, but in terms of RE specifically, it was noted that this would be taken away to find out.

63. VOTING OF CHAIR AND VICE-CHAIR

The Chair noted that the position of chairperson is to be voted on every four years after the local elections and after speaking with John Coleman, Democratic Services Manager, the Chair requested that a vote be held in the November SACRE meeting for continuity with respect to the school year. It was added that this would be checked and he would get back to the Chair on this.

The Chair added that this would also be the case for the vice-chairperson position and asked members if any would like to be considered for chair or vice-chair, then they should contact either the Chair or the Democratic Services Officer.

64. AOB

The Chair asked members if there was any other business or news that members wanted to cover before the meeting was closed.

Mark Harrington announced that St Thomas Cantilupe CE Primary School had earned its Silver RE quality mark and is one of the few in the county to attain this award.

HEREFORDSHIRE COUNCIL STANDING ADVISORY COUNCIL

FOR RELIGIOUS EDUCATION CONSTITUTION

Introduction

- Section 390 of the Education Act 1996 requires The Herefordshire LEA (referred to in this constitution as the Local Authority (LA)) to establish a permanent body, called a Standing Advisory Council for Religious Education (SACRE), to advise them on matters concerned with the provision of Religious Education and Collective Worship. This constitution sets out the main functions of the SACRE membership, the voting arrangements and the rules for the conduct of business.
- SACRE's main function is to advise the LA upon matters connected with religious worship in County Schools and with the religious education to be given in accordance with an agreed syllabus as the LA may refer to the SACRE or as the LA may see fit.
- 3. SACRE can also require the LA to review its current agreed syllabus, and must consider applications made by a headteacher that the requirement for collective worship in County Schools to be wholly or mainly of a broadly Christian character shall not apply to the collective worship provided for some or all of the pupils at that particular school.
- 4. The broad role of SACRE, therefore, is to support the effective provision of Religious Education and collective worship in schools.

Membership

- 5. Under Section 390(4) of the Education Act 1996, the SACRE must include persons appointed by the LA to represent respectively -
 - A. such Christian denominations and other religions and denominations of such religions as, in the opinion of the LA, will appropriately reflect the principal religious traditions in the area (not including persons to represent the Church of England);
 - B. the Church of England;
 - C. such associations representing teachers as, in the opinion of the LA, ought, having regard to the circumstances of the area, to be represented;
 - D. the Local Education Authority (LA).
- 6. In accordance with the requirements of Section 390(4), the membership of the SACRE for Herefordshire comprises -
 - Group (A) One Roman Catholic representative (nominated by the Roman Catholic hierarchy); One Free Church representative (nominated by Churches together in Herefordshire);
 - One representative of other faiths as a whole;
 - One representative of the Bahá'í faith;
 - One representative of the Muslim faith;
 - One representative of the Sikh faith;
 - One representative of the Jewish faith;
 - One representative of the Buddhist religion;
 - One representative of the Hindu faith;
 - One representative of the Quaker faith.

Other than for the Roman Catholic and Free Church representatives the representatives should, as far as possible, be nominated by the appropriate local faith group.

- Group (B) Three Church of England representatives (nominated in consultation with the Diocesan Education Authority).
- Group (C) Three Teachers' representatives, with one drawn from each of the primary, secondary and special education sectors (nominated through recommendation of recognised Teacher Associations) and one Co-opted Member.
- Group (D) Three Herefordshire Council members as Local Education Authority representatives.
- 7. The number of members appointed to any representative group to represent each denomination or religion required to be represented shall, so far as is consistent with the efficient discharge of the group's function, reflect broadly the proportionate strength of that denomination or religion in the County.
- 8. The SACRE may also include co-opted members.
- 9. SACRE shall have the right to co-opt additional members. These may be as a result of groups making representation to SACRE for inclusion on the basis of representing a relevant faith/belief group, or in order to fulfil a specific role within SACRE. Co-opted members may take part in any of the discussions but do not belong to any of the groups and do not have voting rights.
 - 9.1 Members of SACRE or a representative group should consider the following when cooptions are decided.

Candidates should essentially

a. have an inclusive view of the aims of religious education and collective worship;

Candidates should ideally:

- a. have some experience as religious educators
- b. where possible be representative of specific education phases, to provide a balanced spread across various phases
- 9.2 SACRE will decide co-options following nominations from members of SACRE or representative groups.
- 9.3 Co-opted members shall hold office on such terms as may be determined at the time of co-option by the representative members and shall hold office at the pleasure of, and may be removed at any time by, the representative members, through a vote. If a co-opted member leaves SACRE for whatever reason, (such as those in Para 10), the nominating body should re-apply for another co-optee; there is no right of succession.

Term of Office

10. Any member of SACRE may at any time resign his/her office. Members or co-opted members shall remain until such time as they have a) resigned; b) have been removed from membership under the rules dictated by their nominating body, or c) in accordance with the terms specified by SACRE.

Substitution at meetings

11. Any member of SACRE unable to attend a meeting may appoint a named substitute to attend in his/her place.

Failure to attend meetings

12 Members or co-opted members who fail to attend three consecutive meetings without a satisfactory explanation will have their membership reviewed by the SACRE. The Local Authority may remove any representative or co-opted member that has failed to attend three consecutive meetings without valid reason.

Voting Arrangements

- 13. On any question to be decided by SACRE, only the representative groups (Groups A-D) on SACRE shall be entitled to vote, and each such group shall have a single vote.
- 14 In the event of an equality of votes on any issue the Chairperson may exercise a casting vote, however, depending on the degree of urgency the presumption will be that no action shall be taken on the issue and the existing position shall continue until it is next considered.

Conduct of Business

- 15. Subject to the requirement of the voting arrangements above, SACRE and, in relation to any question falling to be decided by members of SACRE of any particular category, the members of that category may regulate their own proceedings.
- 16. The validity of proceedings of SACRE or of the members of SACRE of any particular category shall not be affected:
 - (a) by a vacancy in the office of any member of SACRE required by Section 390(4); or
 - (b) on the ground that a member of SACRE appointed to represent any religion, denomination or association does not at the time of the proceedings represent the denomination or associations in question.
- 17. The representative groups on SACRE, other than that consisting of persons appointed to represent the LEA, may at any time require a review of any agreed syllabus for the time being adopted by The Herefordshire Council.
- 18. Meetings of SACRE may be convened at the request of the Chairperson or any one of the Groups.

Quorum

19. No business shall be transacted at the meeting unless all representative groups are represented at that meeting. If the meeting is not quorate, the meeting could continue but decisions would have to be ratified at the next SACRE meeting.

Chairperson and Vice-Chairperson

20. The Chairperson and Vice-Chairperson of SACRE is appointed by the membership of SACRE in accordance with the voting arrangements under 13 above. In the absence of the Chairperson and Vice-Chairperson from a meeting, a Chairperson pro tem shall be appointed from amongst the LA representatives there present.

Clerk

21. The Assistant Director Communities (or their successor) of The Herefordshire Council shall be the Clerk of SACRE. The Clerk may nominate an officer from Democratic Services to represent them at meetings.

Rights of Press and Public to attend meetings

22. In accordance with the statutory requirements of the Religious Education (Meetings of Local Conferences and Councils) Regulations 1994 (SI1994 No 1304), the Education Act 1996 and associated regulations, the press and public will be entitled to attend meetings of the Council, but may be excluded from the meeting during the consideration of items containing information capable of being treated as exempt information if meetings of SACRE were meetings of a local Authority. At the beginning of each meeting, for up to half an hour, members of the public will have an opportunity to receive answers to any pre-received written questions they have submitted to the Clerk.

23 Further guidance on the constitution and administration of a SACRE can be found in the Department for Children, schools and families publication 'Religious education in English schools: Non-statutory guidance 2010' or any subsequent publication.

The role of SACRE is to create and monitor the agreed syllabus for RE in our local area, and to advise the local authority on matters relating to the provision and quality of RE and school collective worship. SACRE is eager to respond to teacher-needs and school requests for RE help.

National RE news for teachers and SACRE members

Open letter from over 30 Parliamentarians

An Open Letter was published on the 18th September by the Daily Telegraph. More than 30 MPs and peers have written to the Education Secretary, highlighting that school pupils receive tokenistic religious education or none. The MPs are blaming this on a lack of trained teachers and funding for the poor quality of religious education. They argue that this lack of education leaves children ill-prepared to understand their own and others' worldviews, hindering their ability to participate in society. Link to the letter

NATRE provide evidence at Education Select committee enquiry session

NATRE, along with 3 other subject associations, were invited to speak to a session of the Education Select Committee to support their enquiry into Recruitment and retention of teachers. Deborah Weston, NATRE Research Officer and Chair of the RE policy unit (Joint group made up of NATRE, REC, RE Today), gave evidence in the two hour session.

The TES wrote about the session in which <u>D&T teachers 'rummage in skips' for materials</u>, <u>MPs told | Tes</u> Deborah Weston is quoted:

'Deborah Weston, research officer at the National Association of Teachers of Religious Education, told MPs that "schools are very inflexible places". She said that the "pressures on headteachers are so significant in terms of accountability...that there's a nervousness about taking people on part time". Ms Weston also argued for an increase in the provision of part-time training to become a teacher, arguing that this could boost recruitment and retention.'

Recruitment crisis in teaching and especially in secondary RE

London, 6th March, 2023: A campaign to attract a new generation of RE teachers has kicked off with teaching groups, religious organisations and parliamentarians stressing the importance of the subject for preparing students for life in modern Britain.

As of January, UCAS data show that teacher recruitment for all subjects is down 22% from last year. However RE stands out, being down a third of applicants from the last recruitment cycle.

Government inaction over recruiting teachers to RE has been blamed. The Department for Education (DfE) has so far missed its target for the recruitment of RE teachers in nine of the last ten years.

Despite this year's fall in applicants, the subject continues to grow in popularity. Over the last five years entries to the GCSE have stood around an average of 250,000 with entries to the full course GCSE rising by 30% over the last decade.

The recruitment campaign – entitled 'Beyond the Ordinary' - draws attention to the academic and knowledge rich approach of the subject to life's big questions, and will seek to attract a set of talented graduates up to the task of getting young people to grips with the complex nature of modern belief.

Kathryn Wright, Chief Executive Officer of Culham St Gabriel's Trust, which is supporting the campaign, said: "Religious education is an important curriculum subject enabling children and young people to navigate our complex multi religious, multi secular society. Everyone has a worldview, and it's important we prepare young people to become free thinking, critical participants in public discourse, who can make informed judgements about matters of religion or belief and reflect meaningfully on the big questions in life."

We are looking for ambitious graduates from a range of humanities and social science subjects who can deliver an academic and rigorous curriculum aimed at getting young people to think critically about their own beliefs and those of others."

NATRE analysis of GCSE and A level Religious Studies data: National and regional variations

The reports linked to below cover GCSE and A level RS in both England and Wales and reveal many similarities and some differences between the two nations in relation to trends over time. It is clear that the removal of the short course from performance tables has had a devastating impact on the number of children leaving school with a qualification in Religious Studies. In many cases, the loss of the short course has coincided with an increase in the number of schools reporting zero hours of timetable time for RE in year 11 in the school workforce data. At A level, entries have remained fairly stable over recent years in England but in Wales, there is a step decline, of around 33% since 2020. The reasons for this need further investigation.



