- Running concurrently to this the System Leaders of Health (Commissioner & main Providers) and the Local Authority attended a number of workshops to agree the principles of a system-wide transformational change programme which took place on the following dates 24 May, 10 June and 20 June
- 6 The CCG's 5 Year Strategic Plan brings together all of this intelligence
- 7 Key Features of the 5 Year Strategic Plan are:
 - The CCG's Two Year Plan
 - The development of a strategic transformational programme involving Health (Commissioner and Providers) and Herefordshire Council
 - Within this programme the identification of 4 Key Workstreams; Supportive Communities, Community Collaborative, Planned Secondary Care and Urgent Care across all ages (Children & Adults) encompassing Physical and Mental health
 - How we plan to involve the population of Herefordshire in the design of Health and Care services going forward
