Purpose

To update the Health and Wellbeing Board on progress in creating a children and young people's plan for Herefordshire and for the Board to receive the Children's Integrated Needs Assessment.

Reasons for recommendations

- 2 To enable the Board to monitor progress by the Herefordshire children and young people's partnership in the creation of a new children and young people's plan.

- 3 Attached at Appendix 1 is the newly published Children's Integrated Needs Assessment. This is published for use by all commissioners and providers to aid the identification of priorities, service developments and system change to improve outcomes for children and young people in Herefordshire
- 4 Attached at Appendix 2 is the progress report from Dr Henri Giller, who working with the children and young people's partnership to create a new children and young people's plan for Herefordshire.
- 5 The new children and young people's plan will be guided by the needs assessment work that has taken place and will form a key component of Herefordshire's overall approach to health and wellbeing. Work is taking place to ensure that the creation of the children and young people's plan is done in tandem with the development of Herefordshire's health and wellbeing strategy.
- 6 The new plan will focus on the key areas for improvement highlighted to the health and wellbeing board at the last meeting in December 2014, but will be strengthened through the work that Dr Giller and the Children and Young People's Partnership is leading. Further details can be found in his attached report and his work is being overseen through the children and young people's partnership steering group, with reports to the executive.

Community impact

- 7 The children and young people's plan will play a key part in delivering Herefordshire's health and wellbeing strategy, making use of the recently completed children's integrated needs assessment, the wider joint strategic needs assessment and other needs assessment work. It will also form part of the wider system transformation work which is underway for the whole population in Herefordshire.
