1.0 Introduction

To inform and help shape our future transport policies and delivery programmes we are undertaking public consultation from 23rd November 2015 until 29th January 2016.

This report sets out interim consultation results, comprising a summary responses as of 11 January. A final report will be drafted and published after 29 January when the consultation concludes.

1.1 Our approach to consultation

A wide range of consultation and stakeholder engagement has been undertaken and has assisted in the development of our draft LTP Strategy and Policy. Key studies and consultation which have informed our strategy include:

2.0 Interim Response


2.1 Returns

A total of 154 consultation returns have been received including: 143 completed online response forms and a further 11 responses via letters and e-mails.

2.2 Transport Objective Priorities

This question asked respondents to rank the LTP transport objectives in order of importance. The five LTP objectives were set out in the consultation document.

Figure 1: Transport Objective Priorities




In summary the results indicate that:

• Economic growth, quality of transport network and rural access have all been rated as top priority objectives.

2.3 Transport spending priorities


This question asked respondents to list their top five spending priorities for both capital and revenue funding. Respondents were asked to list their top five spending priorities in order of preference with one being the highest and five being the lowest.

Maintenance was the top priority followed closely by walking and cycling

Figure 3: Transport spending priorities for revenue schemes




 Support for bus routes was identified as the top priority followed by routine maintenance.

2.4 Summary of free text comments provided on consultation form

So far free text comments have been provided from 85 online returns and 11 hard copy letters.

Figure 4: Free text responses by theme.



This chart provides an overview of the proportion of responses in relation to different transport issues and measures. The majority of free text responses relate to new highway infrastructure and public transport with further responses in respect of active travel, maintenance, road safety and parking.

A summary of the issues raised in relation to these measures is outlined below:

Highway Infrastructure

- Improve traffic lights in Hereford
- Congestion in Hereford
- Support for new bridge and Hereford Relief Road (HRR)
- Support for South Wye Transport Package
- Against new roads/Southern Link Road
- Upgrade A49
- Consider Eastern Wye crossing

Public transport (Bus and Rail)

- Against concessionary fares for OAP
- Against removal of services

- Improve public transport (bus/Rail)
- More money to be spent on public transport
- Poor bus links to Rotherwas
- Rural transport as a priority
- Comments on specific bus services

Maintenance

- More maintenance on PROW network
- Roads in a poor state
- Improve workmen supervision
- Support for cost effective asset management

Transport Safety

- Safety should be a priority
- Improve safety on A4110 Lawton Cross
- Cycling too dangerous
- More spend for road safety education
- Poor safety in Leominster (Corn St & Mill St)
- More speed limits

Active Travel

- Encourage sustainable travel
- Improve cycle infrastructure in Hereford City
- Improve walking and cycling infrastructure
- Improved transport to schools
- More money spent on active travel
- Reduce short distance car journeys
- Support active travel

Parking

- Against discouraging commuter parking
- Better peripheral parking
- Increase parking charges to use on buses

Figure 5: Do you agree with the approach taken by the SEA?





Figure 6: Do you agree with the findings in the SEA?
