Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

No supply of alcohol may be made under the premises licence-

- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

No supply of alcohol may be made under the premises licence-

- (c) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (d) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Additional mandatory conditions:

The responsible person [as defined by Section 153(4) Licensing Act 2003] shall: -

• take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises

ensure that no alcohol is dispensed directly by one person into the mouth of another

ensure that free tap water is provided on request to customers where it is reasonably available.

Age verification

• The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark



Smaller measures

The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures–

- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.

Mandatory condition: door supervision

Each individual required to carry out a security activity must be licensed by the Security Industry Authority

Annex 2 - Conditions consistent with the operating Schedule

Licensing conditions/objectives

General:

1. Additional training for all house managers on dealing with illegal activities and aggressive customers.

2. To join Pub Watch (if scheme exists)

3. Sensible drinking policy and training in place - restrictions on discounting and promotions, sale to under 18's and drunks.

4. Additional training on communicating with customers when service is refused for proof of ID.

5. Additional training on communicating with customers when service is refused for drunkeness.

The above restrictions do not prohibit:

a) during the first twenty minutes after the licensed hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;

b) consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol to any person residing in the licensed premises;

c) the ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;

d) the sale of alcohol to a trader or club for the purposes of the trade or club;

e) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majestys naval, military or air forces;

f) the taking of alcohol from the premises by a person residing there; or

g) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or

h) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises;

Prevention of Crime:

1. Additional training for all house managers on dealing with illegal activities and aggressive customers.

Public Safety:

4. To join Pub Watch will facilitate the exclusion of known troublemakers thus making the pub safer.

Prevention of Public Nuisance:

- 1. To join Pub Watch
- 2. No external drinking after 23:00.
- 3. Please leave quietly signs.
- 4. Delivery and collection times not to be changed.
- 5. Regulated entertainment (excluding recorded music) to end at 23:00.
- 6. Sensible drinking policy and training in place.

7. Additional training on communicating with customers when service is refused for dunkeness.

8. No external regulated entertainment.

9. External background music to be turned off at 21:00.

10. All windows and external doors to be kept shut during live performance save for customer access and egress.

Protection of Children:

- 1. No children to be allowed on the site after 22:00.
- 2. Minimum signage to be displayed on the AWP's.
- 3. Audited proof of age scheme to be in place.
- 4. Family orientated business.

5. Additional training on communicating with customers when service is refused for no proof of ID.
