What are the aims or main purpose of the service, function or policy? What does it provide and how does it provide it?

Local Authorities have a duty to make arrangements for the accommodation and care of children for whom it has a responsibility pursuant to Sections 31 and 20–23 of the Children Act 1989. Herefordshire has developed a strategy to meet this sufficiency duty. The strategy includes a range of approaches to ensure that there is sufficient accommodation available for looked after children and young people of all ages and levels of need. One of these approaches is the procurement of a framework agreement for the provision of supported Accommodation placements by independent agency organisations. This particular agreement will help to ensure that the authority has access to good value and quality externally provided placements for young people between the ages of 16 and 18 years when it is not possible or appropriate to place the young person in an alternative provision.

This agreement will deliver a framework of preferred providers that have been evaluated through a procurement exercise that considers cost and quality. The Council will have no financial commitment to purchase services from these providers, but will be able to call-off purchases at pre-agreed prices and to standard terms and conditions of service and quality.

Location or any other relevant information

Where it is in the best interests of the young person, placements will be sought within Herefordshire to maintain links with their local communities, schools and families. Preferred providers may also be able to offer placements outside of Herefordshire.

The framework agreement has been procured jointly by the 14 West Midlands local authorities with Staffordshire County Council as lead procuring and contracting authority.

Herefordshire Council has been operating a framework arrangement for supported accommodation services for four years. The new agreement will have some minor technical structural differences which will relate to the regional approach and administration though the service will not be changed in any way.

Who is intended to benefit from the service, function or policy?

Securing sufficient 16+ accommodation has been a growing pressure in recent years. Herefordshire's 16+ normally operates a case load of around 200 young people. Out of these 200 on average around 45-50 young people are looked after 16-18 so are in need of a placement. Some will be able to remain in their existing fostering placement under the Council's 'Staying Put' arrangements for looked after children. In some cases though, a supported living placement will be more suitable to help them develop their independent living skills as they transition to adulthood.

Who are the stakeholders? What is their interest?

- Young People who are service users are interested in the availability and quality of the placements they are provided with
- Sixteen Plus Service is interested in the availability, quality and cost of placements
- Independent Supported Accommodation Providers are interested in the Council's quality and cost expectations, procurement processes, and placement decision processes

This service has recently been been tendered. The Specification will form the basis of a pre-placement agreement which sets outs the requirements of the service and expectations in terms of service delivery and appropriate legal framework.

The contract will reflect the provider's responsibility to comply with the Equality Act 2010 or subsequent revisions and all other relevant anti-discriminatory legislation.

Provider's will also operate an equal opportunities policy for the duration of the Contract Period and ensure that their recruitment, employment and equal opportunities policies comply with all statutory obligations.

The needs of each child requiring the service are assessed by the Council's social care teams. Preferred providers submit service offers based on this assessment, and Social Care undertake a matching exercise to decide which provider offer or option can best meet the assessed needs. Any specific equality issues are highlighted in the needs assessment and reflected in an individual placement agreement (contract) that is signed by the provider and Council.

None. Increased service choice is more likely to meet the young person's needs, promote their independence and improve their outcomes as they enter adulthood.

C) Information

What information (monitoring or consultation data) have you got and what is it telling you?

Herefordshire is a party to the current sub regional supported accommodation framework administered by Staffordshire which was implemented in 2012 this is now due to expire and be replaced by this new framework. Herefordshire usually has fewer than five active placement via the current framework at any one time and costs vary depending on the level of support required for each young person. The relatively small numbers of placements are due to a restricted pool of providers willing to deliver services in the county. A new framework agreement on a regional level will seek to provide some further options for the placement of looked after children aged 16/17 when there is either limited local availability or it is in the best interests of the young person to be accommodated elsewhere. Organisations that have been successful at tender have been placed on a tiered list of service providers and will enter into a framework agreement with the council subject to the councils governance procedures.
