

# 1 Executive Summary

#### **Performance**

There is to be a short-term change to the role of **Contract Director** at Balfour Beatty Living Places in Herefordshire. Our current Contract Director, Alasdair MacDonald, will begin a 6 month secondment to our UKCS business to support bidding activities from the 1<sup>st</sup> February 2018. During this time, Andy Williams will return to the role of Contract Director, assuming all responsibilities related to the position. As some of you may remember, Andy previously held this position for a number of years prior to Alasdair taking on the role and so knows the business well.

The **Annual Plan** Annexes and budgets are now in the final review stage and on track to be finalised for the start of the new financial year as per schedule. Briefing sessions for Members and Parishes are planned for March.

In January, we carried out 27 priority **winter gritting** route treatments. We have not needed to carry out any secondary route or footpath treatments as, although the cold has dipped overnight, there has not been any prolonged cold temperatures during the day which is the trigger for treatment activity. Due to the winter storms that we had in January that brought strong winds and heavy rain, this led to a number **of tree and flooding emergency response** events.

Liaison on the planned works on the A4103 and A438 for Phase 2 of the **Challenge Fund** programme has been undertaken with affected businesses and stakeholders to gain their feedback on the preferred option with regard to timing and methodology works in advance of the cabinet member decision.

We are pleased to confirm that we have made offers to two new **Locality Stewards** who are due to start on the 19<sup>th</sup> February and the 5<sup>th</sup> March respectively.

### **Major Projects**

**HCCTP (inc. CLR):** *CLR* opened to traffic on 17<sup>th</sup> December. TRO's Draft Objections report issued with Final report to follow for Cabinet Member approval by end of January. ATM-Bus Strategy/Transport Hub & Public Realm Works –Baseline report issued to HC for comments. Bus strategy target completion March 2018. Transport Hub and Public Realm works will commence on completion of Bus Strategy.

**SWTP (inc. SLR):** Development of Business Case & Discharge of planning conditions continuing. Cabinet approved next steps for delivery of ATM measures. CPO – Heads of Terms agreed with 2 landowners, good prospects of settlement of agreements with remaining landowners. Planned publishing of notices Feb 18. Construction Programme – estimated start Spring 2019

**HCCI: High Town:** Phase 2 nearly complete with target cost submitted to HC. Cabinet approval expected end of Jan'18. Anticipated construction start Feb 18. **Residents Parking:** Recommendation report to be submitted. **On Street Parking:** Works to hard wire St Owen St meters complete w/c 22<sup>nd</sup> Jan. **St Owen Street:** Further consultation with key stakeholders scheduled for 12/02/18. Anticipated construction Sept 18.

**HTP:** Phase 2 consultation and shortlist of schemes approved by cabinet on Jan 18. Consultation event planned to commence on 5<sup>th</sup> February. The options appraisal process is complete Initial ATM design high level concepts have been developed to inform phase 2 consultation.










# 4.3 Risk Profiles

The risk profiles are shown in the series of graphs below.




This graph shows the trend of number of risks at each level. It can be seen that this month there has been a decrease in green and yellow risks but no change in red and amber risks.

This reflects risks being closed as works progress.



This graph shows the trend of value of risk by value for escalated risks (SMT level and above). This shows that the pre mitigation risk value has increased with a lesser increase in post mitigation value. This shows that although there is an increase in risk value, proposed mitigations currently remain effective and managing the residual risk values.



This graph shows the trend of value of risk by value for all significant risks (all risks on ThinkRisk). This shows that the pre mitigation risk value has decreased slightly as have the post mitigation risk values.

We can confirm that all risks on the ThinkRisk system have been reviewed in the last period.

QC Checks should form part of normal day to day working procedure and is primarily for each business area to develop. However, additional quality control checking by performance staff will be done across the business as resource and time allows.

Fly Tipping	Ongoing	Checks are ongoing and findings will be incorporated into a refresher training exercise by the Street Cleansing Supervisor. This exercise will also be beneficial as tighter control is being introduced at Thorn over hazardous waste reporting to comply with a new version of the ticket that the operatives have to complete for every fly tip job.		
Street Lighting	Completed	Checks implemented by the Supervisor identified that some of the operatives had forgotten to close off jobs after they had been completed. This has now been addressed. Further to this, in order to build resilience into the monthly reporting, an operative is being shown how to obtain the street lighting statistics for the report so there is support in place should the supervisor be unavailable or off.		
Quality Control Checking	Ongoing	The consultants that are in the Thorn Depot for two days a week for the next few weeks have a Quality Control Checking report on their list to do. This will enable Managers and Supervisors to run of reports of the activity in their Service Areas that will pick at random a percentage of jobs that need to be checked. This will ensure that there is an ongoing level of quality checking being done as and when resource allows.		
Right First Time Checks	Process discussions ongoing	A 'Right First Time' initiative is to be implemented to ensure that all defect requests for action from Locality Steward investigations, include all the details necessary for the Highway Operatives who are responding to do the work can get the work done right the first time e.g. have the right equipment, the right amount of materials and the right Traffic Management items.



## **Community Commissioning Model**

## **Background**


A number of local Communities, often through their parish or town council (who have the opportunity to raise additional revenue via the precept mechanism and other local funding mechanisms), have expressed an interest in directly funding minor works or services to resolve issues or enhance their communities. This approach has been encouraged, being aligned to Herefordshire Council's Asset management strategy where the community is better placed to recognise, fund and deliver on points of local concern ahead of the timescale that can be delivered through the Council.

Over the last few years, the level of enquires has increased, particularly as budgets for the delivery of public realm services continue to be subject to ever increasing demand with core delivery being focused on meeting safety priorities and obligations to the whole county. In some service areas this has historically led to a long term programme or a waiting list e.g. Traffic Regulation Orders.

To enable this approach the Community Commissioning Model was developed to allow Communities to access a range of services through existing contractual mechanisms. The year to date position of enquiries is as follows:

## Community engagement and support

Through January, all parishes were contacted with documents required to be completed and returned in order to participate in next (financial) years' P3 scheme. In addition to this, 19 parishes submitted grant claims.

#### **Customer interactions**

January was an extraordinary month in terms of call volume and raised enquiries. The number of calls more than doubled compared to January 2017 and increased by 42% from November 2017 which was the nearest preceding full month. The volume of enquiries raised by 81% compared to January last year.

The main topic of the calls and enquiries were related to potholes that significantly deteriorated due to snow and frost. 916 pothole/highway deterioration enquiries were logged in total. We also logged 32 carriageway floodings that resulted in road closures in some instances



### **Section 278 Agreements**

Where a development requires work to be carried out within the boundaries of the existing highway and HC is satisfied that the works will be of benefit to the public, an agreement will need to be completed between the developer and Herefordshire Council under Section 278 of The Highways Act 1980. These works could incorporate items such as traffic calming, new roundabouts, traffic signals or other junction improvements. Under the provisions of Section 278, the developer can:

- Be appointed as the Authority's Agent to carry out the works at their own expense in which case the agreement must be supported by a bond.
- Contribute towards the future maintenance of the completed works with a commuted sum.

#### **High Amenity Cuts**

Amenity cuts cover box mowing, which is mowing to a higher specification that is generally needed and includes children's play areas and the Cathedral in Hereford, and the remaining grass areas in Herefordshire.

## **Amenity Grass Cuts**

The timing of grass cutting is important, particularly the first cut of the growing season if undertaken too early then grass height is likely to be low and if too late can lead to additional effort to cut the grass and results in larger quantities of cut grass on the ground. The timing of the first cut also impacts on the timing of subsequent cuts and therefore the delivery programme. With this in mind the weather forecasts are reviewed and feedback from staff and operatives is taken into account to achieve the optimum timing of the first cut. Schedules will be amended accordingly to reflect potential changes to the start of the cutting programme.

#### **Verge Cuts**

Two verge cuts and strimming per year are programmed to take place between April and September to ensure safety on the highways network. Regular review meetings will be held





between BBLP and verge contractors to monitor progress of the programme. Verge cuts tend to be up to one metre cut from the edge of the verge.

## Visibility fencing & Vis-splays

Visibility fencing is where a fence needs to have the vegetation cut back to improve visibility as cars come up to junctions and, in the same way, vis-splays are where the verge needs to be cut back. This is important to maintain to ensure good through visibility for road users.

As and where required, the landlords approval is sought. Where there are no safety concerns, the Grounds Maintenance Supervisor works with HC and the Locality Stewards to identify any sites where visibility fencing may not be required to be maintained.

#### **Hedge Cuts**

The programme of hedge cuts runs from October to February due to birds nesting from March to September. If there is a safety issue or some urgent need to trim a hedge during the months March to September it is necessary to undertake a bird nesting survey of the hedge which determines actions that need to be taken in order to cut back the hedge. The last hedge survey undertaken was in Oak Crescent, Holme Lacy Road, next to St Martins Church as there was a safety concern of vehicles coming out at the junction and seeing clearly enough. These surveys are taken place only when there is sufficient risk to justify disturbing wildlife.

#### Tree/branch clearance

The reactive maintenance element of the grounds maintenance service increases with severe weather, and assets such as trees can be affected, falling on the highway or having the potential to do so. In this event the operatives use their training to use grounds maintenance equipment to cater for this situation.

General safety inspections are undertaken by Locality Stewards with the knowledge and training to identify risks to pedestrians and road users from trees,

#### **Tree Surveys**

Herefordshire has approximately 26,000 trees, 15,000 of which are in Hereford with the rest distributed around the county. Tree surveys are carried out every five years, and within the five year period, should a tree be identified as being a potential danger to the public and/or road users, further assessments can be made.

# **Annex 7 - Managing Water on the Network**

Asset Management of public realm Highway and Land Drainage Assets that are the responsibility of HC and providing services supporting HC as a Lead Local Flood Authority. This includes:

#### **Highway Drainage**

 A risk-based approach to inspection, cyclical and preventative maintenance of highway drainage assets accordance with the HMP and Well Managed Highways.

Carry out the service in line with the 2012 Highways Maintenance Efficiency Programme (HMEP) Guidance on the management of highway drainage assets.

- Discharge HC's responsibilities under the Land Drainage Act in consenting and enforcing but to also manage and deliver the programme of rehabilitation, maintenance and improvement works on HC's land drainage assets, including culverts, grills and watercourses.
- Working with the local water authorities, Environment Agency (EA), Parish Councils and land owners to ensure the most effective management of surface water systems and drainage in Herefordshire.

## Flood Risk Management





### **Highway enforcement**

This includes cases where enforcement action has been pursued, for example hedges that need cutting and obstruction on the highway such as verge marker stones.

- 1. Section 137 Highways Act 1980 (obstruction) ongoing issue with regard to unauthorised verge markers on C1125, Hope End, Ledbury.
- 2. Section 148 Highways Act 1980 large amount of garden waste deposited in highway ditch, U67404 Baregains Lane, Little Marcle. Person responsible spoken to and written requirement subsequently made to remove waste. This was done.

#### **Skips and Scaffolds**

Under S139 and S140 of the Highways Act 1980, permission is required to place a skip on the highway. Permission is also required under S169 of the Highways Act 1980 to place a scaffold on the highway.

The number of skips and scaffolds applications increased this month. There are also various scaffold enquiries in the pipeline with respect to work in the spring.

#### **Dropped Kerbs**

Under S184 of The Highways Act 1980 permission is required to construct a vehicular or pedestrian crossing onto the highway.

The number of applications for dropped kerbs has remained steady. There were also 9 people advising they were going to carry out the work.

#### **Abnormal Loads**

Under the Road Vehicles (Authorisation of Special Types) Order 2003, any vehicle which exceeds 44 tonnes in weight, or exceeds various widths or lengths, has to give notice to the Bridge and Road authority prior to travelling. This enables the highway authority to direct vehicles away from routes that may not be suitable from either a structural or geometry viewpoint.

The number of abnormal load movements started slowly but had climbed back to normal levels by the end of the month. There were also a further 17 communications in addition with respect to companies forwarding their indemnity statements for 2018.

#### Other Licencing

A number of other licences were issued where discussions had been ongoing. These included benches to be situated on the Homend in Ledbury and in Corn Square, Leominster. Three noticeboard licences were issued to Hereford City Council for Holme Lacy Road, one on the River Wye path and one on the playing field at Wordsworth Road. Cultivation licences were also issued to Ross Town Council for flower tubs around the town, together with some slight amendments to existing licences for other planting beds, they are also going to be carrying out additional grass cutting at The Prospect in Ross. A licence was also issued for trees in the verge at Sheepcote Court, Ullingswick.


