The applicant intends to operate a bespoke wedding and private function venue utilising marquees, tipis and tents, appropriate to the event, on the portion of 'House Meadow' indicated on the attached plan. These will be sited towards the southern portion of the licensed area of 'House Meadow'. The specific siting will vary slightly each time, given the need to 'rest' and protect the even growth of grass in the meadow. It is not intended for the

marquees to be permanent features but typically will be erected one day prior to the event and removed the day after the event. Grid reference SO 55583 37862 is approximately central to the proposed licensable area. The business model is to provide small bespoke events for discerning clients. The attached plan indicates the licensable activity area, (delineated in red) also showing three adjacent areas where guests may consume alcohol 'off' the premises (delineated in blue). These adjacent areas are within the curtilage of Whitehall Farm. Additionally, a further plan demonstrates a typical 'triple tipi' set up.

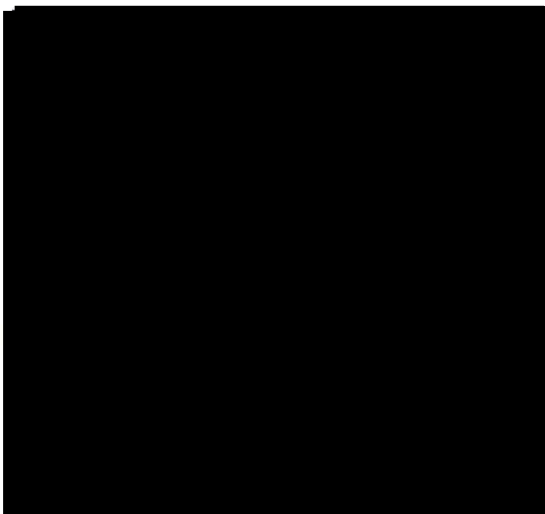

The four licensing objectives will be promoted at all times.
Staff will receive induction training as well as regular refresher training concerning the four licensing objectives, premises licence conditions and mandatory licence conditions.

b) The prevention of crime and disorder

The designated premises supervisor shall ensure that tables are cleared of all bottles and glasses on a regular basis to avoid an accumulation of glassware.
All staff involved in the sale of alcohol will receive training and regular refresher training in the refusal of the sale of alcohol. There will be written record of all such training, signed by the DPS and the staff member.
Whilst licensable activities are taking place, the toilets at the premises will be checked at least hourly for evidence of illegal drug use or supply.
Signs will be placed in the toilets to warn that guests who possess, use or supply illegal drugs will immediately be reported to the police.

c) Public safety

There will be a qualified 'First Aider' at each event.
There will be a HSE Compliant Industrial High Response First Aid Kit located behind the bar, comprising of the following:
1 x Guidance Leaflet
6 x Eye Pads with Bandages
8 x Triangular Bandages
12 x Safety Pins
16 x Assorted Sterile Dressings
20 x Moist Wipes
3 x Pairs of Disposable Gloves
The tented structures will be erected by professional and competent personnel and should not readily collapse when exposed to fire.
Those erecting the tented structures will follow the best practice guidelines as advised in 'Safe Use and Operation of Marquees and Temporary Structures' published by the Made Up Textiles Association (https://www.muta.org.uk/MUTAMembers/media/MUTAMembersMedia/PDFs/MUTA-s-Best-Practice-Guide,-September-2014_1.pdf)
All grass surrounding the tented area will be mowed as short as practicable.
There will be procedures in place to ensure the occupancy figure is not exceeded and to manage the occupancy levels within areas to enable a safe and quick evacuation in the event of an emergency and to allow unrestricted and unobstructed access for emergency vehicles.
There will be a clearly signed fire / incident assembly point as indicated on the attached plan.
The Premises Licence Holder or Designated Premises Supervisor will check prior the the admittance of patrons or staff: exits from the tented areas are sufficient for the number of persons attending; all escape routes will be free from obstruction; all fire exit signs will be clearly visible; the tent will be free from any obvious fire risks; emergency lighting will work correctly; fire extinguishers and other fire fighting equipment will be correctly sited; all staff are trained in the evacuation procedure.
There will be a designated smoking area sufficiently distant from any marquee.
There will be sufficient numbers of toilet facilities for the number of patrons present.

d) The prevention of public nuisance

There will be at least one employee detailed to marshal the safe parking of guests' vehicles.
There will be signage to direct vehicles leaving the farm site to turn left at the junction with Whitehall Road to then join the B4224. This will minimise any vehicle noise through the village. There will be at least one employee detailed to effect this.
All staff involved in the marshalling or directing traffic will wear a high visibility garment.
There will be a number of signs clearly displayed requesting that guests leave quietly and have respect for neighbouring homes.
At the termination of the event, all staff members will actively encourage guests to disperse in a quiet and orderly manner.
The DPS or other nominated person will at all times monitor the noise level at the event.
A direct contact telephone number will be made available in the event that neighbours should wish to contact the

organiser during an event.

e) The protection of children from harm

A 'Challenge 25' policy will be operated. All staff involved in the sale of alcohol will receive training and regular refresher training in the refusal of the sale of alcohol, in particular, to those under the age of 18 and in respect of those attempting proxy purchases on behalf of guests under 18 years of age. There will be written record of all such training, signed by the DPS and the staff member.

There will be clear signs displayed advising a 'Challenge 25' policy operates.

Only the following will be accepted as proof of age: a current passport; a current driving licence; a Proof of Age Standards card.

A 'Refusal Register' will be operated and this shall be made available for inspection upon demand by police officers or Authorised Persons as defined by s13 Licensing Act 2003.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Continued from previous page...

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **full** birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's parents or adoptive parents, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;

In terms of specific **regulated entertainments** please note that:

- **Plays:** no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- **Films:** no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- **Indoor sporting events:** no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- **Boxing or Wrestling Entertainment:** no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- **Live music:** no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- **Recorded Music:** no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
