# What are the aims or main purpose of the service, function or policy? What does it provide and how does it provide it?

The aim of the accommodation based service is to provide transitional supported accommodation, for single homeless people over the age of 18. The service provides support to assist people to be able to live independently by sourcing and settling into suitable accommodation in the community.

The aim of the floating support service is to support vulnerable adults, who are homeless or at risk of homelessness. The service users receive targeted support to remain in their own home, to work towards maintaining and sustaining their accommodation, without the need to make a homeless application, where possible.

The strategic outcomes of the service are to:

- 1. Reduce levels of homelessness
- 2. Reduce levels in incidences of repeat homelessness
- 3. Reduce the use of temporary accommodation
- 4. Reduce the number of households registered with Homepoint
- 5. Reduce the number of people who reoffend

The proposal is to commission, by means of a competitive tender process, an accommodation based housing related support service and housing related floating support service. Two separate but related contracts.

## Location or any other relevant information

Both services support those who have an offending history, substance use or mental health issues.

The accommodation based service has a total of 30 bed spaces in two buildings, and the facility to accommodate one single emergency homeless case out of hours. All the accommodation units are located in Hereford.

The housing related floating support service provides a housing support service across the County of Herefordshire.

# What information (monitoring or consultation data) have you got and what is it telling you?

Quarterly monitoring meetings are held with the current provider of both services. There is a need to increase the provision of supported accommodation in Herefordshire. Currently referrals are received exclusively from Herefordshire Council's Housing Solutions team. In a 6 month period, from January to June 2018, an average of 13 referrals a month were received, with all the accommodation fully occupied. The increasing complexity of client needs presents challenges for the provider to support a move to independent accommodation and managing a suitable mix of vulnerable adults.

Data of need has also been collated from mental health, Addaction, Warwickshire West Mercia Community Rehabilitation Company and Children's Wellbeing.
