	<b>Contract AC896P –</b> The Aconbury Centre. Awarded to Blue Line Taxis for a 3 month term commencing 29 <sup>th</sup> April 2019 at a total cost of £3699.40. 4 compliant bids were received.	
	<b>Contract BF997S –</b> The Brookfield School. Awarded to Hereford City Taxis for a 1 month term commencing 1 <sup>st</sup> May 2019 at a total cost of £433.20. 3 compliant bids were received.
