	 Award Balfour Beatty the contract to complete the roofing works up to the value of £210,464, to include a contingency of up to £19,133.
	 To authorise the expenditure of up to the value of £4,800 from the 2020/21 programme professional fees as set out in the Cabinet Decision. To delegate the responsibility to Capital Project Manager, responsible for managing the delivery of this Capital scheme at Clehonger Primary School to spend within the Capital Maintenance budget.
Reasons for decision:	Clehonger Primary School had initially not been included in the planned maintenance programme 2020/21 for any works.
	 To complete the works required at Clehonger Primary School to make the building fit for purpose and to address the school's Capital Maintenance request.
	 To ensure all Council buildings are fit for purpose and maintained to the standards set out in the condition survey to address suitability, sustainability and affordability.
	4. The cost of the roofing works will be added to the Schools Capital Maintenance programme for 2020/21.

considerations:	A contingency has been allowed to cover unforeseen elements once the roofing works commence. Should this contingency be insufficient then a further officer decision will be required. If the roofing works are not carried out there is risk that the school will have to shut and re-accommodate pupils in mobile classrooms or other schools, which is against the objectives set out in the schools Capital Strategy.
