Transfer of Getting Building Funds (GBF) for the NMiTE Skylon Park Campus Development GBF Project

Please find attached at Appendix 1 a copy of the letter dated 18/09/20 from Steven Greenwood, Deputy Director, Cities and Local Growth Unit, Ministry of Housing, Communities and Local Government (MHCLG) confirming to Gill Hamer, the Marches LEP CEO the arrangements for the initial payment of GBF by the Ministry of Housing, Communities and Local Government (MHCLG) to Shropshire Council as the Accountable Body for the Marches LEP ("the Accountable Body").

As you can see in paragraph 3 of Appendix 1 MHCLG have instructed that, for the period 2020/21, the Accountable Body transfer to the County of Herefordshire District Council ("Herefordshire Council") £800,000 for the NMITE Skylon Park Campus GBF project as soon as practicable. This is to be used explicitly for the NMITE Skylon Park Campus Development GBF project. Please also note that is intended that a further £800,000 is to be transferred by the Accountable Body to Herefordshire Council for the NMITE Skylon Park Campus Development GBF project once the 2021/22 indicative allocation is paid by MHCLG to the Accountable Body. Please note payment of the 2021/22 indicative allocation is subject to assurance that the overall Marches GBF programme is on track at the LEP's Annual Performance (further details on this will follow).

Please also see attached at Appendix 2 a copy of Tony Bray's letter of 14 February 2020 for details of the principles agreed for NMITE Phase 2 LGF project, which will also apply to this GBF project as outlined in Appendix 1.

It is agreed that the Accountable Body delegates responsibility for managing this grant and the relationship with the applicant (NMiTE) to Herefordshire Council. The amount of £800,000 will be transferred by the Accountable Body to Herefordshire Council as soon as reasonably practicable and in any event within five (5) working days of receipt of a signed Acknowledgement and Acceptance Declaration (as set out at page 3 of this letter) from Herefordshire Council; and in advance of project delivery.

Once the transfer has been effected it will enable the Marches LEP to demonstrate that this element of the 2020/21 GBF capital grant has been defrayed. Please note that the date of eligible spend in relation to this grant is 31 March 2021. Please also note that the acceptance by Herefordshire Council of this award includes acceptance of the associated terms and conditions as outlined in Appendix 1 and Appendix 2.

In consideration of the above, the Accountable Body requires Herefordshire Council to agree to the following conditions:-

- From 2 November 2020 and thereafter on a quarterly basis Herefordshire Council will send to the Accountable Body the information as outlined in Appendix 3. This information will allow the Accountable Body to report to the Marches LEP Board and MHCLG on the overall performance of the Marches GDF programme;
- 2. That Herefordshire Council operates according to the Government's National Local Growth Assurance Framework in all matters where it is acting as the local accountable body for the project;
- 3. That Herefordshire Council agrees in principle that if the project delivery needs to extend beyond FY 2020/21, then Herefordshire Council can use its capital spend freedoms and flexibilities to achieve this. Herefordshire Council should notify any resultant alterations to project milestones to the Marches LEP as soon as the new milestones are agreed with NMiTE.

The Accountable Body confirms that neither it nor The Marches LEP will seek to clawback funding on the basis that any project failure is for Herefordshire Council to manage and remedy locally and on the basis that MHCLG looks to:

- (i) the performance of the whole GBF programme and not individual projects; and
- (ii) the degree to which partners have recognised risks and put in place appropriate mitigation.

The information contained in this letter and the attached documents should be brought to the attention of all relevant staff in Herefordshire Council. As the Council's s151 Officer, you are required to sign and return the Acknowledgement and Acceptance Declaration below as evidence of Herefordshire Council's acceptance of the terms and conditions under which this grant will be awarded.
