Although we are unable to offer additional information, we agree, that the evidence clearly supports historic rights of way along the claimed routes. We fully

support the additions of these Bridleways and Byway to the Definitive Map.

Several years ago, we had a long and very difficult dispute with a local landowner who tried, (unsuccessfully), to close a very established right of way in our parish. Apologies the late response but I wanted to walk the suggested routes myself. These are old Bridle Ways and I use parts of them myself. The route M344 is particularly important as the end at the A4103 is opposite a lane to Monkhide (part of Yarkhill Parish) and will allow ramblers and horse riders to walk across the Parish without having to negotiate a stretch of the dangerous A4103. Yarkhill Parish Council are of the opinion that PROW should be preserved and reinstated where necessary as they form a fundamental part of Rural life and are of course important for all walkers, ramblers and riders.

We look forward to seeing these rights of way reinstated and useable.
