| <b>Ward:</b>   | Golden Valley South  |
| <b>Consultation:</b>   | A communication plan will be implemented to inform and liaise with key stakeholders affected by this closure and the resting diversion. This will include local residents, businesses, Parish Councils and local ward members. Final approval subject to the impact and mitigation following the communication plan being implemented.   |
| <b>Decision made:</b>  | To authorise the making of a Temporary Road Closure Order served under section 14(1) of the Road Traffic Regulation Act 1984 to require a temporary closure on the C1206 From C1205 To Crossway, Michaelchurch Escley, from the junction with the C1205, then eastwards for approximately 100 metres, planned to be effective for a period of 5 weeks commencing on the 31st of August 2021. Final approval subject to the impact and mitigation following the communication plan being implemented.   |
| <b>Reasons for decision:</b>   | To enable BBLP to carry out new drainage network construction works within the highway, for which purpose the Council, as highway authority, consider the closure of the road is required due to the likelihood of danger to highway users while the said works are being carried out.   |
| <b>Highlight any associated risks/finance/legal/equality considerations:</b> | Localised disruption on highway network which will be mitigated using diversion route signage and closure period to be kept at shortest possible duration. Pedestrian access to premises affected by this closure will be maintained.  |
| <b>Details of any alternative options considered and rejected:</b>           | Not to introduce a temporary closure of the road; but there would then be operational difficulties in the said works being carried out, and/or would result in a longer period of disruption. In addition, there would be a greater risk to users of the highway and possible claims against the highway authority as a result.  |
