Decision made:	<p>To authorise the making of a Temporary Road Closure Order served under Section 21 of The Town Police Clauses Act (1847) to require the temporary closure of the following roads in Hereford:</p> <p><u>Sunday 19 September 2021 between 09:30 hrs and 14:00 hrs</u> A4103 Roman Road, Hereford between the C1095, Tillington Road junction and Stretton Sugwas roundabout, junction with A480</p> <p><u>Sunday 19 September 2021 between 10:00 hrs and 14:00 hrs</u> C1103 between the C1095 and the A480 C1099 between the C1095 and the A480 U73005 Crowmoor Lane, between the C1103 and C1099</p> <p><u>Sunday 19 September 2021 between 10:00 hrs and 11:00 hrs</u> C1095 Tillington Road between the A4103 and the junction with the C1103</p> <p>The order shall come into effect on 19th September 2021 and is planned to be in effect for 1 day.</p>
Reasons for decision:	To enable the Run Hereford to take place, for which purpose the Council, as highway authority, consider the closure of the road is required due to the likelihood of danger to highway users while the said event is taking place.

Highlight any associated risks/finance/legal/equality considerations:	Local disruption on highway network which will be managed by the event organiser and appropriate signage.
Details of any alternative options considered and rejected:	Not to introduce a temporary closure of the road; but there would then be operational difficulties in the said event taking place, and/or would result in a longer period of disruption. In addition, there would be a greater risk to users of the highway and possible claims against the highway authority as a result
