Reasons for decision:	To enable the Cheltenham Motor Club Special Stage Rally to take place, for which purpose the Council, as highway authority, consider the closure of the roads are required due to the likelihood of danger to highway users while the said event is taking place.
Highlight any associated risks/finance/legal/equality considerations:	<p>Local disruption on highway network which will be managed by the event organiser and appropriate signage.</p> <p>The event will be run in accordance with the permit issued by the governing body, Motorsport UK. It will be run in accordance with the rules and regulations issued by Motorsport UK, including safety. The sport is heavily regulated by the governing body.</p> <p>The club will be responsible for the repair of any damage to the highway and carry the appropriate insurance for this.</p>
Details of any alternative options considered and rejected:	Not to introduce a temporary closure of the roads; but there would then be operational difficulties in the said event taking place, and/or would result in a longer period of disruption. In addition, there would be a greater risk to users of the highway and possible claims against the highway authority as a result
