- 1 The Special Responsibility Column includes allowances for the Chairman and Vice-Chairman of the Council, Leader, Deputy Leader, Cabinet Members, Cabinet Support Team, Group Leaders and Chairmen of other Committees.
- 2 The Members' Allowances Scheme was adopted by the Council having regard to the recommendations of an Independent Remuneration Panel consisting of representatives of local businesses, the voluntary sector and the press and trade unions in accordance with the Local Authorities (Members' Allowances) (England) Regulations 2003.
- 3 Receipts are required for travelling and subsistence allowance with the exception of mileage claims (see column 4). As from 31 August 2013 subsistence allowance is only paid for meetings held outside of the county

- 5 The Allowances paid for the financial year 2013/2014 do not cover an election year. There have been three by elections.
- 6 A Members' ICT Allowance was introduced in 2011. Members were entitled to claim reimbursement for ICT equipment up to the sum of £1,000.00 during the first three years of the administration plus an additional £200.00 per year for consumables (eg printer cartridges, paper). The consumables element of this allowance ceased as from 31 August 2013.
7. No Childcare and Dependant Carers Allowance was claimed for the year 2013/2014.
8. All allowances are subject to annual audit.
