A total budget of £1million has been allocated to the 2025/26 project, funded through Herefordshire Councils Capital Programme. To enable the Works Orders Package, the budget allocation utilised is identified below.

Of the £1million budget, £632,000 has already been committed for the delivery of resurfacing works and as a result of this decision, a further £226,498.48 will be committed as a result of this decision
