Decision made:	To award a contract (Works Order 23) to Tarmac Trading Ltd using the Council's NEC 4 Framework Agreement, up to the value of £226,498.48, for carriageway and remedial works with an additional contingency of up to a value of £22,649.84 (10%)
Reasons for decision:	In order to deliver the investment, as set out in the decision reports above.
Equality Considerations	As a result of the selection of roads for investment as part of this decision is considered to have a positive impact on the protected characteristics of Age and Disability. The investment set out in this report is considered to have a neutral impact on the other protected characteristics.

	<p>quotation information provided which shows that the total of the prices of Tarmac Trading Ltd is likely to be significantly lower than the other Suppliers on the Framework based upon the quotation information submitted within the framework tender and therefore this Supplier gives the council good value for money.</p> <p>A total budget of £1million has been allocated to the 2025/26 project, funded through Herefordshire Councils Capital Programme.
