Under the selection process for the framework, Officers carried out a mini competition exercise using Lot 1 of the Council's Highways and Public Realm Schemes Framework Agreement. Three tenders were received and an evaluation exercise based on price and quality was undertaken by Officers. Following evaluation, Owen Pell Ltd were identified as the preferred bidder and are recommended for award.

A total works budget of £58,663.00 has been allocated to the project, funded through Herefordshire Council's Capital Programme as follows: £58,663.00 of the uncommitted 2025/26 Project Management budget.
