## **Purpose**

To respond to the Adult Social Care and Strategic Housing Scrutiny Committee review of Carers' Services in Herefordshire.

## **Recommendation**

**THAT**

- a) **the Scrutiny review of support for carers in Herefordshire be noted; and**
- b) **the executive's response to the recommendations (see Appendix 1 to the report) be approved.**

## **Key Points Summary**

- The Adult Social Care & Strategic Housing Committee conducted a review of carers services reporting in October 2009 (report at Appendix 2)
- The proposed response from the executive to each recommendation is set out in Appendix 1.

## **Alternative Options**

- 1 That the review, its recommendations and action plan are rejected or revised for further consideration.

## Reasons for Recommendations

- 2 The majority of the review's recommendations are welcomed, and it is acknowledged that considerable improvement has been achieved for Carers Services over the past two years, led by Integrated Commissioning, social care provider services and third sector organisations.

## Introduction and Background

4. On 24 July 2008, the Adult Social Care and Strategic Housing Scrutiny Committee established a group to review support for Carers' in Herefordshire. The Review Group worked against a background of the Government agenda for 'Putting People First' through personalisation, individualised budgets and self-directed care and 'Carers at the heart of 21st century families and communities: a caring system on your side, a life of your own', published in 2008
5. The Adult Social Care and Strategic Housing Scrutiny Committee considered the final report of the review of support for carers in Herefordshire on 30 October 2009 and approved its recommendations.
6. The proposed response to the recommendations is attached at Appendix 1 for consideration by Cabinet.

## Key Considerations

7. Carers provide a vital role that underpins the whole of the health and social care economy.
8. The number of carers is predicted to increase over the next 16-17 years, due to the projected increase in the number of people aged over 65, increase in the number of people with learning disabilities reaching adulthood or suffering dementia and the numbers of people with health and care needs that will be supported in their own homes.
9. The numbers of carers providing 1-19 hours of care per week is expected to remain fairly constant, with relatively small changes, first upwards until 2021 and then downwards to 2026. However, the number of carers providing between 20-49 hours per week and those providing more than 50 hours is predicted to increase steadily over the period of the projections.
10. Government funding to statutory bodies (previously provided as a ring fenced Carers grant, now subsumed in the ABG) is expected to be constrained over the foreseeable future, which will require commissioners to ensure investment in carers services is seen as a significant element of delivering increasingly better value for money.
11. It is envisaged that personal budgets will be an important area of development for Commissioners throughout 2010.

## Community Impact

- 18 Carers play a major role in providing support and care for some of the most frail and vulnerable people in our community.
- 19 It is acknowledged that without their support, many people's independence would be threatened and this would lead to increased pressure on many statutory and voluntary services throughout the county.
- 20 Conversely, supporting carers through effective services ensures that their own health and well being needs are addressed and as citizens in their own right, this is an important

consideration for commissioners of statutory services.

## **Financial Implications**

- 21 All costs must be met from within agreed budgets if the response to the recommendations is accepted.

## **Legal Implications**

## **Risk Management**

- 10 The challenging financial future faced by public services is likely to place increased pressure on funding for carers services and support during a period of an expected increase in both the number of carers and the amount of care they provide. The opportunity will be taken during the development of the forthcoming Carers Commissioning Strategy to explore with carers innovative ways to meet their needs in a context of tightening finances.
