#### **OFFICER COMMENTS**

Despite numerous attempts to seek further comment from Welsh Water comments are still awaited on the amended foul drainage scheme. Given the private nature of the treatment plant which is now proposed and the subsequent preclusion of the schemes connection to the foul sewer, this application will have no impact on the capacity issues of the public sewerage system at Clehonger. It is envisaged that a condition specifically precluding a connection to the public sewerage system appended to any approval given would satisfactorily ensure that no connection is made. The condition should read as follows:

• No foul or surface water discharges from the site shall connect either directly or indirectly at any time to the public sewerage system.

However, it is considered necessary to await confirmation from Welsh Water that the above suggested course of action is acceptable and as such, the formal officer recommendation is hereby amended as follows.

#### **CHANGE TO RECOMMENDATION**

That officers named in the scheme of delegation be authorised to grant planning permission subject to the conditions as stated in the report and any other conditions considered necessary subject to Welsh Water having no objection to the proposed method of foul sewerage disposal.
