Dear Fred,

I am aware that a document has been served on the council summarising a telephone call between myself and Ms Natasha Dunlop and that this will be heard at the Licensing Sub Committee on 5th December. I therefore thought it would be helpful for the committee to have my written response to assist it in its deliberations.

On Thursday morning on 1st November I telephoned Ms Natasha Dunlop following her request to speak to me the day beforehand. Prior to making this call I met with one of the Licensing Technical Officers, so that I could be fully briefed. As is my practice, I made detailed notes in this meeting to assist and remind me of the various timelines and deadlines, so I have a record of this conversation. I therefore respond in order of the points in Ms Dunlop's letter.


- 1. Ms Dunlop explained her situation and I recall that she understood that she had missed the deadline for a TENS submission and I that she asked me for discretion to be applied. Her response in her submission is accurate in that I stated that the Licensing Act is prescriptive and I could not offer any discretion.
 - I would not have used the word "ass" as mentioned, although I am aware that the expression "the law can be an ass" could have been used to Mrs Dunlop in trying to empathise with her about how prescriptive the Licensing Act can seem to be to those who seldom use it. In this respect I recall that she mentioned that she worked for the local authority in the role of safeguarding and that I used this as an example of why the legislation must be fully adhered to, as one of the most important objectives relates to keeping children protected from harm.
- 2. Given that our call was on the last day for an objection I may have stated that objections would be unlikely so late in the day, although I do recall that I was extremely careful to add the caveat that representations could still be received until midnight, as per my briefing by officers beforehand. Ms Dunlop seems to capture this in her note. I recall that I also offered for the team to ring her on Monday morning so that she would be made aware of how the consultation period finished.
 - The remainder of this paragraph seems to be getting confused with the public and evidential tests referred to in the council's Enforcement and Prosecution Policy which I would have mentioned when asked about the possibility of formal action being taken. I recall that I was careful not to say that the business would be protected from a licensing review, representation or enforcement as the Licensing Authority would have to proportionately respond to any complaint should the business still choose to sell alcohol to the public.
- 3. I remember that we discussed Ms Dunlop's experiences in getting advice from the Licensing Team and recall that this was a helpful conversation, providing feedback to the service which I would consider and pass on. In the future we intend to provide pre application advice and this application would have benefited from this. In our discussion about the Licensing Act I may have commented that the planning legislation required the local planning authority to place public adverts and notices to reduce the likelihood of errors and may have compared that to the Licensing Act, where the onus is all on the applicant. However, I would have been careful to add that we have no discretion over this.

I recall apologising at the end of the conversation, because I could not assist her any more than this. I hope this assists with the committee's understanding of this telephone call.

Thank you for your application for a Temporary Event Notice for the 07/07/2018 received on 02/07/2018. Due to less than 5 working days' notice between receipt of the application and the event we are unable to accept it on this occasion. We would have had to receive the notice by 29/06/2018 at 17:00 at the very latest.

Standard TEN -the processing time for the application is 10 working days. In calculating the 10 days the government have advised us that we cannot count the day that the application is received or the day of the actual event.

A Late TEN can be given no later than 5 working days but no earlier than 9 working days before the event in relation to which the notice is given. In calculating the 9-5 days the government have advised us that we cannot count the day that the application is received or the day of the actual event. A late notice given later than 5 working days before the event to which it relates will be returned as void and the activities described in it will not be authorised.

We will arrange a refund, which you will receive in due course.

Thank you for submitting your application to grant a premise licence at The Buttermarket I have reviewed the application and found the following to be incomplete:

Section 17 of 21 - Opening Times

The opening times do not match what is being applied for. Sale/Supply of alcohol is for Monday – Saturday 08:00 – 17:00 and

The opening times you have requested are Monday – Saturday 08:00 – 17:00

We cannot licence something (ie: Sunday) when the premise is not open.

Sale of Alcohol DPS Consent Form

The proposed DPS needs to fill out the consent form to become DPS. The purpose of this form is to get the proposed DPS' authority to be named on the licence. (form attached).

It was noted that the proposed DPS does not have a personal licence.

A Personal Licence is required by anyone authorising the sale of alcohol from a Licensed Premises. All Licensed Premises must have an allocated Personal Licence Holder, known as the Designated Premises Supervisor (DPS). The DPS must authorise every sale of alcohol.

In order to obtain a Personal Licence; applicants must be 18 years of age or above and will need the following:

- Personal Licence application form Obtained from local Councils or Licensing Authorities.
- Level 2 Award for Personal Licence Holders Qualification Certificate
- Basic Disclosure and Barring Service (this replaces the CRB check)
- Two passport-size photos Signed by a professional to prove the identity of the applicant
- Application fee £37

All of the above must be submitted to the local Council (where the applicant lives) in order to apply for the Licence to sell alcohol.

The Personal Licence is obtained independently of the Premises Licence.

Thank you for submitting an application for a premise licence.

I am pleased to inform you that the licensing department has accepted your application.

I have attached all the relevant documentation that is needed for the next part of the process.

You are required to advertise in a newspaper that is local to the premise and that is distributed door to door OR that is readily available at local shops/premises.

This needs to be done within 10 working days of 6th October 2018 (day 1 being the 6th).

(b) by publishing a notice -

(i) in a **local newspaper** or, if there is none, in a local newsletter, circular or similar document, circulating in the vicinity of the premises;

(ii) on at least one occasion during the period of 10 working days starting on the day after the day on which the application was given to the relevant licensing

authority.

26. - (1) In the case of an application for a premises licence or a club premises certificate, the notices referred to in regulation 25 shall contain a statement of the relevant licensable activities or relevant qualifying club activities as the case may require which it is proposed will be carried on on or from the premises.

(2) In the case of an application for a provisional statement, the notices referred to in regulation

25 -

- (a) shall state that representations are restricted after the issue of a provisional statement; and
- (b) where known, may state the relevant licensable activities which it is proposed will be carried on on or from the premises.
- (3) In the case of an application to vary a premises licence or a club premises certificate, the notices referred to in regulation 25 shall briefly describe the proposed variation.
- (4) In all cases, the notices referred to in regulation 25 shall state -

(a) the name of the applicant or club;

- (b) the postal address of the premises or club premises, if any, or if there is no postal address for the premises a description of those premises sufficient to enable the location and extent of the premises or club premises to be identified;
- (c) the postal address and, where applicable, the worldwide web address where the register of the relevant licensing authority is kept and where and when the record of the application may be inspected;
- (d) the date by which an interested party or responsible authority may make representations to the relevant licensing authority;

(e) that representations shall be made in writing; and

(f) that it is an offence knowingly or recklessly to make a false statement in connection with an application and the maximum fine for which a person is liable on summary conviction for the offence.

Notice to responsible authority

27. In the case of an application for a premises licence under section 17, a provisional statement under section 29, a variation of a premises licence under section 34, a review under section 51, a club premises certificate under section 71, a review under section 87 or a variation of a club premises certificate under section 84, the person making the application shall give notice of his application to each responsible authority by giving to each authority a copy of the application together with its accompanying documents, if any, on the same day as the day on which the application is given to the relevant licensing authority.

IF YOU DO NOT COMPLY WITH THE REGULATIONS WE HAVE NO POWER TO DETERMINE YOU APPLICATION AT THE END OF THE CONSULTATION PERIOD. In effect you licence will not be granted. You premises will be visited to ensure compliance with the regulations.

In order for your licence to be processed without delay, you must submit confirmation of the advert (a copy of the advert with proof of the name of the paper/circular and date of publication) to the licensing section, within the next 14 days.

During the 28 day representation period responsible authorities and interested parties (including local residents) can make relevant representations to the Licensing Section regarding your application. Provided that you have complied with the regulations and the 28 day representation period has lapsed, the licensing section will write to inform you of the outcome and advise you accordingly.

Thank you for submitting the newspaper Advert for The Butter Market

I have checked through the newspaper advert and unfortunately, it has come to our attention that the notice placed in the newspaper is incorrect. It doesn't give the full details of the Grant applied for.

The advert proposes that

Sale and consumption of alcohol between 08:00 – 17:30

The application (copy attached) proposes

Recorded Music (Indoors) & Sale/Supply of Alcohol (consumption on and off the premises)

Monday – Saturday

08:00 - 17:30

Sunday 10:00 - 16:00

Live Music (Indoors)

Saturday

10:00 - 16:00

Non-Standard Timings

Sale/Supply of Alcohol on every Wednesday in December until 21:00

As you can see there are discrepancies (highlighted in red) between the activities/timings in the application and what was advertised.

Under the Live Music Act 2012, a licence is not required to stage a performance of live music, or the playing of recorded music if:

- it takes place between 8AM and 11PM; and
- it takes place at an alcohol on-licensed premises; and
- the audience is no more than 500 people

You also don't need a licence:

to put on unamplified live music at any place between the same hours

As the hours applied for Live Music & Recorded Music fall under the Live Music Act 2012, you can have Live & Recorded Music at the premises as long as it falls within the bullet points above.

It is now a matter for you as to how you further this matter. One option open to you would be request us to re-start the 28-day period again. Whilst there would be no additional fee for this to us, you would

be required to re-advertise your application in the newspaper again showing the amended consultation dates, and **full details** of the variation.

Another option open to you would be to grant the application as advertised in the newspaper advert with the timings stated below.

Thank you for your application for a Temporary Event Notice for the 3rd November 2018 received on 29th October 2018. Due to less than 5 working days' notice between receipt of the application and the event we are unable to accept it on this occasion. We would have had to receive the notice by Friday 26th October 2018 at 17:00 at the very latest. Saturday's, Sunday's and Bank Holiday's do not count as working days.

Standard TEN -the processing time for the application is 10 working days. In calculating the 10 days the government have advised us that we cannot count the day that the application is received or the day of the actual event.

A Late TEN can be given no later than 5 working days but no earlier than 9 working days before the event in relation to which the notice is given. In calculating the 9-5 days the government have advised us that we cannot count the day that the application is received or the day of the actual event. A late notice given later than 5 working days before the event to which it relates will be returned as void and the activities described in it will not be authorised.
