Statement of Truth

I am Sebastian Thomas HAYWARD and I live at 15A Burgess Street, LEOMINSTER HR6 8DE.

I live at the rear of Shooters Bar in the old Police Station. We've lived here since 2018. We've got three kids aged 9, 5 and 6 months old. My house is only 20 feet from Shooters – I'm a scaffolder and a standard scaffold pole is 21 feet long.

Shooters Bar used to be noisy – pretty bad to be fair – and it would bother me on a Friday and Saturday night. It doesn't help that we have single glazed windows.

But since Jon RUDGE took over it's improved beyond all recognition. It's got so much better since it's been insulated and the windows of the bar have been done. I've not heard the Club in operation since – not even heard it. I now get a good night's sleep – and I'm a light sleeper. My kids are never bothered by it either.

We've got a Cam-Doorbell that works 24/7 and we don't get any disturbances at all. The only trouble I ever heard of regarding damage was a barber shop front door being smashed in up by Co-op by the Black Swan and Bus Station, but that is considerable distance away. I park my works vehicles on Central Car Park (it's free after 18:00hrs) and we've never had any trouble with that either.
