4. REVIEW OF A PREMISES LICENCE IN RESPECT OF: MAGAZIN TIMISOARA, 22 COMMERCIAL ROAD, HEREFORD, HR1 2BD CALLED BY THE LICENSING AUTHORITY AS A RESPONSIBLE AUTHORITY - LICENSING ACT 2003	3 - 4



SUPPLEMENT – CONDITIONS THE LICENSING AUTHORITY SEEK TO BE ADDED TO THE PREMISES LICENCE

Having looked at the application in further detail, the Licensing Authority considered requesting the removal of the Designated Premises Supervisor (DPS) – Mr Hemel Hassan. However, if he was removed from the premises licence as DPS, Mr Hassan remains the premises licence holder. A premises licence holder is responsible for the day-to-day operation of a venue, ensuring it upholds four (4) licensing objectives, therefore the removal of him as DPS would hold no value.

The Licensing Authority therefore seeks the amendment of two (2) licensing conditions that are on the licence, due to the continual breach

Current:

Spirits of high ABV will be sold from behind the counter.

Amend to:

Alcohol of 15% ABV or higher will be sold from behind the counter

This proposed amended condition, makes it enforceable and there is no confusion of what high ABV is. It will also help deter underage sales (as per the information held by West Mercia Police in their supplement) and therefore promote the licensing objectives Prevention of Crime & Disorder and Protection of Children from Harm.

Current:

The premises licence holder will ensure that there is an unobstructed view at all times into the licensable area of the premises. In respect of any street facing the windows, any obstruction will be restricted to the top 25% of the window and the bottom 25% of the window in each case. (Window refers to the whole area covered by glass). This will mean that at least 50% of all windows and 100% of all doors looking into the premises from Commercial Road are clear of obstruction. No obstruction includes any permanent or temporary signage placed on glass surfaces of doors and windows, as well as any other item within the shop which obstructs the view through the window.

Amend to:

The premises licence holder will ensure that there is an unobstructed view at all times into the licensable area of the premises. This will mean that 100% of all doors and windows looking into the premises from Commercial Road are clear of obstruction. No obstruction includes any permanent or temporary signage placed on glass surfaces of doors and windows (with the exception of one open/closed sign), as well as any other item within the shop which obstructs the view through the window (ie; racking, storage, stock).

Due to the continual breach of this condition, and information held by West Mercia Police (which has been served as a supplement) the amended proposed wording enables the premises to easily comply with the condition and there is no confusion as to what is allowed in the window or on the door. This will also allow the relevant authorities to be able to see straight into the premises from Commercial Road without any obstruction thus promoting the licensing objective Prevention of Crime & Disorder and Protection of Children of Harm.

The Licensing Authority hope that adding the amended conditions to the premises licence are enforceable and the current holder and any future premises licence holders should be able to comply with these easily.
