4. Purpose

The purpose of this report is to note the content and feedback from the Safeguarding Seminar held on 27th February, 2013.

5. Recommendation(s)

6. Key Points Summary

- On 27th February, 2013 a safeguarding seminar was held for all members in the Council Chamber. This was both in response to the Scrutiny Task and Finish group recommendations on Safeguarding and in an approach to strengthening leadership and governance arrangements in the Council following the Ofsted inspection of arrangements in Herefordshire to safeguard children.
- Herefordshire Council has been made subject to an Improvement Notice in Children's Services and a series of seminars have been programmed to assist members in understanding their role in scrutinizing practice and ensuring appropriate improvements are made to services.

- The seminar held in February was designed to enable members to understand in more detail the nature of Child Protection investigations, how these are regulated by policy, legislation and guidance, and how Herefordshire is performing against these standards.
- 30 members attended the seminar which was held for a three hour period. There was a drop out in attendance towards the end of the afternoon with 20 members remaining until the end of the session.
- Thirteen Members complete an evaluation questionnaire, the feedback from which was very positive with the majority commenting that the content was excellent. Messages about what members learnt included, that the seminar improved understanding, raised awareness, enabled the corporate parenting role and provided better understanding of legislation as well as the complexities of the issues associated with child protection investigations.
- Suggested improvements were that handouts would have been helpful, the quiz would have been better as a finishing exercise and the session could have been divided into two sessions.
- Other comments were that the presentations were excellent, the case studies were very interesting, the real case problems made for very interesting discussions and that it was helpful to have social workers involved in the discussions. Also the information was professionally presented but quite dense in content at some stages.
- Members were asked to contribute ideas for future seminars and this will be taken into account in developing the next seminars.
