Purpose

To consider a supplementary report of the Budget Working Group (BWG) on the following matters: National Funding Formula proposals for 2015/16 and High Needs Tariffs.

Recommendation(s)

THAT:

- 1. Schools Forum comments on the Budget Working Group's budget strategy preparations prior to the drafting of the schools budget consultation paper over the summer; and in particular to approve:
 - (a) Funding Model C, the continuation of the current approved budget strategy, with an increase in funding for English as an Additional Language provision (Model D), should form the basis of the recommended budget strategy; and
 - (b) The consultation paper include the following options in relation to moving some funding from deprivation to prior attainment in line with the direction of Model F:
 - Primary schools a choice between no change and options for transferring £200 per pupil and £400 per pupil, and

- 2. High schools a choice between no change and options of transferring £500 per pupil and £1,000 per pupil.
- 2. The final high needs tariff top-ups be approved for implementation from September 2014 as recommended by the Budget Working Group as follows;
 - (a) based on a -5% reduction on the original proposals to balance the budget and allow for expected future "tariff creep" as shown below;

- (b) that high needs top-up tariff protection based on the Minimum Funding Guarantee be approved for Brookfield and Westfield on the basis that gains of Barrs Court and Blackmarston are capped until 2016/17 and thereafter the residual protection cost is met by the high needs block directly;
- (c) the DSG underspend for 2013/14 of £554k be retained in the High Needs Block to support the financial risk from implementing the new tariff scheme and budget pressures in the high needs block; and
- (d) Schools Forum receive a report on a post implementation review of the new tariff scheme in Summer 2015; and
- the arrangements for consultation meetings with schools on the 2015/16 funding formula as set out below be endorsed:

KEY CONSIDERATIONS

- The report of the Budget Working Group (BWG) published with the agenda papers for the Forum's meeting on 11 July referred to the fact that the Budget Working Group was to meet on 7 July and that an update would be provided from that meeting. The agenda papers and notes of the meeting on 7 July have been circulated separately to Members of the Forum for information.
- The recommendations printed above reflect the discussions of the BWG on 7 July. The only changes to the recommendations originally printed are an updated recommendation 1b and a new recommendation 3. The recommendations to the Forum are repeated in full above for ease of reference.

NATIONAL FUNDING FORMULA 2015/16

- 3. The BWG gave consideration to options for transferring funding from deprivation (Ever-6 Free School Meals) to low prior attainment to start a process of funding low prior attainment more in line with national standards. In doing so there was an acceptance that different funding models for primary and secondary schools would be necessary due to unsatisfactory early years foundation data for primary low prior attainment and the unsound educational concept of rewarding failure in early years.
- The BWG acknowledged that benchmarking was a problematic business to some degree. However, Herefordshire was a significant outlier in the comparative funding of low prior attainment and funding for deprivation and there was a case for beginning to move towards the median levels of expenditure nationally. (The relevant DfE graphs are appended.) The BWG considered that a choice should be offered in the consultation document of no change or a range of increases in the funding of low prior attainment. An observation was made that the increase in funding for schools for 2015/16 afforded an opportunity to make the change in direction at a faster pace than might otherwise have been the case.
- The BWG noted that the DfE had published a paper: "What impact does school spending have on pupil attainment? a review of the recent literature." This included the finding that: "additional school resources positively influence attainment, although the effects are relatively modest at all key stages".

RECOMMENDATION

That the consultation paper include the following options in relation to moving some funding from deprivation to prior attainment in line with the direction of Model F:

- Primary schools a choice between no change and Options for transferring £200 per pupil and £400 per pupil, and
- High schools a choice between no change and options of transferring £500 per pupil and £1,000 per pupil.

RECOMMENDATION

That arrangements for consultation meetings with schools as set out in the report be endorsed.

High Needs Tariffs

- Recommendation 2c above proposed that the DSG underspend for 2013/14 of £554k be retained in the High Needs Block to support the financial risk from implementing the new tariff scheme and budget pressures in the high needs block.
- The BWG considered it would be helpful if the Forum was provided with a breakdown of the DSG 2013/14 underspend:

It is proposed that to inform future budgets further work is undertaken for 2015/16 and reported back to BWG to determine the feasibility of planning budgets at the DfE published block total for High Needs and that the transfers between the schools, high needs and early years blocks are eliminated as far as possible and in particular containing the early years spend within the Early years Block of £6,617k is progressed. Account will also need to be taken of post 16 provider's high needs commitments for the summer term 2014 and inter-block funding transfers required from implementing the high needs tariffs for Pupil Referral Units.

Funding of Sports Facilities

The BWG also discussed a letter received from Earl Mortimer College and Sixth Form requesting that additional DSG funding be provided as an exceptional factor to the College to cover the cost of the joint use agreement for use of the Leominster Leisure Centre. Earl Mortimer College does not have any of their own sports facilities and must buy provision from HALO at an additional cost to the school. The BWG requested further information and will consider the matter at their next meeting, making recommendations to the Forum as appropriate. Permission for an exception premises factor must be obtained from the DfE.





Low cost, high incidence Special Educational Needs

Use of this factor is optional, with 142 local authorities using the indicator for primary pupils and 145 the indicator for secondary pupils; six are not using this factor at all. For primary pupils, local authorities could use one of two indicators: either pupils who do not achieve 78 points or more, or pupils who do not achieve 73 points or more, in the Early Years Foundation Stage Profile. For secondary pupils a single indicator was available: the number of pupils who fail to achieve Level 4 or above in both English and Mathematics at Key Stage 2. There is considerable variation in the per-pupil amounts selected. They range from £115 to £7,211 for the primary indicator and from £160 to £10,688 for the secondary indicator.





The chart below shows that 70 per cent of the local authorities are allocating between 2 per cent and 6 per cent of their total funding through this factor.

Deprivation

This is another mandatory factor which every local authority must use in their 2013-14 formula. Local authorities can distribute their Deprivation funding using two indicators: children eligible for Free School Meals (FSM; which could be either straight FSM or Ever 6); or Income Deprivation Affecting Children Index (IDACI) data; or both.

Because of the different permutations of deprivation indicator selections available for local authorities use for this factor, it is not immediately straightforward to calculate perpupil funding amounts on a comparable basis. For the purpose of this analysis, total funding allocated through the Deprivation factors is divided by the number of FSM pupils, to obtain an estimate of the deprivation funding per FSM pupil, as below.

Total Deprivation per FSM pupil for each LA = $(\frac{\text{Total Deprivation funding in FSM+IDACI}}{\text{Number of FSM pupils}})$

The first chart below indicates that there is some variation between local authorities in the amount of funding allocated per FSM pupil. Two-thirds are allocating between £1,250 and £2,750 per FSM pupil.
