Members of the Licensing Panel of the Council's Regulatory Committee considered the above application, full details of which appeared before the Members in their agenda and the background papers.

Prior to making their decision, the Members heard from Mr. Symonds, the applicant, together with P.C. Thomas, representing West Mercia Police Authority, and Mrs. Silver; Mr. Webster; and Mr. Grover, three local residents who had objected to the application.

Having carefully considered those matters brought before them, the Committee were of the opinion that the application should be **granted subject** to the conditions appearing below. In reaching their decision, the Members had full regard to both the provisions of the Licensing Act 2003 and the Council's Licensing Policy. The Members imposed conditions in order to promote the four licensing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

CONDITIONS

The application was granted in respect of the hours of operation of the licensable activities described in the box above together with the following conditions

- The mandatory conditions of The Licensing Act 2003.

Prevention of Crime and Disorder

- The provision of a capacity limit
- The provision of CCTV which meets the requirements and expectations of the Licensing Authority and Police
- The provision of Door Supervisors at the minimum ratio of 2 and then 1 per 100, over a capacity of 200
- The provision of the required number of Door Supervisors from 2200 until 0200 on Fridays and Saturdays and any non-standard timings when they are licensed until 0200
- The active participation in the Bromyard pub watch scheme
- The provision of a terminal hour for all licensable activities of 0200
- The provision of a last entry time of 0000
- The provision of an incident book
- The provision of a condition on irresponsible drinks promotions, such as compliance with the BBPA guidelines
- The prevention of open containers being removed from the premise
- That a personal licence holder is on the premise on Fridays and Saturdays from 2000
- The provision of a dispersal policy

Public Safety

- No open bottles or containers shall be taken off the premises
- Adequate means of ventilation shall be provided during performance, particularly after 2300 when windows to entertainment areas are closed

- In undertaking any or all of the conditions, the Licensee shall comply with all reasonable requests of the Police, the Fire Authority and the Licensing Authority's Officers.
- Any gas installations or appliance shall be examined, and shall hold a current safety certificate signed by a member of the Council and Registered Gas Installers (CORGI)

Prevention of Public Nuisance

- All windows to the entertainment area shall be kept closed during performances after 2300
- All doors shall remain closed except for access/egress by persons to/from the entertainment area and shall at no time be propped open after 2300
- The licensee shall ensure that noise and vibration does not emanate from the premises so as to cause a public nuisance
- A designated person shall be made responsible for assessing the local area from time to time for noise breakout from the premises during performance, to prevent nuisance to neighbours.

Protection of Children From Harm

- No films or videos of any description will be shown so that they can be viewed by persons under the age of any applicable BBFC/Local Authority certification

Additional Conditions

- A capacity limit to be set as agreed with the local Fire Authority and the Environmental Health Department
- Transfer of the Designated Premises Supervisor from Mr. E. Symonds by 1st April, 2006
