### REGULATORY COMMITTEE DECISION NOTICE (THE LICENSING ACT 2003)

#### CONDITIONS

The application was granted in respect of the hours of operation of the licensable activities described in the box above together with the following conditions

- The mandatory conditions of The Licensing Act 2003.

#### **PUBLIC NUISANCE**

- The licensee shall ensure that noise and vibration does not emanate from the premises so as to cause a public nuisance.
- No noxious smells shall be emitted from the premises at any time so as to cause a nuisance.
- The extraction/filtration system fitted in the kitchen/cooking area shall be maintained in a good state of repair and in clean condition.
- A grease trap shall be fitted to the foul drainage pipe work serving the kitchen/cooking area to prevent grease accessing the pipe work that could cause a blockage. The grease trap shall be maintained in good working order and regularly cleaned.
- Receptacles of sufficient capacity shall be provided for the deposit of litter in the shop front area at all times. Such receptacles shall be regularly emptied to prevent accumulations.
- Receptacles of sufficient capacity with close fitting lids shall be provided at the premises for adequate storage of refuse and a regular sufficient waste collection contract in place to prevent accumulations and minimise the likelihood of nuisance.
- The licensee shall ensure the area in the immediate vicinity of the premises is cleared of any litter or food debris at the close of business each evening.
- Prominent, clear and legible notices shall be displayed at the main entrance/exit requesting the public to 'Please respect the needs of local residents and leave the premises and the area quietly' and 'Please keep Herefordshire Tidy, dispose of your litter responsibly'.

#### **PUBLIC SAFETY**

- No serviettes, straws, cutlery or other eating utensils shall be stored in the customer area after 11pm.
- No glass bottles or glass containers shall be supplied at the premises after 20.00 hours on any day.
- Adequate systems shall be in place to effectively control the number of persons entering the premises and effectively deal with any altercations, aggressive behaviour or crowd control issues that may arise at the premises.
