Members of the Licensing Panel of the Council's Regulatory Committee considered the above application, full details of which appeared before the Members in their agenda and the background papers.

Having carefully considered those matters brought before them, the Committee were of the opinion that the application should be **granted subject** to the conditions appearing below. In reaching their decision, the Members had full regard to both the provisions of the Licensing Act 2003 and the Council's Licensing Policy. The Members imposed conditions in order to promote the four licensing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

CONDITIONS

The application was granted in respect of the hours of operation of the licensable activities described in the table above together with the following conditions

- The mandatory conditions of The Licensing Act 2003.

PREVENTION OF PUBLIC NUISANCE

- No noise or vibration shall be emitted from the premises to as to cause a public nuisance.
- Prominent clear and legible notices shall be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises and the area quietly.
- All external doors and windows shall be kept closed except for access when amplified music entertainment is provided at the premises.

OTHER CONDITIONS

- Investigation be made into the provision of a suitable form of soundproofing to be provided at the premises to prevent noise nuisance to neighbouring residential properties.
- All wheelie bins located at the premises to be secured to prevent them being moved by unauthorised persons.
- Notices to be erected on the premises providing details of who to contact when the premises are closed, should the need arise.
