GUIDANCE ON DECLARING PERSONAL AND PREJUDICIAL INTERESTS AT MEETINGS

The Council's Members' Code of Conduct requires Councillors to declare against an Agenda item(s) the nature of an interest and whether the interest is personal or prejudicial. Councillors have to decide first whether or not they have a personal interest in the matter under discussion. They will then have to decide whether that personal interest is also prejudicial.

A personal interest is an interest that affects the Councillor more than most other people in the area. People in the area include those who live, work or have property in the area of the Council. Councillors will also have a personal interest if their partner, relative or a close friend, or an organisation that they or the member works for, is affected more than other people in the area. If they do have a personal interest, they must declare it but can stay and take part and vote in the meeting.

Whether an interest is prejudicial is a matter of judgement for each Councillor. What Councillors have to do is ask themselves whether a member of the public – if he or she knew all the facts – would think that the Councillor's interest was so important that their decision would be affected by it. If a Councillor has a prejudicial interest then they must declare what that interest is. A Councillor who has declared a prejudicial interest at a meeting may nevertheless be able to address that meeting, but only in circumstances where an ordinary member of the public would be also allowed to speak. In such circumstances, the Councillor concerned will have the same opportunity to address the meeting and on the same terms. However, a Councillor exercising their ability to speak in these circumstances must leave the meeting immediately after they have spoken.

The Public's Rights to Information and Attendance at Meetings

YOU HAVE A RIGHT TO: -

- Attend all Council, Cabinet, Committee and Sub-Committee meetings unless the business to be transacted would disclose 'confidential' or 'exempt' information.
- Inspect agenda and public reports at least five clear days before the date of the meeting.
- Inspect minutes of the Council and all Committees and Sub-Committees and written statements of decisions taken by the Cabinet or individual Cabinet Members for up to six years following a meeting.
- Inspect background papers used in the preparation of public reports for a period of up to four years from the date of the meeting. (A list of the background papers to a report is given at the end of each report). A background paper is a document on which the officer has relied in writing the report and which otherwise is not available to the public.
- Access to a public Register stating the names, addresses and wards of all Councillors with details of the membership of Cabinet and of all Committees and Sub-Committees.
- Have a reasonable number of copies of agenda and reports (relating to items to be considered in public) made available to the public attending meetings of the Council, Cabinet, Committees and Sub-Committees.
- Have access to a list specifying those powers on which the Council have delegated decision making to their officers identifying the officers concerned by title.
- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.



Community Impact

11 The granting of the licence as applied for may have an impact on the community.

Legal Implications

- 12 The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 13 The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, which was before the Honourable Mrs Justice Black.
- 14 In this case it was summed up that: -

A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.

- 15 Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 16 This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:

'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.

17 Schedule 5 gives a right of appeal to: -

Rejection of applications relating to premises licences

1 Where a licensing authority—

- (a) rejects an application for a premises licence under section 18,
- (b) rejects (in whole or in part) an application to vary a premises licence under section 35,
- (c) rejects an application to vary a premises licence to specify an individual as the premises supervisor under section 39, or

(d) rejects an application to transfer a premises licence under section 44,

the applicant may appeal against the decision.

Decision to grant premises licence or impose conditions etc.

- 2(1) This paragraph applies where a licensing authority grants a premises licence under section 18.
 - (2) The holder of the licence may appeal against any decision—

(a) to impose conditions on the licence under subsection (2)(a) or (3)(b) of that section, or

(b) to take any step mentioned in subsection (4)(b) or (c) of that section (exclusion of licensable activity or refusal to specify person as premises supervisor).

- (3) Where a person who made relevant representations in relation to the application desires to contend—
 - (a) that the licence ought not to have been granted, or

(b) that, on granting the licence, the licensing authority ought to have imposed different or additional conditions, or to have taken a step mentioned in subsection (4)(b) or (c) of that section,

he may appeal against the decision.

- (4) In sub-paragraph (3) "relevant representations" has the meaning given in section 18(6).
- 18 Section 9 states that any such appeal must be made to a Magistrates Court for the area in which the premises are situated within 21 days of notification of the decision.


- 19 Responsible authorities and persons living within the vicinity or with a business interest within the vicinity of the premises.
- 20 A copy of the application was served on the responsible authorities. This was backed up by an email sent to them by the Licensing Authority.
- 21 The notice of application was displayed on the premises prior to the start of the consultation period and for a period of 28 days. In addition, notice of the application was required to be published in a newspaper which was circulated within the vicinity of the premises.
- 22 The applicant has produced a copy of that advertisement. However it is noted that no mention has been made of licensable activities taking place outdoors and no non-standard timings are shown.

As a long term resident of Church SI., Biomyard, I would ike to register my concerns about the proposed, new Licensing arrangements for the new Function Room at the Grown and iceptre Public House in Sherford St., Bromyard Sherford St., adjoins Church St., and my property is sited very close to he Pub and Function Room, in a residential street at the neart of the town.

The Crown and Sceptre has a history of antisocial behaviour as it has traditionally closed later than he other Pubs in Bromyard and has therefore attracted an ilready alcohol-fuelled clientele. My family and I have requently been troubled by excessive late night [early working noise and anti-social behaviour which has spilled at from the Pub into the surrounding streets and the Market quare. The noise level (shouts, screams, broken-glass hattering, thumps from scuffles?) has necessitated the use from ing home at the end of an evening have been usetted, and made fraiful by this alcohol-fuelled is haviour as our front door is approached.

With the increased capacity of the new Function Room, plus the request for permission for outside entertainment in the Beer Garden and new, pared Pario area, my family and) are naturally very concerned that mese problems will escalate. I worry about adequate tevels & policing, particularly at closing times. Has any consideration been given to the fact that here are no parking facilities at the Pub. Street parking is already a serious issue in Bromyard, with virhally 10 places free for non-residents in Sherford Street ind Church Street. I can foresee clashes between residents and the Pub's clientele - particularly as the function is adverticed to be able to cater for up to 200 people!

I hope you will consider my concerns

attentively and understand that mey are based on long-standing, (of and unreported) personal experience, and also that they are the understandable worries it a fair-minded, tolerant neighbour and resident. Thilst respecting the right of the owners of the Grown and Sceptre to earn a living, I question the ssumption that this enterprise can berefit the putation of our town as a safe, nelcoming place to shabit or visit. THE CROWN AND SCEPTRE PUBLIC HOUSE, SHERFORD STREET, BROMYARD Reference the proposed EXTENSION OF LICENSING HOURS

I wish to submit this letter of protest to any extension of licensing hours at the above premises. I run the Time Machine Museum (DR WHO MUSEUM) opposite the Crown and Sceptre which is only 25 yards away, and I have been subjected, together with other residents over the last year or more, to loud music, screaming, shouting, swearing and disorder both inside and outside this pub. I natually have to open on Saturdays and Sundays as my business is Tourism and mostly weekend trade.

As it is now, the pub has a licence till midnight, however there is then a period of further drinking after the music is switched off at midnight. The customers come out in small parties over the next two and a half hours, mostly extremely drunk, making a horrendous noise as they come out of the pub, meaning that I can only get to sleep after 0300hrs.

My protest is that if the licensing hours are extended till 0130hrs (God forbid!) I will not be able to get to sleep till 0400hrs at the earliest!

This is a completely ridiculous situation for a local trader to be harassed whilst simply trying to run his own business and trying to get some sleep against all odds.

The location of the new Function Room at the Crown and Sceptre, which is where the noise would be coming from, is too near people's houses where businessmen, babies and the elderly are only 30 yards away. We need a decent quality of life, as does everyone and to pay Council Tax to live and run a business where you cannot even get a good nights sleep or run one's business properly is completely and totally unacceptable.

The current midnight cessation of music is more than adequate and I would personally like to see it reduced to 2300hrs.

There are no Police Officers in Bromyard anymore to help with this noise and disorder.

I have spent the last 15 years building up this business where I both live and work and the Dr WHO museum brings in many many visitors to Bromyard each year. It is a very valuable asset to Bromyard and the surrounding area as well as Herefordshire in general.

I feel I must tell you now that if my quality of life and/or health deteriorate because a decision is made to extend the licensing hours at the Crown and Sceptre then I will be forced to assess whether I and my business can stay in Bromyard.

There is, as I hope you agree no point in living in a town where one dreads and is in genuine fear of the weekends and what they bring.

This is not a city centre. It is a small Market Town with many residents living nearby. The Licensing hours must reflect this, the hours must be proportionate to the location.

Dear Sir

I understand an application has been submitted for a Variation of Licence at the above premises.

I wish to comment on that application, and to ask that Conditions be imposed if a Licence is granted. My comments are made under three of the Licensing Objectives. These relate to Public Nuisance, Public Safety, and to Crime and Disorder. In view of the history of associated disorder when events have been held in the past, I am especially concerned about noise from the premises and in the adjacent street.

I am concerned also at the public nuisance which will inevitably be associated with the complete absence of car parking for patrons.

Under the present Licence, the premises already open later than others in Bromyard. Coupled with the excitement offered by music events on the regular occasions that they have been held in the bar, this frequently leads such events to be noisy into the late evening. I have an audio recording to verify this. It is significant that the Conditions in the current Licence regarding late-night audibility of music have not been adhered to at any time in the past.

It is one thing to have a music event for a comparatively small crowd in a pub bar. It is quite another to propose, as has already been advertised for these new premises, 'ticket-only' music events for three or four times the previous size of audience. In the light of the longestablished pattern whenever smaller-scale music events have been held in the past, I would now expect regular disruption and noise on a proportionately larger scale. This will constitute a Public Nuisance. I am advised that Police have been called in almost monthly during the present year. If I had not chosen to show tolerance, the level of complaints could well have been much higher, this year and in the past; I have often been disturbed in my home by loud music and alarmed by shouting and noise from the adjacent street as well as from the pub. I should not be penalised now for my tolerance of smaller-scale nuisance in the past.

The application relates to a new building erected on the base, and vastly extending the floor area, of former outbuildings. Although it can be used as a restaurant or function room, I have been shown built-in sound equipment and a purpose-built stage area. The building is clearly designed for the presentation of live music events.

In conversation with the previous manager of the premises, I was told that the intended capacity is above 170 persons; if so Licensed, this would be the largest public assembly room in Bromyard, with commensurate potential for nuisance. In the interest of Public Safety, I ask that a Condition is made limiting the capacity of the Premises to a specified number of persons in accordance with the recommendation of the Fire Safety Officer.

Patrons and staff of the premises already park in the street outside the building, in spite of parking restrictions there. I have photographs to verify this. This demonstrates the lack of parking facilities, even with the premises at their current capacity. Four car park spaces are allowed-for in Planning Permission; I suggest none of these can be used when the new building is occupied, since even a single car will obstruct the limited emergency exit-ways. A further Public Nuisance is inevitable in view of the number of cars associated with such large crowds as are intended to use the new hall. Public car parking is already so limited near the premises as to have been a subject of concern to Bromyard Town Council. Even if such numbers of people were able to park nearby, nuisance would regularly be caused very late at night to local residents over a wide area by excited patrons returning to their vehicles.

Apart from the limit on capacity mentioned above, I ask the following:

- A. That, for a significant trial period, Licensed hours continue as at present, that is to midnight on Thursdays, Fridays and Saturdays and to 11pm on other evenings. Such a 'trial period' will allow a pattern of good behaviour to be demonstrated. If this Condition is imposed, I have no objection to the occasional 'extra hour' requested in the Licence Application for specified Public Holidays and for the Folk Festival weekend. However, I would otherwise oppose that extra hour.
- B. That Conditions embodied in the current Licence are maintained; that is to say, that *1. All windows are closed/lockable*.
- 2. Customers are requested to leave quietly.
- 3. The fabric of the building retains sound, and to add that this be proven before opening.

4. Prominent, clear and legible notices shall be displayed at all exits requesting the public to respect the needs of local residents and to leave the premises quietly.

5. No live music to be played in the outside area of the premises, but to modify this condition to cover only amplified music, whether live and recorded.

6. No live music after midnight on Monday to Saturday and 23:00 on Sunday.
7. Noise from recorded and live music entertainment to be inaudible at the nearest noise sensitive location after 23:00, this condition to be strictly observed.

8. The outdoor area (beer garden) shall not be used for the consumption of alcohol or licensable activities after 23:30.

9. Music to be played at such a level so as not to cause a nuisance.

- C. That, to limit Public Nuisance and Crime and Disorder, all events conform with regulations governing the required number of Certificated professional security staff under SIC regulations.
- D. That smokers use the inner courtyard area between the pub and the new building rather than the area around the pub front door.
- E. That the Licensee conforms with conditions laid down in the Licensing Act regarding his responsibility for the behaviour of his customers once they leave the premises.

I hope it will be helpful to the Applicant to note that the hours requested for the 'screening' of major sporting events will not cover all such events, many of which take place in daytime.

Thank you for your consideration of these modest requests.

I write regarding the licence application for the above premises and particular the :the proposed use of the new function room; the patio area to the front; rear of the new room and the beer garden.

I note in Herefordshire Council Licensing Policy that :

- 1.4 The Council has a duty under the Act to exercise its functions with a view to promoting the four licensing objectives, which are:
 - a. the prevention of crime and disorder
 - b. public safety
 - c. the prevention of public nuisance; and
 - d. the protection of children from harm.

Without prejudice to other obligations imposed on it, it is the duty of the Authority to exercise it's various functions with due regard to the likely affect of the exercise of those functions on, and the need to do all it reasonably can to prevent crime and disorder.

Before looking at the application form in detail, I will make some general comments under those headings:

Prevention of Crime and Disorder

While I cannot provide a log of incidents, as a neighbour whose bedroom faces onto the Sherford Street, I can confirm that there have been regular incidents in Sherford Street late at night with intoxicated persons outside the Crown and Sceptre Inn.

I would ask that the licensing authority request and consider any records from West Mercia Police of the times they have been called to incidents outside the Crown & Sceptre Inn. I note that that there is no mention of the number of people that will be able to access this premises at any one time but understand that it can accommodate 150 people. This is a considerable increase from current number of people attending the premises and resulting disorder in Sherford Street.

Public Safety

No provision has been made for additional parking facilities for the customers and they will therefore park in the neighbouring streets. There are very few spaces in the adjoining streets and it is likely that customers will park in unauthorised places such as on the double yellow lines outside the pub and in the surrounding streets.

I doubt if staff from Crown & Sceptre will be inclined to take neighbours concerns on this matter seriously as they are aware of this problem already and this even without the new premises being open. Their workman and staff regularly park outside 7 Sherford Street, on double yellow lines.

This poses a serious public safety risk as this is a busy junction and I would guess the double yellow lines were put there to make the junction safer.

Prevention of public nuisance

Besides the problems with alcohol induced crime and disorder and illegal parking, neighbours have to endure the noise of music and customers leaving the premises late at night.

Approval of this licence application would means that granting of the opening of a night club in a residential area which borders the rear gardens of residential properties. This is not a music venue in a busy town centre; this is a late night music venue on the edge of a small market town, with residential properties on three sides and open fields to the rear.

While neighbours accept an established pub garden adjoining their gardens, I am very unhappy with having a night club next to my rear garden. While it may be 'indoors' this is no guarantee that windows and doors will not be open and customers will not spill out into the rear garden in high spirits.

There will be an added problem if the rear garden becomes a designated smoking area as this means that those of us in neighbouring gardens will endure passive smoking by default. This problem will be compounded in the summer when residents wish to make use of their gardens during the warm evenings.

Protection of children from Harm

No comment.

With regard to the actual application I would make the following comments:

Page 2

I note the application applies to the new function room and area to the rear of the new function room. This garden area adjoins a private garden of 7a Sherford Street. This is relevant as impact of any use of this area clearly affects private gardens.

Page 15

It is noted that doors will be closed to the outside whilst music is on in the function room to limit noise levels but we are not clear windows they refer to .

What is the link between function room and rear beer garden; is this by a separate entrance/doors or will people enter from beer garden to function room directly and if so if this is a regular flow of people the doors could be opening and closing (allowing noise to be heard) for much of the evening negating any controls.

Page 19

b) The prevention of crime and disorder

I note the management will work closely with the local Police, Pub Watch Scheme and Local Residents. The interesting point here is that they 'will' as they have not, to my knowledge undertaken any work with local residents in preparation of this licence application. This makes me doubt that they are taking this aspect seriously and perhaps have no intention of doing so once the application is approved. I feel that if this important, the 'management' would have consider the concerns of local residents and worked with us prior to this application. The face of Public cuts , the reality is Police and Council resources will be stretched.

c) Public Safety

I hope that in considering this application you ask for clear evidence of the procedure for enforcing this statement. This is important as I expect over time staff will change and you cannot rely on personal knowledge and recognition.

d) The Prevention of public nuisance

See point b.

Point d), the rear of the premises, new terrace and balcony will allow patrons to look into the private gardens of the neighbouring two properties. The management have therefore not taken action to promote the privacy of neighbours.

Even before this new facility was built, there have been occasions when customers swearing, intoxicated conversations and playing of ball games in the pub garden have interfered with the quite enjoyment of the neighbours using their gardens.

There is now a proposition for a music venue and the rear garden to be an extension of this facility. The license application suggest this will be dealt with by a set of 'rules that include protection of local residents and consideration to their privacy and safety'.

This is clearly not strong enough to give residents any comfort that our interests will or are being protected.

Again, I would trust that the Committee considering the Licensing application would ask to see a set of the rules, ask what consultation the Management have undertaken with the neighbours on these rules, how these rules will be enforced and what will happen if the rules are consistently breached.

It might also be useful if the Licensing Authority visit the premises and neighbours to see if any further works should be taken to protect our privacy.

General

Parking

I note that the application is completely silent on the issue of parking and the impact this could have on public safety or in causing possible nuisance to neighbours. This should have been considered by the management in submitting this application.

Hours

Customers will be leaving this premises on Monday to Thursday at 0.30 hours in the morning and on Saturday and Sunday mornings at 1.30 hrs. This is into a largely residential area!

Planning

In the original planning application for the new area, the applicant requests permission for a building with opening hours of Friday 6 – 11pm, Saturday 12 -11pm and Sunday 12 – 11pm and for a 'drinking establishment' (no mention music or 'Assembly and Leisure'). As approval was given for the building on these grounds, why is that the Licensing Application can ignore the planning application that was I assume approved on those grounds. This change from the planning application does very little to build the confidence of residents that our interests will be respected or considered by the applicant when the original planning application was so different.

The development and request for a license for this premises feels most uncomfortable and inappropriate for this site. Far from being a real addition to Bromyard's economy and character; this is a request for a licence to operate a business that will have a negative impact on those people who have chosen to live in this area of Bromyard and from a venue from which residents have seen multiple incidents of criminal and anti social behaviour and inconsiderate/illegal parking even before this licence is considered.

I would be grateful if you could advise me when the application is being considered

I refer to the above mentioned application made pursuant to the Licensing Act 2003, and received by the West Mercia Police on the 30 November 2010.

A previous application to vary the premises licence was received by West Mercia Police 26 October 2010, and West Mercia Police submitted representations to this application on 01 November 2010. No notification has been given to West Mercia Police to indicate that this first application has been withdrawn. The view was this first application was to extend operating hours for the premises and to introduce a function room.

This new application in the view of West Mercia Police expands the current operating schedule and the view that most customers will be local. The premises is located in a small market town in an area of both commercial and residential buildings. The application will have a direct impact on the current status quo of its near neighbours.

As a result of reviewing the premises and West Mercia Polices involvement with the current designated premises supervisor, West Mercia Police has the following representations with regards to the application.

In order to comply with and promote the licensing objectives and in particular that of the prevention of crime and disorder, the following conditions should be applied to any new licence issued to the premises –

- Condition That the operating schedule for the premise has sufficient SIA registered door staff and control measures relevant to the risk presented to the four licensing objectives. In addition where there is a pre planned function and in particular on Friday and Saturday evenings SIA door staff will be provided on a risk assessed basis.
- Condition The operator of a premise, designated premise supervisor or duty manager shall maintain
 a register indicating the name of person in charge of the management of the premise, numbers of staff,
 performers and SIA staff, including names of door supervisors, who are present when the public are
 present. Further the register will contain detail regarding any incident relevant to the four licensing
 objectives. This register shall be produced immediately on the request of an authorised officer.

3 The grounds for the review are:

The premise is a busy public house located in the Hereford city centre. Its location is in the appendix covering the special policy for the cumulative impact zone as approved within the Licensing Policy for Herefordshire Council 2008-2011. This policy gives detail and information regarding the impact the area has with regard to the licensing objectives.

The request for this review is based on the licensing objectives regarding the prevention of crime and disorder and the protection of children from harm.

It is alleged that young persons were allowed to purchase and consume alcohol in the premises whilst under the age of 18 and whilst under the influence of alcohol obtained from other sources. In addition serious disorder occurred with a man seriously injured as a result of an assault by persons who had been in the premises a short time earlier.

4 The information submitted to support the grounds stated:

During the evening of Friday 12 November 2010, a serious assault took place a short distance away from this premises. This matter is still subject to a police investigation, however at this stage it is apparent that those suspected of being involved are aged 16 years, and that all had been drinking alcohol in the Commercial Hotel prior to the incident and at least one of them returned. In addition others in the same group who are witnesses are also under the age of 18 years, and they too made been drinking in the Commercial Hotel prior to the alleged assault.

This incident is viewed as serious crime and disorder.

There is no evidence of any person involved being challenged by any staff at the Commercial Hotel with regards to their age. In addition there is evidence that a number involved had been drinking elsewhere in the city prior to going to the Commercial Hotel and that they had consumed large quantities of alcohol before going to the Commercial Hotel. There is no evidence that any of the group were challenged regarding their behaviour.

West Mercia Police has received information that the Commercial Hotel is being used by persons under the age of 18 to purchase and consume alcohol on the premises and that staff do not challenge individuals to confirm age.

- 5 On 26 November an application for a Minor Variation was submitted by the premises licence holder, Steven Harrison.
- 6 This requested that the following three conditions should be added to the licence:
 - Provision of adequate CCTV
 - · Provision of SIA door supervisors when risk assessment requires it
 - Challenge 21 To include only ID accepted hologram. Staff Training on underage drinking
- 7 On 13 December the Licensing Authority received representation from Trading Standards following a test purchase operation carried out at the premises on the evening of 11 December when a young person was sold alcohol by the barmaid at the premises. This was dealt with by way of the police issuing an £80 fixed penalty notice.
- 8 On 14 October 2009 the Licensing Authority wrote to Mr Harrison following a complaint of underage drinking at the premises. (see Appendix C)
- 9 Under the legislation, an application for a minor variation is refused if 'no determination' is made within a 15 day period. Following the representation from Trading Standards the Licensing Officer decided to make '*no determination*' in respect of the minor variation and thus it was automatically refused. The applicant was notified of this in writing.

REPRESENTATIONS MADE UNDER THE LICENCING ACT 2003 – THE COMMERCIAL -COMMERCIAL ROAD - HEREFORD

On the 10th December 2010 a test purchase operation was carried out in the Hereford City area. A volunteer under the age of eighteen was instructed by a Weights and Measures Inspector to attempt to purchase alcohol in numerous on-licence premises.

At The Commercial a sale was made of alcohol, namely Stella Artois by Gemma Brace to a volunteer who was under eighteen years old.

In the PACE interview with Gemma, she said that she had received training the day before on selling age restricted products, however at no point did she challenge the young person for identification, which is the ultimate check which should have been carried out.

My representation is that all sales of alcohol should/must be authorised by a Personal Licence Holder or the DPS.

I am in receipt of a complaint regarding underage drinking.

I will draw your attention to Section 150 of the Licensing Act 2003 which states that a person who works at the premises commits an offence if he knowingly allows the consumption of alcohol on premises by an individual aged under 18.

It is your and your staff's responsibility to promote the Licensing Objectives, in this case the protection of children from harm by preventing the consumption of alcohol by persons under 18 on your premises.

This offence carries a maximum penalty of £20,000 and or 6 months imprisonment on summary conviction.

I also advise you that we will undertake ad-hoc visits to ensure that the conditions of the licence are complied with and that the licensing objectives are promoted.
