GUIDANCE ON DECLARING PERSONAL AND PREJUDICIAL INTERESTS AT MEETINGS

The Council's Members' Code of Conduct requires Councillors to declare against an Agenda item(s) the nature of an interest and whether the interest is personal or prejudicial. Councillors have to decide first whether or not they have a personal interest in the matter under discussion. They will then have to decide whether that personal interest is also prejudicial.

A personal interest is an interest that affects the Councillor more than most other people in the area. People in the area include those who live, work or have property in the area of the Council. Councillors will also have a personal interest if their partner, relative or a close friend, or an organisation that they or the member works for, is affected more than other people in the area. If they do have a personal interest, they must declare it but can stay and take part and vote in the meeting.

Whether an interest is prejudicial is a matter of judgement for each Councillor. What Councillors have to do is ask themselves whether a member of the public – if he or she knew all the facts – would think that the Councillor's interest was so important that their decision would be affected by it. If a Councillor has a prejudicial interest then they must declare what that interest is. A Councillor who has declared a prejudicial interest at a meeting may nevertheless be able to address that meeting, but only in circumstances where an ordinary member of the public would be also allowed to speak. In such circumstances, the Councillor concerned will have the same opportunity to address the meeting and on the same terms. However, a Councillor exercising their ability to speak in these circumstances must leave the meeting immediately after they have spoken.

- Have a reasonable number of copies of agenda and reports (relating to items to be considered in public) made available to the public attending meetings of the Council, Cabinet, Committees and Sub-Committees.
- Have access to a list specifying those powers on which the Council have delegated decision making to their officers identifying the officers concerned by title.
- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.



Options

- 1 There are a number of options open to the committee:
 - the modification of the conditions of the premises licence;
 - to exclude a licensable activity from the scope of the licence;
 - the removal of the designated premises supervisor from the licence;
 - the suspension of the licence for a period not exceeding 3 months; and
 - the revocation of the licence.

3 The grounds for the review are:

This premises is located in a busy area of a medium size market town. It is a well established business that has been operating for a number of years. In previous years there has been direct police involvement due to the level of crime, disorder and public nuisance that has occurred in or in the vicinity of the premises. As a result of these issues specific conditions were applied to the licence. One of these conditions was that at any time licensable activities are undertaken a personal licence holder must be on the premises.

Since early 2010, there has been a steady increase in crime and disorder issues that are attributed to the premises and the way it has been managed. In addition there has been an increase in similar behaviour in the nearby area that again has been connected to other licensed premises. West Mercia Police commenced steps to address these issues in September 2010.

A number of incidents occurred in September and October 2010, which caused the police to make an unannounced visit to the premises on 16 October 2010. At this time there was no

personal licence holder present as required by the licence issued and from speaking to members of staff, details of who was in charge, were different to that as stated on the premises licence.

Further enquiries were made with both the brewery and the Licensing Authority. A meeting was arranged for all interested parties on 21 October 2010, present was brewery representative and three members of the Warren family - Rebecca Hallam, Ross Warren and Trevor Warren their father who had 'taken over' the premises. It was established that both Rebecca Hallam and Ross Warren held personal licences and the intention was for them both to run the premises. It was pointed out by the police that neither were named on the licence and that technically there was no DPS. The police listed their concerns and itemised particular issues regarding non compliance of licence conditions. In addition a copy of the licence for the premises was left with all parties so there was no misunderstanding of what the conditions were. It was further stated by the brewery and the Warrens, that the issue of the DPS would be sorted immediately. The Warrens volunteered the use of SIA registered staff for Fridays and Saturday evenings - this was supported by West Mercia Police with an expectation that in the passage of time it would become part of the licence conditions.

The issue regarding the DPS did not happen, and on 22 October 2010, the brewery were informed to do this without delay or a S19 Closure notice would be issued. An application to appointed Rebecca Hallam as the DPS was received later that day. On the same day a letter was hand delivered to the premises laying out the expectations of West Mercia Police with regards to compliance of the licence conditions.

During the evening of Friday/Saturday 22/23 October 2010, disorder occurred in and in the vicinity of the premises, this disorder was recorded on the council CCTV and is subject of a police investigation. It can be said that a number of breaches occurred with regards to the premises licence conditions specifically in place to address the licensing objectives.

As a result of this further contact was made with the brewery to discuss these issues and a further warning letter was hand delivered to the premises on 25 October 2010.

There was clear evidence that the persons responsible for running the premises at this time were disregarding significant conditions of the premises licence and therefore not adhering to the licensing objectives. These are -

- 1. Having a personal licence holder on the premises when licensable activities are taking place.
- 2. Allowing bottles, glasses and open containers to be taken from the premises
- 3. Allowing entry and re entry after 2330
- 4. Use of the rear beer garden after 2300
- 5. Music being played loudly after 2330

As a consequence to these issues on 04/11/10, a closure notice under S19 of the Criminal Justice and Police Act was served on the premises. At the time of serving no one with a personal licence was on the premises.

Further an application to review the premises licence was submitted by West Mercia Police on 10/11/10

In order to address the issues and the concerns, a further meeting was held between West

Mercia Police, a representative of the brewery (who hold the premises licence) and a Stuart HARRIS, who was being put forward as the new designated premises supervisor on behalf of the brewery and the Warrens who still were involved in the premises. This meeting established that Mr Harris would be the appointed DPS and that he was experienced in the licensing trade. It was agreed that a variation to amend the premises licence would be submitted, with the following new conditions -

- 1. Reduction in terminal hours for Sunday through to Thursday to midnight.
- 2. Provision of SIA registered door staff on Friday and Saturdays and any other time on a risk assessed basis.

An application was subsequently submitted for these variations and as a result the application to review the premises licence was withdrawn on 03/12/10.

It is fully understood that the premises is such that it will attract the younger customer. It was also understood that with a new DPS being appointed, he would need to put his authority on the premises and therefore time would be needed to address the issues that had been occurring. It was expected however that all conditions of the premises licence would be complied with.

However since the review notice was withdrawn in the region of 11 incidents have occurred, in or near the premises that gives rise for concern regarding the management of the premises and the operating hours and its impact on the licensing objectives and the local community.

At least 2 of these incidents involve the SIA door staff employed at the premises. There are allegations of unprofessional behaviour and use of excessive and unnecessary force. One of the incidents has been recorded on CCTV. This incident is subject to a separate police criminal investigation and has additionally been reported to the Security Industry Authority who licence and regulate security door staff.

Additional a number of further visits have been made to the premises - on these occasions, no one with a personal licence has been found on the premises. Additionally requests have been made to examine the incident log/book of the premises and also to obtain details of those door staff working at the premises on particular dates. None of these records were available. These issues are further non compliance with the premises licence.

It is the view of West Mercia Police that this premises is not adhering to the conditions of its premises licence, those currently connected to the premises who are personal licence holders are failing to comply with their responsibilities as required. Overall this has direct impact on the licensing objectives - in particular the objectives of the prevention of crime and disorder and the prevention of public nuisance.

The information submitted to support the grounds stated: Information obtained from West Mercia Police systems -

0034hrs 01/01/11 - male attempted to gain entry to premises - refused entry and then he smashed a window. Male detained by staff and arrested by police.

0139hrs 25/12/10 - males detained causing damage to the town Christmas tree - established males had been drinking in premises just prior to incident. Males detained and issued with fixed penalty notices.

2230hrs 24/12/10 - report of scuffle/fight inside premises - at least 20 ejected by staff. One male arrested another person issued with a dispersal notice.

0117hrs 19/12/10 - disorder outside premises. Matter recorded on CCTV. Male seen to punch window causing it to break, male detained by door staff. Certain members of door staff seen to use excessive and unnecessary force on customers, seen to punch, push, headbutt and seen to detain one person in particular by the neck. Matter subject to police investigation and SIA made aware.

2347hrs 17/12/10 - member of public approached police complaining that he had been threatened by member of door staff. Conduct denied by door staff

0022hrs 11/12/10 - disorder outside premises - one female arrested

0130hrs 05/12/10 - officer on patrol came across disorder at the front of the premises. Parties dispersed by police.

0002hrs 05/12/10 - disorder at premises - male removed by door staff and police.

0216hrs 27/11/10 - disorder at premises - domestic dispute - both parties known to have been in premises throughout the evening, both intoxicated, both dispersed

0022hrs 27/11/10 - report of disorder at premises - male detained at location/

2340hrs to 0020hrs 30/10/10 - CCTV reviewed by Police Licensing Officer shows that on various (3) occasions persons were seen standing at the front of the premises drinking. In addition numerous incidents of customers entering and re entering after 2330hrs

0145hrs 30/10/10 - officers attended premises, loud music still playing. Advice given to the person in charge.

2330hrs to 0125hrs 29/10/10 - CCTV reviewed by Police Licensing Officer - numerous incidents of customers entering and reentering and incidents of customers drinking at the front of the premises

2135hrs 29/10/10 - disorder in the street near to the premises - 4 persons arrested. Awaiting court appearance

0010hrs 24/10/10 - police attended premises - approx 15 customers in rear garden drinking. Manager warned.

2302hrs 22/10/10 - domestic incident outside the premises - one female arrested for being drunk and disorderly - had been seen leaving the premises a few minutes earlier

CCTV reviewed of premises - shows group of young males/females congregating outside the premises for a number of hours, as the evening progresses, people leave the premises with glasses/bottles and then seen to re enter. Disorder occurs with a number fighting, patrons leave premises and 'join in' and then go back into the pub. Incidents of people entering after 2330hrs. This evidence is part of a pro active police investigation, a number of persons have been arrested and either charged or issued with disorder fixed penalty notices

0110hrs 17/10/10 - officers entered premises and made one arrest for breach of bail conditions.

2338hrs 16/10/10 - report from staff at premises that disorder was about to happen. Officer attended and established a fight had happened inside the premises and a number of males had been ejected by staff

Letter of complaint dated 26/10/10 from the Ross Traders association reading disorder in Ross town, specifically voicing concerns over the running of The Eagle Inn

It should be noted that a large number of these incidents have occurred at weekends -Friday through to the early hours of Sunday mornings.

This is a total of 13 visits by officers.

On a number of the earlier visits officers encountered a member of staff who indicated he had a personal licence - this male was unable to produce it and enquiries with Herefordshire Licensing Authority established he was not licensed with them. West Mercia Police has a view that this male and those who have been running the premises have been 'misleading' them during their visits.

Further supporting information will be provided in due course.

5 **Current Licence**

The current licence authorises the following licensable activities during the hours shown: -

6 Representation

Agreed Conditions

- 7 The following conditions have been agreed between the Police and the Premises Licence Holders' solicitor:
 - A. Reduction in hours of Sundays to Thursdays such that the sale of alcohol is permitted between 10 am and 11 pm and the premises close at 11.30 pm.
 - <u>B.</u> Reduction of hours on Fridays and Saturdays such that the premises may sell alcohol from 10 am until 11.30 pm and close at midnight.
 - <u>C.</u> Live music the hours for the provision of live music are to match those for the supply of alcohol save for on Sundays were the provision of live music will finish at 2230 hours.
 - <u>D.</u> Recorded music the hours for recorded music are to match the opening hours of the premises i.e. be permitted on Sundays to Thursdays from 10 until 11.30 pm and on Fridays and Saturdays from 10 am until midnight.
 - <u>E.</u> Late night refreshment this is to be permitted from 11 pm until 11.30 pm on Sundays to Thursdays and from 11 pm until midnight on Fridays and Saturdays.

In addition, a number of conditions are to be imposed upon the premises licence. Those conditions are as follows:-

- (a) A personal licence holder will be on site at all times that the pub is trading.
- (b) 2 SIA registered door staff will be provided on Fridays and Saturdays until closing time.
- (c) Full records be kept and all incidents be recorded.

Key Considerations

- The licensing authority must take into account any relevant representations made. Relevant representations are those that:
 - relate to one or more of the licensing objectives;
 - have not been withdrawn; and
 - are made by the premises licence holder, a responsible authority or an interested party (who is not also a responsible authority).

Community Impact

This will depend on the resolution of the sub committee, as the premises is in close proximity to other businesses and some housing.

Legal Implications

- An appeal may be made within 21 days of the licence holder being notified of the licensing authority's decision to a magistrates' court. An appeal may be made by the premises licence holder, the chief officer of police and/or any other person who made relevant representations.
- The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal or until that appeal is disposed of.

- Responsible authorities and persons living within the vicinity or with a business interest within the vicinity of the premises.
- The notice of review was displayed on the premises which invited representation. The notice was also displayed at the offices of the Licensing Authority at Bath Street.

The issue regarding the DPS did not happen, and on 22 October 2010, the brewery were informed to do this without delay or a S19 Closure notice would be issued. An application to appointed Rebecca Hallam as the DPS was received later that day. On the same day a letter was hand delivered to the premises laying out the expectations of West Mercia Police with regards to compliance of the licence conditions.

During the evening of Friday/Saturday 22/23 October 2010, disorder occurred in and in the vicinity of the premises, this disorder was recorded on the council CCTV and is subject of a police investigation. It can be said that a number of breaches occurred with regards to the premises licence conditions specificial in place to address the licensing objectives.

As a result of this further contact was made with the brewery to discuss these issues and a further warning letter was hand delivered to the premises on 25 October 2010.

There was clear evidence that the persons responsible for running the premises at this time were disregarding significant conditions of the premises licence and therefore not adhering to the licensing objectives. These are -

- 1. Having a personal licence holder on the premises when licensable activities are taking place.
- 2. Allowing bottles, glasses and open containers to be taken from the premises
- 3. Allowing entry and re entry after 2330
- 4. Use of the rear beer garden after 2300
- 5. Music being played loudly after 2330

As a consequence to these issues on 04/11/10, a closure notice under S19 of the Criminal Justice and Police Act was served on the premises. At the time of serving no one with a personal licence was on the premises.

Further an application to review the premises licence was submitted by West Mercia Police on 10/11/10

In order to address the issues and the concerns, a further meeting was held between West Mercia Police, a representative of the brewery (who hold the premises licence) and a Stuart HARRIS, who was being put forward as the new designated premises supervisor on behlf of the brewery and the Warrens who still were involved in the premises. This meeting established that Mr Harris would be the appointed DPS and that he was experienced in the licensing trade. It was agreed that a variation to amend the premises licence would be submitted, with the following new conditions -

- 1. Reduction in terminal hours for Sunday through to Thursday to midnight.
- 2. Provision of SIA registered door staff on Friday and Saturdays and any other time on a risk assessed basis.

An application was subsequently submitted for these variations and as a result the application to review the premises licence was withdrawn on 03/12/10.

It is fully understood that the premises is such that it will attract the younger customer. It was also understood that with a new DPS being appointed, he would need to put his authority on the premises and therefore time would be needed to address the issues that had been occuring. It was expected however that all conditions of the premises licence would be complied with.

However since the review notice was withdrawn in the region of 11 incidents have occurred, in or near the premises that gives rise for concern regarding the management of the premises and the operating hours and its impact on the licensing objectives and the local community.

At least 2 of these incidents involve the SIA door staff employed at the premises. There are allegations of unprofessional behaviour and use of excessive and unnecessary force. One of the incidents has been recorded on CCTV. This incident is subject to a separate police criminal investigation and has additionally been reported to the Security Industry Authority who licence and regulate security door staff.

Additional a number of further visits have been made to the premises - on these occassions, no one with a personal licence has been found on the premises. Additionally requests have been made to examine the incident log/book of the premises and also to obtain details of those door staff working at the premises on particulat dates. None of these records were available. These issues are further non compliance with the premises licence.

It is the view of West Mercia Police that this premises is not adhering to the conditions of its premises licence, those currently connected to the premises who are personal licence holders are failing to comply with their responsibilites as required. Overall this has direct impact on the licensing objectives - in particular the objectives of the prevention of crime and disorder and the prevention of public nuisance.

Information obtained from West Mercia Police systems -

0034hrs 01/01/11 - male attempted to gain entry to premises - refused entry and then he smashed a window. Male detained by staff and arrested by police.

0139hrs 25/12/10 - males detained causing damage to the town Christmas tree - established males had been drinking in premises just prior to incident. Males detained and issued with fixed penalty notices.

2230hrs 24/12/10 - report of scuffle/fight inside premises - at least 20 ejected by staff. One male arrested another person issued with a dispersal notice.

0117hrs 19/12/10 - disorder outside premises. Matter recorded on CCTV. Male seen to punch window causing it to break, male detained by door staff. Certain members of door staff seen to use excessive and unnecessary force on customers, seen to punch, push, headbutt and seen to detain one person in particular by the neck. Matter subject to police investigation and SIA made aware.

2347hrs 17/12/10 - member of public approached police complaining that he had been threatened by member of door staff. Conduct denied by door staff

0022hrs 11/12/10 - disorder outside premises - one female arrested

0130hrs 05/12/10 - officer on patrol came across disorder at the front of the premises. Parties dispersed by police.

0002hrs 05/12/10 - disorder at premises - male removed by door staff and police.

0216hrs 27/11/10 - disorder at premises - domestic dispute - both parties known to have been in premises throughout the evening, both intoxicated, both dispersed

0022hrs 27/11/10 - report of disorder at premises - male detained at location/

2340hrs to 0020hrs 30/10/10 - CCTV reviewed by Police Licensing Officer shows that on various (3) occasions persons were seen standing at the front of the premises drinking. In addition numerous incidents of customers entering and re entering after 2330hrs

0145hrs 30/10/10 - officers attended premises, loud music still playing. Advice given to the person in charge.

2330hrs to 0125hrs 29/10/10 - CCTV reviewed by Police Licensing Officer - numerous incidents of customers entering and reentering and incidents of customers drinking at the front of the premises

2135hrs 29/10/10 - disorder in the street near to the premises - 4 persons arrested. Awaiting court appearance

0010hrs 24/10/10 - police attended premises - approx 15 customers in rear garden drinking. Manager warned.

2302hrs 22/10/10 - domestic incident outside the premises - one female arrested for being drunk and disorderly - had been seen leaving the premises a few minutes earlier

CCTV reviewed of premises - shows group of young males/females congregating outside the premises for a number of hours, as the evening progresses, people leave the premises with glasses/bottles and then seen to re enter. Disorder occurs with a number fighting, patrons leave premises and 'join in' and then go back into the pub. Incidents of people entering after 2330hrs. This evidence is part of a pro active police investgation, a number of persons have been arrested and either charged or issued with disorder fixed penalty notices

0110hrs 17/10/10 - officers entered premises and made one arrest for breach of bail conditions.

2338hrs 16/10/10 - report from staff at premises that disorder was about to happen. Officer attended and established a fight had happened inside the premises and a number of males had been ejected by staff

Letter of complaint dated 26/10/10 from the Ross Traders association rerding disorder in Ross town, specificially voicing concerns over the running of The Eagle Inn

It should be noted that a large number of these incidents have occurred at weekends -Friday through to the early hours of Sunday mornings.

On a number of the earlier visits officers encountered a member of staff who indicated he had a personal licence - this male was unable to produce it and enquiries with Herefordshire Licensing Authority established he was not licensed with them. West Mercia Police has a view that this male and those who have been running the premises have been 'misleading' them during their visits.

We write further to your recent telephone conversation with Richard Taylor at this office. We confirm that we act for Enterprise Inns PLC. Our client is the premises licence holder at these premises.

Enterprise lnns PLC owns around 7000 public houses in England and Wales. It does not, however, operate any of them. All of the pubs that are open and trading are subject to tenancy agreements of varying lengths. Those tenancy agreements/leases are such that the tenant operates his/her/its business out of our client's premises.

Immediately upon the issue of these review proceedings, Enterprise Inns Plc terminated the tenancy agreement of the operator and the premises closed.

Thereafter, our client's regional manager met with the Police and agreed terms upon which the Police were content to allow the premises to re-open. The premises have subsequently re-opened and we understand that subject to the terms agreed with the Police being imposed as conditions/amendments to the premises licence, the Police are satisfied that the premises may continue to operate.

The agreed terms are as follows:-

- 1. Reduction in hours of Sundays to Thursdays such that the sale of alcohol is permitted between 10 am and 11 pm and the premises close at 11.30 pm.
- 2. Reduction of hours on Fridays and Saturdays such that the premises may sell alcohol from 10 am until 11.30 pm and close at midnight.

- 3. Live music the hours for the provision of live music are to match those for the supply of alcohol save for on Sundays were the provision of live music will finish at 2230 hours.
- 4. Recorded music the hours for recorded music are to match the opening hours of the premises i.e. be permitted on Sundays to Thursdays from 10 until 11.30 pm and on Fridays and Saturdays from 10 am until midnight.
- 5. Late night refreshment this is to be permitted from 11 pm until 11.30 pm on Sundays to Thursdays and from 11 pm until midnight on Fridays and Saturdays.

In addition, a number of conditions are to be imposed upon the premises licence. Those conditions are as follows:-

- (a) A personal licence holder will be on site at all times that the pub is trading.
- (b) 2 SIA registered door staff will be provided on Fridays and Saturdays until closing time.
- (c) Full records be kept and all incidents be recorded.

We understand that subject to the above being imposed upon the premises licence, the Police require nothing further.

Dear Sir/Madam,

Please note my comments for the review.

Recently, I have had to complain many times about the noise and disorder caused by people using the Eagle pub. This has been a problem both IN and OUTSIDE the pub and in the side streets nearby.

The level of noise from the amplified music and screaming/shouting customers could be heard in my house on Kyrle St, night after night, into the early hours of the morning. The noise has been so bad that it has been difficult to sleep or enjoy the peace of my own home.

I have also had to go out in Kyrle street on several occasions to remonstrate with drunk and disorderly people, who were causing a disturbance as they left the pub; not just in the early hours of the morning when they closed but even at 9 and 10 pm at night.

The Eagle Pub was given many an opportunity to deal with the issues of noise and disorder, but sadly nothing really seemed to work; Resulting in it's closure for the second time in a matter of months. Allegedly, there were some issues i.e. illegal

substances and under age drinking on the premises, which could have exacerbated the problems.

In my opinion, the pub, with it's prominent position on Broad Street and the problems caused recently, should <u>not</u> be licensed till midnight. They have a large function room across the courtyard from the main building and I am concerned that this will generate even more noise should it be used <u>regularly</u> as a large 'party/club' venue under a 'late closing' license.


There are already 2 late night music establishments close by that cater for drinkers till 2 am: one of which is immediately opposite the Eagle Pub on the corner of Kyrle St.

Therefore, all things considered, I would object to the Eagle:

- a) closing any later than 11.30 pm and
- b) playing amplified music, like disco's and bands etc, more than 2 nights a week.... (perhaps restricted to a Friday and a Saturday?)

No doubt this could be reviewed in the future if the situation on (and around) the premises improves.

The new licensee (temporary?) and management now need to show that this *lovely local pub* can be run for the benefit of all, without causing crises and disturbances to the local residents, B&B's and restaurants etc nearby; Because living here OR coming to Ross on Wye for a visit, should be a pleasure rather than it being too rowdy, noisy and intimidating to endure!

Noting that the above establishment has been closed down, I am still obliged to note my concerns about the running of this Public House.

There does not appear to have been any element of order or managerial skill in running the place,

I live in a double glazed house about 150 Yards away from this Pub, but the noise emanating from it beggars believe, I cannot get to sleep for the "rowdiness", swearing, fighting and screaming particularly at weekends. It can go on until 0300 hrs. There is absolutely no control and general disorder. Matters are getting worse this situation has been appalling.

Also there has been a lot of drug taking on the premises, you can smell it, "skunk" in particular and you could also witness wheeling and dealing going on with hard drugs.

I have spoken to management about these problems but the young 20 year old "Manager" has stated that there is no problem in the place. Rest assured there has been I am NOT a very "Happy Bunny"

In considering their case I would request that the licensing hours terminate at 2300 hours latest and for everyone to be dispersed by 2330hrs latest.

I call upon the relevant authorities to implement my request. Monitoring of the situation will continue............if and when the place opens up again.

If needs be I will willingly attend any meeting that may be convened for the hearing of this unfortunate case.
