he following reasons given:

The Committee has been referred to the Gambling Commission Code of Practice for (Machines et al dated August 2014 and in particular, paragraph 2.1 which specifies that machines must be suitably located to ensure their proper supervision and that arrangements are in force. Further, that any gaming machines are not in close proximity banking machines.

The Committee must also be content with reference to Code provision 3.1 to safeguard cl and young people from engaging in underage gambling.

The Committee is not satisfied either as to the location of the new machine applied for r other requirements have been met having had no evidence put before it to allow it to I decision save for a site plan which it considers inadequate for its purpose.

The Committee notes the Gambling Act 2005 schedule 13 paragraph 4 which limits its op either granting or refusing any such application within narrow parameters. It is therefor that refusal is the only appropriate option for it to take.
