

Purpose

To consider an application for a review of a premise licence in respect of Balti Shabagh, 16 Burgess Street, Leominster, HR6 8DE called by Police Sergeant 3456 Reynolds of West Mercia Police

Recommendation

THAT:

The sub-committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- The steps that are appropriate to promote the licensing objectives,
- The representations (including supporting information) presented by all parties,
- The guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- The Herefordshire Council Statement of Licensing Policy 2015 2020.

Options

- 1. There are a number of option open to the committee in relation to the review:
 - The modification of the conditions of the premises licence;

- The exclusion of any licensable activities from the scope of the licence;
- The removal of the designated premises supervisor from the licence;
- The suspension of the licence for a period not exceeding 3 months; and
- The revocation of the licence
- 2. Where the authority takes a step mentioned in bullet point 1 and 2 above it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3. Alternatively it is open to the licensing authority to determine that no action is required to promote the licensing objectives or issue an informal warning in writing to the licence holder and/or to recommend improvement within a specified period of time.

Reasons for Recommendations

4. Ensures compliance with the Licensing Act 2003.

Key Considerations

- 5. The licensing authority must take into account any relevant representations made. Relevant representations are those that:
 - · relate to one or more of the licensing objectives;
 - have not been withdrawn; and
 - are made by the premises licence holder, a responsible authority or an interested party

- 7. The application for the review is attached (appendix 1)
- 8. Copies of the application were sent to the premise licence holder and responsible authorities.
- 9. In brief West Mercia Police's grounds for the review are:

The premises were subject to a visit from multiple agencies and two (2) persons were found to be working at the premises, one was an asylum seeker with no right to work in the UK and the other was in the UK illegally.

Premises History

10. The premises was first licensed in September 2005 where it was converted from an old justice's licence. Since it has been licensed, there have no changes to the licence.

Current Licence

11. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

Sale/Supply of Alcohol & Late Night Refreshment

- (1) On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 10 am to 12pm.
- (2) On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12 noon to 11:30pm
- (3) On Christmas Day: 12 noon to 11:30pm; for residential licence only from 12 noon to 10.30 with a break of four hours beginning at 3pm.
- (4) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- 12. The licence is also subject to a number of conditions.

Circumstances leading to the review

- 13. A pre-planned multi-agency operation took place on Thursday 14 June 2018 which involved West Mercia Police, UK Border and Immigration Office, Hereford & Worcester Fire & Rescue Service and departments from Herefordshire Council
- 14. At 19:00 hrs officers attended the premises known as Balti Shabagh as a result of intelligence with regards to the employment of illegal immigrants.
- 15. One male was working at the premises in the kitchen, he was detained at the premises as it was established that he was in the country illegally.
- 16. Another male was detained in the restaurant area and dressed as a waiter with labels identifying him as working at the premises. This male was an asylum seeker but had no rights to work in the UK.
- 17. The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.
- 18. As a result, this review was launched.

Summary of Representations

- 19. One representation has been received from a responsible authority Trading Standards (Appendix 3) which has yet to have been agreed.
- 20. One comment was received from the Councillor for the area that the premises is situated in (Appendix 4).
- 21. One comment was received from Leominster Town Council (Appendix 5)

Community Impact

22. Any decision is unlikely to have any impact on the local community.

Equality duty

- 23. There are no equality issues in relation to the content of this report.
- 24. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 25. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

Financial implications

26. There are unlikely to be any financial implications for the authority at this time.

Legal Implications

- 27. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 28. The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 29. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.
- 30. In this case it was summed up that: -
 - A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.
- 31. Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 32. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:

'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.

33. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

Right of Appeal

34. Schedule 5 gives a right of appeal which states:

An appeal may be made within 21 days to the Magistrates Court by the police or any person who has made a relevant representation and also by the premises licence holder once notified of the licensing authority's decision.

The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or until the appeal is disposed of.

Risk Management

35. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21days of being notified of the decision in writing.



As part of a pre planned operation a joint Multi Agency Targeted Enforcement (MATE) operation took place on Thursday 14 June 2018. This operation involved officers from West Mercia Police, the UK Border and Immigration office, Hereford and Worcester Fire and Rescue Service and departments of Herefordshire Council.

At 1900hrs (7.00pm) officers attended the Balti Shabagh, Burgess Street, Leominster.

This visit was intelligence lead with regards to the employment of illegal immigrants.

This premises is licensed for the licensable activities of the sale/supply of alcohol and late night refreshment.

The premises was open to the public.

One male ran from the premises and was caught as he fled. He was detained and admitted working in the kitchen. This male had no rights to be in the UK and no right to be employed in the UK.

Another male was detained in the restaurant area – he was dressed as a waiter with labels identifying him as working at the premises. This male was an asylum seeker but had no rights to work in the UK.

The employment of illegal immigrants is a criminal offence and is viewed as a serious matter as per the guidance issued under S182 of the Licensing Act 2003.

A civil penalty notice was served on the manager of the premises.

The view of West Mercia Police is that this is a serious matter and as such the premises licence of this premises should be revoked

Mandatory conditions where licence authorises supply of alcohol

No supply of alcohol may be made under the premises licence-

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating Schedule

Licensing conditions / objectives

General:

Alcohol may be sold or supplied:

- (1) On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 10 am to 12pm.
- (2) On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12 noon to 11:30pm

- On Christmas Day: 12 noon to 11:30pm; For residential licence only from 12 noon to (3)10.30 with a break of four hours beginning at 3pm.
- (4) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).

The above restrictions do not prohibit:

- a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- b) consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol to any person residing in the licensed premises;
- c) the ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;
- d) the sale of alcohol to a trader or club for the purposes of the trade or club;
- e) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- the taking of alcohol from the premises by a person residing there; or
- g) the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- h) the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises;
- the consumption of the alcohol on the premises by persons taking meals there during the first thirty minutes after the above hours, if the alcohol was supplied for consumption ancillary to those meals;

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

Suitable beverages other than intoxicating liquor (including water) shall be equally available for consumption with or otherwise as an ancillary to meals served in the premises.

Sale of alcohol for consumption on the premises.

Sale of hot food for consumption on the premises.

Suitable beverages other than intoxicating liquor shall be available for consumption as an ancillary to meals on premises.

Trading Standards would like to make representations for the above licence review that the WMP have instigated. Please see below.

Trading Standards have considered the review very carefully. Whilst they would support the police notion of revoking the licences to ensure the licence objectives are upheld, trading standards have not received any intelligence to have reason to believe children are at risk at this time.

Therefore trading standards have submitted conditions to ensure the further protection of children from harm at all the name premises as above.

- 1. All staff engaged in the sale of alcohol to be trained in responsible alcohol retailing to the minimum standard of BIIAB level 1 or any equivalent training course within 1 month of commencing employment at the premises. Where there are existing staff this training shall be completed within 3 months of the date that this condition first appears on the licence. No person shall be authorised to sell or supply alcohol until this training is completed. Refresher training will be conducted at 6 monthly intervals. Training records shall be kept on the premises and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 2. A written or electronic register of refusals will be kept including a description of the people who have been unable to provide required identification to prove their age. Such records shall be kept for a period of 12 months. It will be collected and reviewed on a weekly basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 3. The premises shall operate a Challenge 25 Policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of the Police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any sale area advertising the scheme operated.

Purpose

To consider an application for a review of a premise licence in respect of Taste of India, 52 West Street, Leominster. HR6 8UE called by Police Sergeant 3456 Reynolds of West Mercia Police.

Recommendation

THAT:

The sub-committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- The steps that are appropriate to promote the licensing objectives,
- The representations (including supporting information) presented by all parties,

- The Guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- The Herefordshire Council Statement of Licensing Policy 2015 2020.

Options

- 1. There are a number of option open to the committee in relation to the review:
 - The modification of the conditions of the premises licence;
 - The exclusion of any licensable activities from the scope of the licence;
 - The removal of the designated premises supervisor from the licence;
 - The suspension of the licence for a period not exceeding 3 months; and
 - The revocation of the licence
- 2. Where the authority takes a step mentioned in bullet point 1 and 2 above it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3. Alternatively it is open to the licensing authority to determine that no action is required to promote the licensing objectives or issue an informal warning in writing to the licence holder and/or to recommend improvement within a specified period of time.

Reasons for Recommendations

4. Ensures compliance with the Licensing Act 2003.

 - relate to one or more of the licensing objectives;
 - have not been withdrawn; and

7. The application for the review is attached (appendix 1).

- 8. Copies of the application were sent to the premise licence holder and responsible authorities.
- 9. In brief West Mercia Police's grounds for the review are:

The premises were subject to a visit from multiple agencies and two (2) persons were found to be working at the premises and in the UK illegally with no right to work.

Premises History

- 10. The premises was first licensed in November 2009 under the name Farzana's. There have been a number of changes to the licence since it was first issued.
- 11. In May 2010, Herefordshire Council received an application to transfer the licence to Farzanas Restaurant Ltd and to Vary the Designated Premises Supervisor (DPS) to Akhtar Hussain
- 12. In October 2012, Herefordshire Council received an application to transfer the licence to Mr Hafiz Ali and to change the name of the premises to Taste of India.
- 13. In November 2012, Herefordshire Council received an application to vary the DPS to Mr Hafiz Ali.
- 14. Since November 2012, Mr Hafiz Ali has been the licence holder and the DPS. No further applications have been received.

Current Licence

15. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

A performance of live music (Indoors)

Any playing of recorded music (Indoors)

Making Music(Indoors)

Dancing (Indoors)

Other entertainment facilities (Indoors)

Late Night refreshments (Indoors)

Sale by retail of alcohol (For consumption both on and off the premises)

Monday-Sunday: 10:00 - 00:00

Non-standard timings:

An additional 30 minutes after the non – standard finish timings for the provision of licensable activities

A further additional hour into the morning following every: -

Friday, Saturday, Sunday and Monday for each May Bank Holiday, Spring/Whitsun Bank Holiday and every August Bank Holiday weekend.

Thursday, Friday, Saturday, Sunday and Monday for the Easter Bank Holiday weekend.

Christmas Eve; Boxing Day.

To reflect existing New Year's Eve/Day hours.

16. The licence is also subject to a number of conditions.

Circumstances leading to the review

- 17. A pre-planned multi-agency operation took place on Thursday 14 June 2018 which involved West Mercia Police, UK Border and Immigration Office, Hereford & Worcester Fire & Rescue Service and departments from Herefordshire Council
- 18. At 18:00 hrs officers attended the premises known as Taste of India as a result of intelligence with regards to the employment of illegal immigrants.
- 19. One male was working at the premises in the kitchen, he was detained at the premises as it was established that he was in the country illegally.
- 20. Another male was detained in the restaurant area and dressed as a waiter with labels identifying him as working at the premises. This male was an asylum seeker but had no rights to work in the UK.
- 21. The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.
- 22. As a result, this review was launched.

Summary of Representations

- 23. One representation has been received from a responsible authority trading standards (Appendix 3) which has yet to have been agreed.
- 24. One comment was received from the Councillor for the area that the premises is situated in (Appendix 4).
- 25. One comment was received from Leominster Town Council (Appendix 5)

Community Impact

26. Any decision is unlikely to have any impact on the local community.

Equality duty

- 27. There are no equality issues in relation to the content of this report.
- 28. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 29. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

Financial implications

30. There are unlikely to be any financial implications for the authority at this time.

Legal Implications

- 31. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 32. The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 33. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.
- 34. In this case it was summed up that: -
 - A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.
- Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:
 - 'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.
- In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

Right of Appeal

38 Schedule 5 gives a right of appeal which states:

An appeal may be made within 21 days to the Magistrates Court by the police or any person who has made a relevant representation and also by the premises licence holder once notified of the licensing authority's decision.

The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or until the appeal is disposed of.

Risk Management

39. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21days of being notified of the decision in writing.



Trading Standards would like to make representations for the above licence review that the WMP have instigated. Please see below.

Trading Standards have considered the reviews very carefully. Whilst they would support the police notion of revoking the licences to ensure the licence objectives are upheld, trading standards have not received any intelligence to have reason to believe children are at risk at this time.

Therefore trading standards have submitted conditions to ensure the further protection of children from harm at all the name premises as above.

- 1. All staff engaged in the sale of alcohol to be trained in responsible alcohol retailing to the minimum standard of BIIAB level 1 or any equivalent training course within 1 month of commencing employment at the premises. Where there are existing staff this training shall be completed within 3 months of the date that this condition first appears on the licence. No person shall be authorised to sell or supply alcohol until this training is completed. Refresher training will be conducted at 6 monthly intervals. Training records shall be kept on the premises and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 2. A written or electronic register of refusals will be kept including a description of the people who have been unable to provide required identification to prove their age. Such records shall be kept for a period of 12 months. It will be collected and reviewed on a weekly basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 3. The premises shall operate a Challenge 25 Policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of the Police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council. Purpose

To consider an application for a review of a premise licence in respect of Summer Palace Oriental Restaurant, 60 Widemarsh Street, Hereford. HR4 9HG called by Police Sergeant 3456 Reynolds of West Mercia Police.

Recommendation

THAT:

The Sub-Committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- The steps that are appropriate to promote the licensing objectives,
- The representations (including supporting information) presented by all parties,
- The Guidance issued to local authorities under Section 182 of the Licensing Act 2003, and

• The Herefordshire Council Statement of Licensing Policy 2015 - 2020.

Options

- 1. There are a number of option open to the committee in relation to the review:
 - The modification of the conditions of the premises licence;
 - The exclusion of any licensable activities from the scope of the licence;
 - The removal of the designated premises supervisor from the licence;
 - The suspension of the licence for a period not exceeding 3 months; and
 - The revocation of the licence
- 2. Where the authority takes a step mentioned in bullet point 1 and 2 above it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 3. Alternatively it is open to the licensing authority to determine that no action is required to promote the licensing objectives or issue an informal warning in writing to the licence holder and/or to recommend improvement within a specified period of time.

Reasons for Recommendations

4. Ensures compliance with the Licensing Act 2003.

Key Considerations

- 5. The licensing authority must take into account any relevant representations made. Relevant representations are those that:
 - relate to one or more of the licensing objectives;
 - have not been withdrawn; and
 - are made by the premises licence holder, a responsible authority or an interested party
- 6. The details of the application are:

- 7. The application for the review is attached (appendix 1).
- 8. Copies of the application were sent to the premise licence holder and responsible authorities.

9. In brief West Mercia Police's grounds for the review are:

The premises were subject to a visit from multiple agencies and one (1) male was found to be working at the premises and in the UK illegally.

Premises History

- 10. The premises was first licensed in January 2006 under the name Aroon Rai Thai Restaurant.
- 11. In January 2008, Herefordshire Council received an application to Transfer the licence to Miss Shiau Hoon Low and to Vary the Designated Premises Supervisor (DPS) to Miss Shiau Hoon Low.
- 12. In March 2008, Herefordshire Council received a request to change the premise name on the licence to Summer Palace Oriental Restaurant.
- 13. Since January 2008, Miss Shiau Hoon Low has been the licence holder and the DPS. No further applications have been received.

Current Licence

14. The current licence (appendix 2) authorises the following licensable activities during the hours shown:

Sale/Supply of Alcohol Late Night Refreshment

- (1) On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 10 am to 12pm.
- (2) On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12 noon to 11:30pm
- (3) On Christmas Day: 12 noon to 11:30pm; For residential licence only from 12 noon to 10.30 with a break of four hours beginning at 3pm.
- (4) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day (or, if there are no permitted hours on the following day, midnight on 31st December).
- 15. The licence is also subject to a number of conditions.

Circumstances leading to the review

- 16. A pre-planned multi-agency operation took place on Friday 15 June 2018 which involved West Mercia Police, UK Border and Immigration Office, Hereford & Worcester Fire & Rescue Service and departments from Herefordshire Council
- 17. At 19:30 hrs officers attended the premises known as Summer Palace Oriental Restaurant as a result of intelligence with regards to the employment of illegal immigrants.
- 18. One male was working at the premises in the kitchen, he was detained at the premises as it was established that he was in the country illegally with no right to work in the UK.
- 19. The employment of illegal immigrants is a serious criminal offence and undermines the licensing objective of the prevention of crime and disorder.

20. As a result, this review was launched.

Summary of Representations

- 21. One representation has been received from a responsible authority Trading Standards (Appendix 3) which has yet to have been agreed.
- 22. One comment was received from the Councillor for the area that the premises is situated in (Appendix 4).

Community Impact

25. Any decision is unlikely to have any impact on the local community.

Equality duty

- 26. There are no equality issues in relation to the content of this report.
- 27. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 28. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

Financial implications

29. There are unlikely to be any financial implications for the authority at this time.

Legal Implications

- 30. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 31. The Committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 32. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative

Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black.

- 33. In this case it was summed up that: -
- 34. A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.
- Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 36. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:

'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.

37. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

Right of Appeal

38. Schedule 5 gives a right of appeal which states:

An appeal may be made within 21 days to the Magistrates Court by the police or any person who has made a relevant representation and also by the premises licence holder once notified of the licensing authority's decision.

The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or until the appeal is disposed of.

Risk Management

39. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21days of being notified of the decision in writing.



The above restrictions do not prohibit:

- a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- b) consumption of the alcohol on the premises by, or, the taking, sale or supply of alcohol to any person residing in the licensed premises;
- the ordering of alcohol to be consumed off the premises, or the dispatch by the vendor of the alcohol so ordered;
- d) the sale of alcohol to a trader or club for the purposes of the trade or club;
- e) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
- f) the taking of alcohol from the premises by a person residing there; or

Trading Standards would like to make representations for the above licence review that the WMP have instigated. Please see below.

Trading Standards have considered the reviews very carefully. Whilst they would support the police notion of revoking the licences to ensure the licence objectives are upheld, trading standards have not received any intelligence to have reason to believe children are at risk at this time.

Therefore trading standards have submitted conditions to ensure the further protection of children from harm at all the name premises as above.

- 1. All staff engaged in the sale of alcohol to be trained in responsible alcohol retailing to the minimum standard of BIIAB level 1 or any equivalent training course within 1 month of commencing employment at the premises. Where there are existing staff this training shall be completed within 3 months of the date that this condition first appears on the licence. No person shall be authorised to sell or supply alcohol until this training is completed. Refresher training will be conducted at 6 monthly intervals. Training records shall be kept on the premises and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 2. A written or electronic register of refusals will be kept including a description of the people who have been unable to provide required identification to prove their age. Such records shall be kept for a period of 12 months. It will be collected and reviewed on a weekly basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.
- 3. The premises shall operate a Challenge 25 Policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of the Police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any sale area advertising the scheme operated.
