- Have access to a list specifying those powers on which the Council have delegated decision making to their officers identifying the officers concerned by title.
- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.

Members of the public are advised that if you do not wish to be filmed or photographed you should let the governance services team know before the meeting starts so that anyone who intends filming or photographing the meeting can be made aware.

The Seven Principles of Public Life

(Nolan Principles)

1. Selflessness

Holders of public office should act solely in terms of the public interest.

2. Integrity

Holders of public office must avoid placing themselves under any obligation to people or organisations that might try inappropriately to influence them in their work. They should not act or take decisions in order to gain financial or other material benefits for themselves, their family, or their friends. They must declare and resolve any interests and relationships.

3. Objectivity

Holders of public office must act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias.

4. Accountability

Holders of public office are accountable to the public for their decisions and actions and must submit themselves to the scrutiny necessary to ensure this.

5. Openness

Holders of public office should act and take decisions in an open and transparent manner. Information should not be withheld from the public unless there are clear and lawful reasons for so doing.

6. Honesty

Holders of public office should be truthful.

7. Leadership

Holders of public office should exhibit these principles in their own behaviour and treat others with respect. They should actively promote and robustly support the principles and challenge poor behaviour wherever it occurs.

Recently several of us attended the LGA Annual conference in Bournemouth where I was pleased to support the campaign to raise awareness of the abuse that can happen towards some elected councillors. While mostly our experience is sensible with some strong questioning at most, sometimes in our communities and chambers behaviours and attitudes can take unfortunate turns. I understand that in the past being on the receiving end. Debating and disagreeing with one another is a healthy part of democracy, but abuse and intimidation crosses the line into dangerous territory. Last month saw the celebration of Armed Forces week and there were several specially organised events. Over 200 cadets took part in a Coronation parade at the Castle Green with the Lord Lieutenant taking the salute. The Vice Chair and myself attended the raising of the flag in High Town and afterwards we witnessed Hereford City Council signing the Armed Forces Covenant.



It is estimated that there some 2,500 serving officers living in Herefordshire with over 1,100 children in our schools.
According to the recently published 2021 Census information, 9,600 residents

in Herefordshire have previously served in the UK Armed Forces representing over 6% of the adult population. In our county 11% of all the households has at least one former veteran.

Herefordshire Council has long been a supporter of the Armed Forces Covenant and provides the secretariat for the County's Herefordshire Armed Forces Covenant Partnership. The partnership is made up of representatives of the main military charities and 130 organisations, who have pledged their support to recognise the needs of our armed forces community and remove disadvantage where it exists, particularly in relation to the areas of Health, Housing and Education. Councillor Barry Durkin is the Council's nominated Armed Forces Champion and Chair of the Covenant Partnership. Further information is available on the council's website link below.

Chairman's Charities

It is customary for the Chairman to adopt Charities, and I am working with the Cabinet member for Adult Care Cllr Gandy and the Director Hilary Hall on raising the awareness of the community's understanding and support of dementia. There has been recent encouraging news on improved treatment of the illness but it still places huge pressures on partners, families, friends and our care network. We all need to learn what we can do to support those impacted and become a more dementia friendly community.

My other charity is "We are Farming minds."



This year Herefordshire has seen five members of the Farming community take their lives, and I know that there are Councillors like myself who knew some of them personally. Farming can be a lonely occupation, hard work, tough financial conditions and lately come under strong public criticism.

But this is an issue not limited to Farming. We all welcome the changing attitudes and awareness to Mental health in our society today, and as community leaders we have a potentially important role in our wards to increase and influence peoples better understanding and support of this issue.

Since the last Council meeting I have attended many events, meetings and activities. Including duties with the Lord Lieutenant, participating in two citizenship ceremonies where twelve people swore allegiance to His Majesty and became UK subjects. Hosted a meeting with our County Mayors, their clerks and the High Sheriff. Briefings on operation London Bridge, Armed Forces covenant and Skylon park. I have visited NMITE and met with their Chairman and Chief Executive, attended the Hereford and Worcester Chamber awards and the launch of fundraising for Snodhill castle in the Golden Valley.



Chief Executive's Announcement – July 2023

Since our last Council in May, where we welcomed both new and returning councillors, individuals have settled into new roles familiarising themselves with the important and valuable work the council undertakes and the various priorities, issues and opportunities facing us and I am pleased to say that there is already much activity and progress under way for me to report on.

I have had a number of one-to-ones with our new councillors which have been going well. For those I haven't yet met and who would like to meet with me, please do get in touch to arrange one.

We continue to work hard to deliver the improvements required of our Children's Services. We are really delighted to begin our long-term improvement partnership with the Leeds Relational Practice Centre (LRPC). This represents a significant and really positive development in the improvement journey under way at Herefordshire Council and very welcomed by our senior leadership team and workforce.

Following the inadequate Ofsted inspection judgement in July 2022, the service, council and partnership have been galvanised into action and the improvement partnership with LRPC plays a key part in our onward journey at this stage and over the next two years. There is clearly much to do and we welcome the knowledge, skills, expertise and experience they are able to offer us – they have assisted many other local authorities in this space and are well respected in the sector. Leeds have been on an improvement journey themselves. They have been judged to be Outstanding (twice) and our early conversations indicate that there is a really good 'fit' which bodes well for the developing partnership.

We have been working hard to put the building blocks of improvement in place to establish a solid foundation upon which to build. At this point in our improvement journey, we welcome the support and challenge LRPC will bring. This is very timely and will assist with our focus and pace. Sal Tariq the Programme Director of LRPC is invited to attend the Herefordshire Children's Improvement Board to make sure that the improvement partnership continues to develop and is reported as an integral part of the work of the Improvement Board.

Further positive achievements are that work is nearly completed at Herefordshire Council's Plough Lane offices to transform a series of rooms into family and child-friendly spaces with the project due to be completed at the end of July. The rooms are being transformed for families who are meeting Children's Services care and support staff. A dedicated entrance to the building is being created so families can access the new area directly without having to go through the main reception area. We look forward to the opening of these new facilities very soon.

Following the feedback we shared from our first Ofsted monitoring visit in March that cited examples of good and improved practice, and raised no serious safeguarding concerns, we now await the feedback from our second monitoring visit held on 28 and 29 June, where the focus of inspection was on children in need or subject to a protection plan. We know that there is still much more to do and as a council, we remain committed to supporting everyone working with children and families in Herefordshire to achieve this.

We will be holding two Member Briefings to update members on the latest Ofsted visit where we will share our current challenges and review our latest performance. These will be taking place on 2 August at 1pm to 2pm and on 3 August at 3pm to 4pm.

Supporting our priority to invest in our communities and grow our local economy through tourism, I am pleased to report that we have successfully been awarded £5 million grant funding from the National Lottery Heritage Fund, which supports initiatives to create positive and lasting change for people and communities. This really is a significant achievement given Herefordshire Council was granted the full amount it bid for, which we believe has never been granted to any other applications made to the Fund.

The funds are to redevelop the Grade II listed Hereford Museum and Art Gallery, significantly enhancing the city's cultural offer. The project will see the introduction of a contemporary museum and exhibition centre to the cathedral city. The revamped museum will also provide a new permanent home for the Herefordshire Hoard, one of the most significant early medieval treasures ever discovered in Britain.

This month, we officially launched the county's new Health and Wellbeing Strategy at Hereford racecourse. Over 100 representatives from across the public, private and voluntary sector came together to celebrate our past achievements in keeping people healthy and making plans on how we deliver our two new priorities - improving mental wellbeing and the best start in life.

Last week, regional colleagues undertook a short review of adult social care to assess the service's preparedness for the new inspection regime to be undertaken by the Care Quality Commission. Inspections under the framework are due to start in the autumn. The review was informal but the team met with the Leader of the Council, Chief Executive, managers, staff, people with lived experience, support organisations and partners. There was positive feedback about the direction of travel and the council's general readiness for inspection. There is no formal report but the team's feedback will feed into the service's ongoing improvement and transformation plans.

In June, the Home Office notified Herefordshire Council of a proposal to use the Talbot Hotel in Leominster as contingency accommodation for asylum seekers. This would be in addition to the current use of the Three Counties Hotel in Hereford. We are very aware of the pressure on the system supporting asylum seekers and Herefordshire has a significant track record in recent years of participating in government migration schemes. However, alongside the regional Strategic Migration Partnership, and local police, health and fire services we have raised a number of concerns in our feedback on this proposal through formal channels to the Home Office.

The Home Office will be carrying out due diligence checks over the coming weeks to assess the suitability of the property, following which they will inform the council of their final decision.

This month, the Rt Hon Michael Gove MP, Secretary of State for Levelling Up, Housing and Communities Minister for Intergovernmental Relations notified all local authorities that the Office for Local Government (Oflog) has been established and new Best Value Guidance has been published. Oflog will provide authoritative and accessible data and analysis about the performance of local government, and support its improvement.

Oflog will help councillors and the public have the information they need to scrutinise more effectively local decisions. It will also ensure council leaders can compare themselves against their peers and find examples of good practice to learn from; and it will allow central government and its partners to identify where there might be challenges and a need to step in to give support, where appropriate.

At the end of May, Herefordshire welcomed a visit by the Secretary of State for the Environment, Food & Rural Affairs (Defra), the Rt Hon Thérèse Coffey MP, accompanied by her local parliamentary colleagues, the Rt Hon Jesse Norman MP and Bill Wiggins MP. She convened a roundtable to meet with the farming community, representatives of Herefordshire Council, Natural England, the Environment Agency, the Welsh Government, Powys and Monmouthshire Councils, local partners and environmental groups, to discuss the environmental challenges being faced across the River Wye Catchment and the region. She was keen to understand the issues first-hand and encouraged proactive collaboration and urgent action.

We have used this opportunity to respond directly to the Secretary of State. We have suggested that Government creates and oversees a Task Force responsible for driving the necessary changes, and which equips statutory agencies and local partners with the capabilities to tackle the environmental challenges to bring about the changes so needed to restore the Wye Catchment, its rivers and the ecosystems across our region.

- 5. Of the decisions taken since my administration came in to office, one key decision was taken under the general exception provisions (giving more than five but less than 28 calendar days' notice) and none were taken under the urgency provisions (less than five days' notice).
- 6. Included in my report is a summary of what I consider the most significant priorities, as well as some additional subjects that I hope will be of interest.

Leader's Report



It is a great privilege to be elected as Leader of Herefordshire Council. Thank you for putting your trust in me. I want to use my first report to council to set out my key areas of focus. I am sure you will agree with me, the improvement of children's services must be the top priority for this council, and for all members.

Further focus must be on stepping up measures to addressing the pressing issues we have with our rivers and our roads in the county. Unlocking this county's fantastic potential is about listening to our businesses and communities, working in partnership to deliver the best outcomes for Herefordshire.

We all have a part to play in Herefordshire's future and I really look forward to working with you all in this shared endeavour.

1. Children and Young People

a. Improvement Board and improvement plan

Members will be familiar with the content of the Ofsted monitoring visit report which was published and debated at the cabinet meeting again on 22nd June 2023. Ofsted's most recent monitoring visit was conducted on 28th and 29th June 2023, the letter is due for publication on 2nd August 2023. I am unable to give any detail of the likely content of that report as it is embargoed until it has been published.

The improvement board continues to progress the details of the children's improvement plan and children's services continue to benefit from the scrutiny and support of the children's commissioner, Eleanor Brazil, and the DfE improvement advisor/independent chair of the improvement board, Gladys Rhodes White. The improvement board recently agreed proposals to rationalise the improvement board infrastructure. These are designed to streamline and coordinate arrangements, improve reporting accountability and increase the pace of the overall improvement programme.

In addition, we welcome our recently announced long term (2 years) improvement partnership with Leeds City Council Children's Services. Leeds have previously been on their own improvement journey and have been rated outstanding twice by Ofsted. They are much respected in the sector having supported several other inadequate local authorities and established a strong reputation for restorative and relational practice.

But, we recognise we still have much progress to make and we are not complacent in this regard.

b. Meeting with parents and families

Councillor Ivan Powell, the Cabinet Member for children and young people is clear in his commitment that the ongoing work to endeavour to reach resolution for families has to occur in tandem with the improvement journey and the need to deliver the latter at pace.

In this regard, members will be aware that the Independent Commission to 'Consider Families Experience of Children's Services in Herefordshire' conducted its work in March and April 2023 - the report was published in June 2023. The terms of reference for the commission set out its purpose as follows:

- I. To give parents and families an opportunity to tell their story to an independent panel.
- II. To identify any steps that the council and partners can and should take as a result of hearing families' testimonies, either in relation to individual cases or in respect of general issues.
- III. To learn from their experiences and to ensure that this knowledge is used to inform improvements to Children's Services.
- IV. To ensure that, as far as possible, families feel that their concerns have been heard and addressed, and that this is as much as can be done to resolve matters.

During the commission, matters raised by some families (eleven of the twenty who made representations) were reported by the panel to the local authority for consideration and response. This work was conducted and the relevant families received a personalised letter from the Service Director for Improvement on 2nd June 2023.

Following the cabinet meeting on 22nd June 2023 Councillor Powell met with three parents at their request. During that meeting it became apparent that for some families despite their involvement in the commission their individual responses from children's services left them with unresolved matters. To that end, I have asked that further meetings with me and the cabinet member for children and young people take place. The first of those meetings, accompanied by the Service Director for Improvement, was held during the evening on 5th July 2023 resulting in an agreed course of action between the family and children's services.

A letter was sent to each individual family thanking them for their contributions and extending the offer to meet with them again, should they so wish to do.

It is acknowledged that there are other families who, for their own reasons, did not wish to contribute to the families' commission but do have similar and related concerns about their experience of children's services in Herefordshire. Where these approach the organisation they will similarly be afforded the opportunity of a meeting with a view to resolving any outstanding matters.

2. River restoration

It has been a busy time stepping up the council's work on river restoration. With the help of our MP's we were able to secure a ministerial roundtable held here in Hereford with Theresa Coffey MP, Secretary of State for Environment, Food and Rural Affairs. The meeting took place in the shadow of the announcement by Natural England that the condition status of the Wye had move to unfavourable and declining. This change means that all the agencies involved must now take further steps and measures to prevent further deterioration of the river and comply with the Habitats Directive.

This only adds to urgency, so in my welcome letter to the Secretary of State, sent in advance of the meeting, I called for a cross border task force to bring the right people together. We would like to see this initiative being led by a high profile River Champion to secure more credible national leadership to coordinate the tangible efforts of the many agencies and partners involved. I am pleased to see this proposal enjoys cross party political support in both England and Wales and we continue to press hard for this.

We have not lost sight of the desperate plight of the County's homebuilders and have attended Meetings at number 10 to discuss how we deal with Nutrient Neutrality. This demonstrates that we now have engagement at the highest level. We have also submitted a £2.1m bid to DLUHC seeking further support to deliver new approaches to mitigation and to cement Herefordshire's role as a respected national leader in tackling nutrient neutrality challenges.

3. Road Improvements

Addressing the condition of our roads is another pressing priority. Government awarded the Council £2.558m to help it improve the condition of its roads. We will be using this tranche of funding to allow our works teams to effectively patch roads across the county, preparing them for surface dressing in the spring of 2024.

I am committed to putting investment in to an ambitious programme of road surface repairs. We recognise that this investment is not enough to repair every road surface in the county. But we will continue to work with our public realm partners and with our local communities to ensure this new investment is targeted appropriately. By investing this money over the coming months we will be better prepared for winter and better able to start our larger programme of surface dressing early in the 24/25 financial year.

4. County Wide Infrastructure

Following a recent meeting with the Chief Executive of Midlands Connect we had some constructive discussions around areas of shared priority.

Upgrading the line between Hereford and Birmingham is an area of long overdue investment. We are working hard to ensure that our proposals for the transport hub, together with their plans for twin-tracking and passing places on the line would increase the number of trains and faster services between Hereford and Birmingham.

We have also considered - within the framework of National Highways priorities – the scope for Herefordshire during their prioritisation of investment. We will be pushing hard to ensure National Highways keep Herefordshire's ambitions front and centre in their plans. Cllr Price and I will be lobbying hard for any new major infrastructure investments to include scope for major projects such as the Southern Link and western crossing to be reconsidered.

These early discussions will be just one example of where my administration will be reengaging with strategic regional and national partners. It is my mission to present our amazing county as being open for business, strategic in our thinking, and driven by a determination to support our communities so that they can thrive in Herefordshire.

5. The Local Plan

There have been a number of additional pieces of evidence base which have been received since the initial drafting of the Local Plan. It is important to reflect upon these to ensure that the plan placed on public consultation is based on the most up to date and robust information. These studies include Landscape Character Assessment, Green and Blue Infrastructure Study and initial Strategic Environmental Assessment and Habitat Regulation Assessment. In addition initial viability feedback on the draft policies and more detailed information regarding infrastructure needs and requirements have been received.

With this in mind, the consultation placed for the 19 June to 8 September have been paused and the Cabinet are currently undertaking a review of the draft plan with officers. We have had constructive meetings with officers following two workshops on 10 and 11 July. The intention is to undertake a public consultation as soon as possible later in the year.

6. Health and Wellbeing Strategy Launch

On Wednesday, 11 July, I was pleased to be amongst public, private and voluntary sectors for the launch of Herefordshire's joint health and wellbeing strategy.

This is another brilliant example of what we do really well – working in partnership to create a shared strategy for the Health and Wellbeing Board. It provides leadership and example to support the Integrated Care System and allows local insights to assist in the development of local health and wellbeing intervention for our local population.

This 10-year plan outlines the county's top two priorities to help people live better and longer lives. Namely, giving people the best start in life, and having good life-long mental wellbeing. These are, of course, national priorities.

Our strategy explores local dimensions around these key objectives. For example, while life expectancy in Herefordshire is slightly better than elsewhere in England it is worse in our more deprived areas. For those living in poverty there is a lower life expectancy of 5.4 fewer years than in wealthier communities.

The overall ambition of the board is to improve the health and wellbeing of everyone living in Herefordshire. To do this, it recognises it needs to close the gap between poorer and wealthier residents. It troubles me greatly, as I know it will you, to see this disparity of life expectancy within our county.

Taking action to deliver these changes are now the next important steps. Delivery plans will be developed for each of the two priorities co-produced with partners, communities and those with lived experience, together with a dashboard that will be subject to monitoring and review.

7. Care Quality Commission – Readiness Report

Staying on the health and wellbeing theme, regional colleagues recently undertook a short review of adult social care to assess the service's preparedness for the new inspection regime to be undertaken by the Care Quality Commission. Inspections under the framework are due to start in the autumn. The review was informal but the team met with the Leader of the Council, Chief Executive, managers, staff, people with lived experience, support organisations and partners.

There was positive feedback about the direction of travel and the council's general readiness for inspection. There is no formal report but the team's feedback will feed into the service's ongoing improvement and transformation plans.

8. Relocating the Hereford Library and Learning Resource Centre (HLCC).

As members will be aware, cabinet considered the review of the proposed location of the HLLC. My cabinet requested this review with one simple but fundamental ambition in mind to deliver the best possible high-quality library and new learning centre for the people of Herefordshire. Our review has been undertaken to ensure that we identify the best possible location for a library and learning centre. A detailed business case will be presented back to Cabinet in the autumn for further consideration.

The ambition is to create a modern 21st century library that offers not just world class learning opportunities but a wonderful visitor experience for all.

9. 'My Herefordshire' Children's Art Competition

I was delighted to help showcase some of Herefordshire's best young artists who have been honoured for their creative talents and some top prizes in a special competition run by Herefordshire Council.

The 'My Herefordshire' artwork competition was open to local schools and nurseries across Herefordshire earlier this year. The competition gave young people the chance to display their artistic skills and express what they like best about living in the county.

A panel of council judges had the difficult task of narrowing down the eye-catching artwork to 10 winners, who received their prizes at a presentation event on 17 July at the council's Plough Lane offices.

The winners came from five schools, St Joseph's Primary School, Trinity Primary School, Steiner Academy Hereford, Walford Primary School, and Ashfield Park Primary School. Each of the winners were presented with book tokens, a printed canvas of their artwork and a signed certificate.

Copies of the artwork will be hung on the walls of the Plough Lane Atrium for staff and visitors to enjoy.

- Motions must be about matters for which the council has a responsibility or which affect Herefordshire.
- 4 Motions for which notice has been given will be listed on the agenda in the order in which notice was received unless the member giving notice states, in writing, that they propose to move it to a later meeting or withdraw it.

be varied at the discretion of the chairman.

Two motions have been received and will be debated at the meeting. The motions for discussion are set out below:

Motion 1 – County Athletics Track

(Proposed by Councillor Jim Kenyon, Seconded by Councillor tbc)

This Council asks the cabinet to reconsider the decision made by council back in February, at the budget meeting, regarding funding for the County Athletics Track in Hereford. Since that meeting they have attracted additional funding from the levelling up government fund and the local community following the initial pump prime funding from Hereford City council of £70k the short fall for the project to be fully funded is £70k the total project cost is £450k.

Motion 2 – Climate and Ecological Emergency

(Proposed by Councillor Ellie Chowns, Seconded by Councillor tbc)

In March 2019 Herefordshire Council unanimously passed a motion recognising the climate emergency. This was updated in December 2020 to include recognition of the ecological emergency.

Since that time the scale of the challenge has become greater, and the need for action more urgent. Climate change is driving extreme weather such as heatwaves that cost lives. Wildlife is under extreme pressure, and species loss is accelerating.

Here in Herefordshire we can see the effects of the climate and ecological emergency very clearly at local level. Climate change contributed to the unprecedented flooding in February 2020 that caused immense damage and disruption. Pollution has caused a collapse in biodiversity in our precious Rivers Lugg and Wye, to the great concern of local residents, as well as impacting on our county's reputation and economy.

This motion therefore offers members the opportunity to renew Herefordshire Council's commitment to taking action to tackle the climate and ecological emergency.

Motion

That this Council resolves to declare its recognition of the climate and ecological emergency, and calls on the executive to:

- a) Integrate consideration of climate mitigation and adaptation, and nature recovery, into all council decision-making; and ensure that all decisions are compatible with the goal of a zero-carbon, nature-rich Herefordshire by 2030;
- b) Commit to further accelerating reduction of the council's own carbon footprint towards the target of net zero by 2030, including taking every opportunity to reduce use of fossil fuels;
- c) Commit to taking every opportunity to improve wildlife protection and better management of land for nature, including on council-owned land;
- d) Support and strengthen action with partners towards the goal of a zero-carbon, nature-rich Herefordshire by 2030, including through the Herefordshire Climate and Nature Partnership Board;
- e) Provide the necessary resources for officers to deliver on the council's carbon reduction and nature protection commitments, and to develop evidence based indicators to enable the council to monitor and report annually on the county's position.

RESOLVED: That -

So this Council urges the executive to press-engage with both the EA and NRW, consulting Powys and Monmouthshire CCs and other interested parties as necessary, to press for nothing less than a Water Protection Zone (WPZ*) for the whole of the River Wye system.

This should include pushing both Agencies for work to start asap on detailed modelling to demonstrate the need for a WPZ, in order to put a business case to DEFRA; Also for funding for this work to go ahead; And for the Executive to provide regular reports to Council on progress.

29 July 2022	Cabinet Commission on Phosphates	Please see update under the Leader's report.

RESOLVED: We welcome all the actions that Herefordshire Council and other statutory partners have taken and continue to take to address the issue of phosphate over-loading of the River Wye SAC.

As scientific research now exists which indicates that further impactful and coordinated responses are required to save the river catchment from permanent eutrophication, this motion calls upon the executive to:

Consider including the following areas of urgent action in the remit of the proposed Cabinet Commission on Phosphates:

- 1. Request of government that:
 - the new Minister in charge of Defra clarifies what additional evidence they require before they would be prepared to reconsider the Council's Water Protection Zone request for the Wye;

 DEFRA commission the catchment-wide appraisal of nutrient flows in the Wye (and all other river systems within Herefordshire) that will inform and enable consideration of the cumulative impact of housing, agricultural and industrial development.

2. Request that:

- the Environment Agency improve the effectiveness of their regulatory and enforcement actions and their work with partners, to deliver best practice in sewerage treatment and manure management and to encourage and support the ongoing work of compliant farm businesses.
- Natural England update their current (2011) River Wye water quality data in relation to the SSSI and SAC targets in a timeframe which is aligned to the current update of the Herefordshire Local Plan; and provide guidance on appropriate conditioning of permissions to achieve the necessary reduction targets.
- 3. Identify now how best to use the update of the Local Plan to:
 - recognise and address proportionately the legacy and ongoing contribution to phosphate pollution made by each development sector;
 - promote and support best practice nutrient actions across all sectors;
 - encourage and incentivise catchment restoration through alternative, restorative and regenerative land use; and
 - decommission intensive poultry units that have reached the end of useful life.
- 4. Using the 'precautionary principle' explore immediately the adoption of a planning position statement for all future development which accurately reflects the sector risks identified in research; and reinstating the consideration of 'cumulative impact', in co-ordination with Powys County Council, to ensure that the Supplementary Planning Document on Agricultural Development, which is already in progress, enables officers to exercise the full extent of the council's planning powers in these regards.
- Consider urgently how data sharing, data management and data visualisation can support science-led and evidence-based decision-making at all levels and across all stakeholders.

The Council, therefore, calls on the Executive to explore the construction of a new multi-storey car park on the current bus station site to serve the needs of Hospital Staff, visitors and contractors as well as to provide additional car parking capacity to support the railway station and town centre.

3 March 2023	River Wye byelaws	Please see update under the Leader's report.

RESOLVED:

This motion calls upon the executive to consider making an application to the UK government to recognise a byelaw drafted by Herefordshire Council to invest the River Wye and tributaries within the county of Herefordshire with the following rights from the rights of rivers declaration.

- 1. The right to be free from pollution
- 2. The right to perform essential functions within its ecosystem
- 3. The right to flow
- 4. The right to feed and be fed by sustainable aquifers,
- 5. The right to native biodiversity
- 6. The right to regeneration and restoration
- 7. With an additional right to be protected from physical damage.

Community impact

- Herefordshire Council's adopted code of corporate governance provides the framework for maintaining high standards of corporate governance in order to achieve the council's vision of "people, organisations and businesses working together to bring sustainable prosperity and well-being for all, in the outstanding natural environment of Herefordshire."
