# The Public's Rights to Information and Attendance at Meetings

#### YOU HAVE A RIGHT TO: -

- Attend all Council, Cabinet, Committee and Sub-Committee meetings unless the business to be transacted would disclose 'confidential' or 'exempt' information.
- Inspect agenda and public reports at least five clear days before the date of the meeting.
- Inspect minutes of the Council and all Committees and Sub-Committees and written statements of decisions taken by the Cabinet or individual Cabinet Members for up to six years following a meeting.
- Inspect background papers used in the preparation of public reports for a period of up to four years from the date of the meeting. (A list of the background papers to a report is given at the end of each report). A background paper is a document on which the officer has relied in writing the report and which otherwise is not available to the public.
- Access to a public Register stating the names, addresses and wards of all Councillors with details of the membership of Cabinet and of all Committees and Sub-Committees.
- Have a reasonable number of copies of agenda and reports (relating to items to be considered in public) made available to the public attending meetings of the Council, Cabinet, Committees and Sub-Committees.
- Have access to a list specifying those powers on which the Council have delegated decision making to their officers identifying the officers concerned by title.
- Copy any of the documents mentioned above to which you have a right of access, subject to a reasonable charge (20p per sheet subject to a maximum of £5.00 per agenda plus a nominal fee of £1.50 for postage).
- Access to this summary of your rights as members of the public to attend meetings of the Council, Cabinet, Committees and Sub-Committees and to inspect and copy documents.



#### The Seven Principles of Public Life

(Nolan Principles)

#### 1. Selflessness

Holders of public office should act solely in terms of the public interest.

#### 2. Integrity

Holders of public office must avoid placing themselves under any obligation to people or organisations that might try inappropriately to influence them in their work. They should not act or take decisions in order to gain financial or other material benefits for themselves, their family, or their friends. They must declare and resolve any interests and relationships.

#### 3. Objectivity

Holders of public office must act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias.

#### 4. Accountability

Holders of public office are accountable to the public for their decisions and actions and must submit themselves to the scrutiny necessary to ensure this.

#### 5. Openness

Holders of public office should act and take decisions in an open and transparent manner. Information should not be withheld from the public unless there are clear and lawful reasons for so doing.

#### 6. Honesty

Holders of public office should be truthful.

#### 7. Leadership

Holders of public office should exhibit these principles in their own behaviour. They should actively promote and robustly support the principles and be willing to challenge poor behaviour wherever it occurs.

#### **Purpose**

To consider an application for a grant of a premises licence in respect of The Byres, Townsend Farm, Brampton Abbotts, Ross-on-Wye. HR9 7JE under the Licensing Act 2003

# Recommendation(s)

That:

The sub committee determine the application with a view to promoting the licensing objectives in the overall interests of the local community. They should give appropriate weight to:

- a) The steps that are appropriate to promote the licensing objectives,
- b) The representations (including supporting information) presented by all parties,
- c) The guidance issued to local authorities under Section 182 of the Licensing Act 2003, and
- d) The Herefordshire Council Statement of Licensing Policy 2020 2025.

#### **Reasons for Recommendations**

Ensures compliance with the Licensing Act 2003

#### **Alternative options**

- 1. There are a number of options open to the sub-committee:
  - a) Grant the licence subject to conditions that are consistent with the operating schedule accompanying the application and the mandatory conditions set out in the Licensing Act 2003.
  - Grant the licence subject to modified conditions to that of the operating schedule where the sub-committee considers it appropriate for the promotion of the licensing objectives and add mandatory conditions set out in the Licensing Act 2003,
  - c) To exclude from the scope of the licence any of the licensable activities to which the application relates
  - d) To refuse to specify a person in the licence as the premise supervisor, or
  - e) To refuse the application

#### **Key considerations**

#### **Licence Application**

- 2. The application for the grant of a premises licence has received relevant representations and is therefore brought before the sub-committee for determination.
- 3. Herefordshire Council Statement of Licensing Policy 2020 to 2025 states "All representation must be 'relevant', for example they must be about the likely effect of the grant of the application". This followed paragraph 8.57 in the s182 Guidance which uses the same wording.
- 4. The details of the application are:

#### **Summary of Application**

5. The application and advice was applied for using the licensing authority's pre-application service and can be found at appendix 1. The application requests the grant of a premises licence to allow the following licensable activities, during the hours shown:

Live & Recorded Music (Indoors/Outdoors), Friday 18:00 - 21:00, Saturday 13:00 - 22:00, Sunday 15:00 – 19:00

Sale/Supply of Alcohol (consumption on and off the premises) Friday 15:00 – 22:00, Saturday 13:00 – 23:00, Sunday 13:00 – 20:00

#### Non-Standard Timings:

Bank Holiday Sunday's 12:00 – 22:00, Bank Holiday Monday's 12:00 – 19:00, Christmas Eve 12:00 – 23:00, New Year's Eve 12:00 – 01:00, Valentine's Day 12:00 – 23:00 Late Night Refreshment (Indoors/Outdoors) New Year's Eve 23:00 – 01:00

Under the Live Music Act 2012 (as amended), an alcohol licenced premises can have live and/or recorded music from 08:00 – 23:00 for up to 500 people, without the need for these activities to be on a premises licence

Late Night Refreshment is only applicable between the hours of Monday – Sunday 23:00 – 05:00

A set of conditions to promote the licensing objectives based upon a model pool of conditions from Herefordshire Council's Licensing Policy 2020-2025 were proposed by the applicant and these will form as part of the licence if granted (Appendix 2).

#### **Summary of Representations**

- 6. One (1) representation has been received from the responsible authorities Environmental Health. The sets of conditions proposed have been accepted by the applicant and can be found at Appendix 3.
- 7. 14 relevant representations have been received from members of the public in line with the licensing objective Prevention of Public Nuisance, which the licensing authority have accepted as being relevant (Appendix 4).
- 8. Two (2) representations were received from members of the public and were not accepted by the licensing authority as being relevant, therefore was rejected. A copy has been kept on file for future reference.
- 9. A number of relevant public representations highlighted concerns about the increased traffic, though the licensing sub-committee and all parties should be made aware, this cannot be considered under the Licensing Act 2003. All parties have been advised of this prior to today's hearing.
- 10. On 17 September 2023, the applicant wrote to the objectors outlining the application made and the conditions he has proposed and agreed to adhere to (appendix 5).
- 11. As a result, two (2) representations made by the public have been withdrawn (appendix 6).

#### **Community impact**

12. Any decision may have an impact on the local community.

#### **Environmental Impact**

13. This report is in relation to a premises license under the Licensing Act 2003 and as such there are minimal environmental impacts for the council.

#### **Equality duty**

14. Under section 149 of the Equality Act 2010, the 'general duty' on public authorities is set out as follows:

A public authority must, in the exercise of its functions, have due regard to the need to -

- a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it:
- c) Foster good relations between persons who share a relevant protected characteristic and persons who do not share it.
- 15. There are no equality issues in relation to the content of this report.
- 16. This report has human rights implications for both the premises licence holder and the residents from the local neighbourhood. Any of the steps outlined in section 1 of this report may have financial implications for a licensee's business and livelihood and/or may have impact upon the day to day lives of residents living in close proximity to the premises.
- 17. Article 8(i) of the European Convention of Human Rights provides that everyone has the right to respect for his/her private and family life and his/her home (which includes business premises). This right may be interfered with by the council on a number of grounds including the protection of rights and freedoms of others. The First Protocol Article 1 also provides that every person is entitled to the peaceful enjoyment of his possessions and shall not be deprived of his possessions except in the public interest and conditions provided for by law. Members must accordingly make a decision which is proportionate to the hearing and endeavour to find a balance between the rights of the applicant, residents and the community as a whole.

#### **Resource implications**

18. This report is in relation to a premises license under the Licensing Act 2003 and as such there are minimal resource implications for the council.

# Financial implications

19. There are unlikely to be any financial implications for the council as licensing authority at this time.

#### Legal implications

- 20. As relevant representations have been received, the sub committee must determine the application under Section 3.5.7 (c) of the Herefordshire Council constitution. The representations must relate to the licensing objectives and the sub committee must determine the likely effect of the grant of the premises licences on the promotion of the licensing objectives.
- 21. The licensing authority must have regard to the promotion of the four licensing objectives namely; the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm in exercising its functions under the Licensing Act 2003. Further regard should be had to the statutory guidance under Section 182 of the Act and the Council's own statement of licensing policy. The options available to the licensing authority are set out in section 1 of this report.
- 22. The sub committee should be aware of a number of stated cases which have appeared before the Administrative Court and are binding on the Licensing Authority.
- 23. The case of Daniel Thwaites Plc v Wirral Borough Magistrates' Court (Case No: CO/5533/2006) at the High Court of Justice Queen's Bench Division Administrative Court on 6 May 2008, [2008] EWHC 838 (Admin), 2008 WL 1968943, Before the Honourable Mrs Justice Black. In this case it was summed up that: -
- 24. A licensing authority must have regard to guidance issued by the Secretary of State under section 182. Licensing authorities may depart from it if they have reason to do so but will need to give full reasons for their actions.
- 25. Furthermore the Thwaites case established that only conditions should be attached to a licence with a view to promoting the Licensing objectives and that 'real evidence' must be presented to support the reason for imposing these conditions.
- 26. This judgement is further supported in the case of The Queen on the Application of Bristol Council v Bristol Magistrates' Court, CO/6920/2008 High Court of Justice Queen's Bench Division The Administrative Court, 24 February 2009, [2009] EWHC 625 (Admin) 2009 WL 648859 in which it was said:
  - 'Licensing authorities should only impose conditions which are necessary and proportionate for the promotion for licensing objectives'.
- 27. In addition to this it was stated that any condition attached to the licence should be an enforceable condition.

# **Right of Appeal**

- 28. Schedule 5, Part 1, Section 1 of the Licensing Act 2003 gives a right of appeal which states:
  - Rejection of applications relating to premises licences
  - (1) Where a licensing authority-
    - (a) Rejects an application for a premises licence under section 18,

. . . .

The applicant may appeal against the decision.

Schedule 5, Part 1, Section 2 of the Licensing Act give a right of appeal which states:

Decision to grant premises licence or impose conditions etc.

- (1) This paragraph applies where a licensing authority grants a premises licence under section 18.
- (2) The holder of the licence may appeal against any decision—
  - (a) to impose conditions on the licence under subsection (2)(a) or (3)(b) of that section, or
  - (b) to take any step mentioned in subsection (4)(b) or (c) of that section (exclusion of licensable activity or refusal to specify person as premises supervisor).
- (3) Where a person who made relevant representations in relation to the application desires to contend—
  - (a) that the licence ought not to have been granted, or
  - (b) that, on granting the licence, the licensing authority ought to have imposed different or additional conditions, or to have taken a step mentioned in subsection (4)(b) or (c) of that section, he may appeal against the decision.
- (4) In sub-paragraph (3) "relevant representations" has the meaning given in section 18(6).
- 29. Appeals should be made to the Magistrates Court and must be made within 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision appealed against

#### Risk management

30. There is little risk associated with the decision at this time as the legislation allows a right of appeal to the Magistrates Court within a period of 21 days of being notified of the decision in writing.

#### b) The prevention of crime and disorder

The Premises Licence Holder shall install and maintain a CCTV system at the premises giving coverage at all entry points and areas to which customers have access.

The CCTV system shall provide clear images in all lighting conditions.

The policy shall be produced on demand of an authorised person' (as defined by Section 13 of the Licensing Act 2003) or the police or an authorised Trading Standards Officer of Herefordshire Council. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any bar advertising the scheme operated.

A written register of refusals will be kept including a description of the people who have been unable to provide required Identification to prove their age. Such records shall be kept for a period of 12 months and will be collected on a daily basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.

No adult entertainment or services or activities must take place at the premises (Adult Entertainment includes, but is not restricted to, such entertainment or services which would generally include topless bar staff, striptease, lap-table, or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong and offensive language).

#### Internet Sales Purchase

Prior to purchasing alcohol on line the purchaser shall be required to confirm that they are aged 18 years old or over. The website shall contain a statement to the effect 'The company will not deliver alcohol to any person until it has been verified that the person is over 18 years of age'.

The Premises Licence Holder shall ensure that any person who purchases from the site shall register with the site. 

All staff engaged in the sale of alcohol to be trained in responsible alcohol retailing to the minimum standard of BIIAB Level 1 or any equivalent training course within 1 month of commencing employment at the premises. No person shall be authorised to sell or supply alcohol until this training is completed. Refresher training will be conducted at 12 monthly intervals. Training records shall be kept on the premises and produced to the police of an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.

An incident log must be kept at the premises, and made immediately available on request to an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or the Police, which must record the following:

- (a) all crimes reported to the venue (where relevant to licensing objectives)
- (b) any incidents of disorder (where relevant to the licensing objectives)
- (c) any visit by a relevant authority or emergency service
- (d) any faults in the CCTV system or searching equipment or scanning equipment

A First Aid Kit capable of treating for 21-50 people shall be kept fully stocked at the premises and kept behind the bar. Such kit shall contain:

### The prevention of public nuisance

'Noise' from the premises must not be 'audible or discernible' within any occupied permanent structure where people normally reside or sleep, when assessed with windows and doors closed. 'In this conditions; 'Noise' -is defined as sound which is created by entertainment consisting of either vocal (recorded or live) or instrumental music (recorded or live) or a combination of both. Audible or discernible' -is defined as 'noise' which is distinct above the general hubbub of activity on the site which can be identified by the human ear as originating from discrete sources from the licensed premises'.

The Premises Licence Holder or DPS or the responsible person must immediately comply

with any request to adjust noise levels/ frequency spectra made by an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or the Police

#### The protection of children from harm

The premises shall operate a Challenge 25 Policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of an authorised person' (as defined by Section 13 of the Licensing Act 2003) or the police or an authorised Trading Standards Officer of Herefordshire Council. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any bar advertising the scheme operated.

A written register of refusals will be kept including a description of the people who have been unable to provide required Identification to prove their age. Such records shall be kept for a period of 12 months and will be collected on a daily basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.

No adult entertainment or services or activities must take place at the premises (Adult Entertainment includes, but is not restricted to, such entertainment or services which would generally include topless bar staff, striptease, lap-table, or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong and offensive language).

#### Internet Sales Purchase

Prior to purchasing alcohol on line the purchaser shall be required to confirm that they are aged 18 years old or over. The website shall contain a statement to the effect 'The company will not deliver alcohol to any person until it has been verified that the person is over 18 years of age'.

The Premises Licence Holder shall ensure that any person who purchases from the site shall register with the site. Such registration details shall include the person's full name, full address and phone number. Records of such checks shall be kept for a period of 12 months and shall be produced on demand of the Police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council.

The person delivering the alcohol to the premises shall operate a Challenge 25 policy and shall require proof of age prior to the alcohol being handed over. No alcohol shall be handed over to a person under 18. The only acceptable proof of identity shall be a photographic driver's licence, a passport or an Identity Card containing the PASS Hologram. The website shall contain a declaration to this effect.

The terms and conditions of the company website will contain the following: -

- a) The company will not sell alcohol to any person until it has been verified that the person is over 18 years of age.
- b) An age confirmation requirement when registering to purchase.
- c) The only payment acceptable shall be 'PayPal' or bank payment card or any other similar type of payment which requires the person to be aged 18 years old or over to obtain such method of payment.
- d) Reference to the operating of a Challenge 25 policy.
- e) That no parcels will be left by the courier if the person at the delivery address is under 18 years of age.

I am writing to strongly object to the above application for the following reasons;

The area is within an A.O.N.B which needs to be preserved. The applicant intends to hold entertainment outside where lighting will be required. There is also a 'beer garden' suggested which will be across the farmyard and adjacent to two houses. This too will need to be lit for safety. At present the area is dark and should remain so for the protection of nocturnal species which have been recorded close by. There needs to be a protection of 'dark skies'.

There is one single track lane which leads to the farm. It is unlit and has no pavements. Another safety issue for people. There will also be late night traffic which WILL disturb villagers. If glass receptacles are used then this is an issue for livestock and children or if plastic is used then the usual litter will enter the surrounding area as purchasers tend to walk further away from site if there isn't a need for returns. It does not matter whether it's biodegradable or otherwise. Farms have always been noted as areas of safety concern due to the machinery used. The 'pub' is in the centre of a working farm.

The hours suggested are too extensive which will have a big impact on the serenity of the village. For the selling of wine, beer and food they do not need to be in the evening. Even the slightest conversation can be heard in the quiet of the moment. Any extension of this will be detrimental to the enjoyment of the area. The noise doesn't cease after the licencing hours end.

Not sure who the 'pub' is for. The village were only made aware of this application by the single A4 notice. It is not for the enjoyment of the village community yet they will face the disruption caused.

There are plenty of public houses and entertainment within Ross-on-Wye where safety and disturbance is easier to manage.

My representation is based on the need to Protect Public Nuisance and Public Safety.

### **Community Venture**

This application is sought as a Community amenity. No residents have been canvassed and asked if this is something they would want in the village. We already have a Village Hall that acts as a community hub, for a small hamlet. The Village Hall has recently undergone a complete

refurbishment at a cost to local residents as an Annual Precept payment on their Council Tax. Residents have a financial vested interest in supporting their Village Hall.

### **Public Safety**

If this application is accepted it will draw in more traffic from the surrounding area. There is one narrow winding road that leads to The Byers, with increased traffic late at night and during the day there is potential for public safety on the road to be compromised. There are no pavements or street lighting, nor should there be in a hamlet of this size in an AONB, so both pedestrians and drivers, as well as wildlife, would be at high risk.

Brampton Abbotts lies in the Wye Valley AONB, it is a very rural community and does not lend itself to this type of enterprise.

### **Noise Pollution**

The application asks for permission to play live and recorded music during the stated opening hours. The venues would not be sound proofed and the music played inside and outdoors would travel to properties nearby.

This became very evident over the August BH weekend when the music from the Wye Fest in Ross on Wye could be heard over that weekend. The sound travelled over a couple of miles and could be heard indoors, even with doors and windows closed and the television on.

Recently the Hope and Anchor pub in Ross has been asked to cease playing live music as this has caused a disturbance for neighbours.

The playing of live music at venues has increasingly become a nuisance for those residents living near the venues. In Brampton Abbotts, people have moved to the area for its beautiful countryside and peace and quiet and do not want this to change.

### **Over Extended Trading Hours**

The application ask permission for 3 nights per week, Friday, Saturday and Sunday, as well as Bank Holidays and other festive occasions.

This demonstrates that the applicant sees his venture as a commercial business venture, and not a one off event each year. As a commercial event it would be of economic benefit to the applicant alone and not to the Community. I understand that the farming community need to look at ways of diversifying, but this venture would be at the compromise of the local community and the rural environment we live in.

As a resident of Brampton Abbotts, I see myself as a custodian of the character of the hamlet for the present and to make sure that future residents can enjoy the rural aspect as I have. To allow this application to go forward would compromise the character of Brampton Abbotts, as one local resident said 'Glastonbury' started life as a small venue on a local farm and look at it now the biggest festival in the world. Our hamlet would not be able to sustain this possible growth in the future, so we must protect it now. I would ask that you do just that by refusing this application.

Please do not grant an alcohol/entertainment licence for this applicant.

- 1. The ambient noise levels in the village are very low, especially at night and would suffer greatly from a large increase in noise pollution. From previous events of live music held in the structure labelled as the 'School' the noise levels are invasive from our dwelling's location. Music could still be heard with the windows shut. Also, the application is very loose in the specifying where 'outdoor' events may occur, this could be even more noise invasive than the indoor venue.
- 2. The frequency and time duration on the application is excessive.
- 3. Traffic arriving and departing events is along a no through road which is tortuous and predominantly single-track lane with no pavements or lighting increasing the risk of accident to pedestrians and traffic alike. Late night traffic would be disturbing to residents with the increased probability of driving under the influence of alcohol.
- 4. As lighting conditions are stipulated by ecology reports for local planning applications, there is a need to keep light pollution to a minimum. Lighting would need to be provided for the venue during night time events (even during summer as the finish times are so late) for health and safety reasons, this would be at the cost of disturbing the local fauna.
- 5. A risk assessment would need to be fully evaluated and mitigating measures applied as the area defined is the hub of a working form with farm machinery either transiting or parked. Various other structures may also present a hazard. In addition, the farmyard is the access to a residence at the 'Cotts' and holiday let at the 'Old Brampton Barn' and a public right of way.

In summary I do not believe there would, on balance, be a positive effect to the local community/residents of Brampton Abbotts and would have a detrimental effect to the village with the prospect of regular disturbing events. The application is too wide ranging with the opportunity for 'feature creep' and does not contain enough detail for myself to come to any conclusion but to object.

I do appreciate the need for farms to diversify to remain profitable and Townsend Farm is certainly pioneering as it does have an impressive portfolio of revenue streams.

My representation based on the need to Prevent Public Nuisance. My key points are:

### Community Venture.

The application is sought as a Community amenity. Yet no residents have been canvases to see if this is something they would want in the village. We already have a Village hall that acts as a Community Hub. The Village Hall has recently been refurbished and part of the cost of this has fallen on the residents as an Annual Precept payment on Council Tax. Why would we want something else to act as a Community Centre.

### Increased Traffic on the Roads - Public Safety

The roads leading to the farm are narrow and would not be suitable for the increased level of traffic that could be generated by this activity, with visitors coming from outside of the local village community. There are no pavements and no street lighting and this would add to a danger to pedestrians, other drivers, and local wildlife.

As Brampton Abbotts lies in an AONB area it would be unreasonable to have street lighting adding to the light pollution that already exists.

### **Noise Pollution - Public Nuisance**

My main objection is on the grounds of Noise Pollution. The playing of live or recorded music in spaces that are not totally soundproofed, would have the music travelling across to adjacent properties.

Just this last weekend music was heard each night over the BH weekend from Ross on Wye that was hosting the Wye Fest. This could be heard indoors over the sound of our television, with our double glazed windows closed.

I have also heard that a local pub, The Hope and Anchor, in Ross on Wye has been asked to stop playing live music as local residents nearby have complained. In Brampton Abbotts any sound from music would travel and be intolerable.

### **Over Extended Trading Hours - Public Nuisance**

The application asks for permission to open for 3 nights a week, Friday, Saturday and Sunday as well as BH Sundays and Mondays and other festive dates. This is not a one off event to happen once a year but a full time business venture that does not sit comfortably in this rural environment.

There is already a small honesty shop on the site and farm produce and other local produce is sold there. So I see no need for a further site to be used for the sale of local produce and in particular alcohol to be consumed on the premises.

As a resident I see myself as custodian of the character of the village while I live in it. I would not want to see this venture go ahead and potentially open up in the future to become a venue for music festivals . And if this application is accepted that is what we could see happen. As one resident said this is how "Glastonbury" started all those years ago, and now look at it!

I hope that my points will be considered and that the application will be denied. I have no suggested conditions.

The licensing application from Townsend Farm states, and I quote, "not your standard pub, more a community offering where we are hoping to provide a community gathering for some home produced beer, wine and food". This is a very laudable statement. Yet, to make any success of the venture there will be a desire to attract as many people as possible. The applicant may say no, but there will be nothing, if the licence is granted, to stop expansion of events based on the hours and days requested. Remember once a licence is granted it is valid indefinitely.

To submit for approval for music and the selling of alcohol on every Friday, Saturday and Sunday plus Bank Holidays, Christmas Eve, New Years Eve and Valentine's Day is not aimed at those of the community if we use the word community in a true sense. This looks to be the start of a large business.

There are a number of issues to consider.

With all these gatherings and music events comes the need for lighting to cover the proposed entertainment areas for safety and therefore general light pollution. Which in a small village with beautiful surroundings just goes against the idea of rural.


We must assume that this venture will be successful, and therefore those attending will bring increased traffic both pedestrian and vehicular along the single track lane that constitutes the only access to the farm. The lane is narrow and twisty from the junction of Ross Road and not designed for heavy traffic flow. There is no pavement, kerbs or street lighting. Imagine the traffic leaving the farm at 1 O'clock in the morning on New Years Day.

The live and recorded music the application asks to play is for every Friday, Saturday and Sunday plus Bank Holidays, Christmas Eve, New Years Eve and Valentine's Day. This is a quiet village that people walk through as part of the Herefordshire Trail and it is an Area Of Outstanding Natural Beauty The last thing needed is the annoyance of music heard every weekend which will be licenced to begin at midday and not finish until 1 O'clock in the morning. Did we not choose to live here because of the quiet environment? There is extensive and varied entertainment to be found in Ross, Ledbury and Hereford.





- 1. There is no doubt that the noise from this location would affect the entire parish. Noise pollution is already experienced within the parish, from events held in Rosson-Wye, so given the proximity, the impact if this were to go ahead would be considerable.
- 2. Based on the detail within the application, the granting of a licence could result in

- 160 events per annum. This is excessive for such a small parish and inappropriate for the location.
- 3. Although the music may end at 22.00 there will continue to be noise associated with the attendees either remaining for a period of time, or leaving, so the total timeframe for noise and disruption would be much longer than that detailed in the application.
- 4. There are dwellings in very close proximity to the site, two of which are right next door
- 5. The parish falls within the AONB, visited and enjoyed for its beauty and tranquillity and its abundance of wildlife, all of which would likely be significantly negatively impacted by this proposal.
- 6. In official terms, noise may be assessed based on impact when windows and doors are closed, but in reality, throughout the spring / summer, residents will have their windows open, and will want to (and indeed should be able to) enjoy their gardens, and the impact on local residents should therefore be assessed on that basis.
- 7. There is a lack if detail as to the proposals for the site as a whole, the barn itself is open sided in places.

### **Light Pollution:**

1. There is, particularly within AONBs a desire to encourage a reduction in light pollution and a move towards "dark skies" in rural areas, not only to reduce emissions but also to help provide suitable habitats for wildlife. Given the size of the site and the dispersal of attendance between various structures, the proposal would result in an unacceptable light pollution effect.

### Highways:

- 1. With only one road in and out of the village, there is simply no capability to accommodate the significant numbers of additional vehicles suggested within the application.
- 2. The local roads are narrow country lanes with occasional passing places, able to accommodate the cars associated with the properties currently in situ. It is simply not feasible for dozens, or potentially hundreds for larger events, of additional vehicles to use this limited infrastructure 3 days per week, day and night, throughout the year, without a significant negative impact on local residents being experienced.
- 3. There is no reference to how the existing site as identified will be adapted to accommodate the events, including car parking

The NDP for the Parish supports proposals for the development of small-scale business enterprises suitable to a rural area such as this, where there is a lack of facilities/infrastructure that take account of the road system, and they do not have a significant adverse impact on the valued landscape (AONB) or rural character of the Neighbourhood Development Plan area, its residential amenity, infrastructure or traffic (both volume and size) or tranquillity. The NDP may apply to planning applications, but it still shows the concerns of the Parish in respect of maintaining its unique nature and tranquillity.

We have been given sight of your objection to our application which understandably we are disappointed about.

The application is to allow us to have

### Live & Recorded Music (Indoors/Outdoors),

Friday 18:00 - 21:00, Saturday 13:00 - 22:00, Sunday 15:00 - 19:00

### Sale/Supply of Alcohol (consumption on and off the premises)

Friday 15:00 – 22:00, Saturday 13:00 – 23:00, Sunday 13:00 – 20:00

#### **Non-Standard Timings:**

Bank Holiday Sunday's 12:00-22:00, Bank Holiday Monday's 12:00-19:00, Christmas Eve 12:00-23:00, New Year's Eve 12:00-01:00 Valentine's Day 12:00-23:00 Late Night Refreshment (Indoors/Outdoors) New Year's Eve 23:00-01:00

As you can see, we do not require the licence every day of the week, we are intending to hold community gatherings, supplying regenerative produced food on our farm, also the wine from our vineyard and beer from our brewery to hold not only functions celebrating local produce but also the celebration of the AONB in which we live in which there were so many concerns. Thankfully I am only one of two AONB specialist demonstration farms in the UK working closely with them to develop the FIPL (Farming In Protected Landscapes) program of sustainable farming for people, history, knowledge exchange, the environment and food and for every reason have liaised with them about our proposals.

It would also be useful to know the operating hours are based on the maximum (according to licensing laws of which we do not want to fall foul due to the duty of care of a a licence) meaning that very little music is intended and when it is we were thinking of a lone acoustic guitar or carol singers at Christmas - not continuous live bands and music festivals (however all live music needs to be covered to uphold the law) The same for recorded music, if the lone guitarists have a recorded backing track, or wants to play low level music between a set, then the law requires an obligation to have a recorded music licence.

It was our intention to have a walking tour of the farm once a week during the summer (Friday evenings) and once a month during the winter, however it was also realised having only a Friday licence would compromise ourselves if for whatever reason a Saturday or Sunday was required instead of a Friday.

Townsend farm and my world wide consultancy reputation on regenerative agriculture would be totally and utterly compromised if whilst trying to farm with the environment, I had 160 live loud music events during the year.

I am more than happy to discuss conditions in terms of music as it seems what we have envisaged and the objections are wildly off the mark and surprised that the ethos of the farm and it's huge national and international reputation hasn't been understood well enough to realise the intention was to comply with the law and not to cause a nuisance of any type.

It is not our intention to bring increased noise/issues or cause any disturbance to our neighbours.

These are the conditions attached to our licence in relation to public nuisance that we will have to abide by when the licence is in operation. I hope these go to somewhat alleviate your concerns

### **Prevention of Crime & Disorder**

The Premises Licence Holder shall install and maintain a CCTV system at the premises giving coverage at all entry points and areas to which customers have access.

The CCTV system shall provide clear images in all lighting conditions.

The CCTV system shall continuously record whilst the premises are open for licensable activities a nd shall be capable of providing frontal identification of customers.

All CCTV recordings shall be retained for a minimum of 31 days and shall be date and time stamped. CCTV recordings should be made available for inspection upon receipt of a request by the Police and/or Authorised Officer of the Licensing Authority.

A member of staff shall always be present on the premises whilst they are open who is capable of operating the CCTV system and able to facilitate immediate viewing of CCTV footage upon the request of the Police and Authorised Officer of the Licensing Authority.

All staff engaged in the sale of alcohol to be trained in responsible alcohol retailing to the mi nimum standard of BIIAB Level 1 or any equivalent training course within 1 month of commencing employment at the premises. No person shall be authorised to sell or supply alcohol until this training is completed. Refresher training will be conducted at 12 monthly intervals. Training records shall be kept on the premises and produced to the police of an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.

An incident log must be kept at the premises, and made immediately available on request to an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or the Police, which must record the following:

- (a) all crimes reported to the venue (where relevant to licensing objectives)
- (b) any incidents of disorder (where relevant to the licensing objectives)
- (c) any visit by a relevant authority or emergency service
- (d) any faults in the CCTV system or searching equipment or scanning equipment

#### **Public Safety**

First aid

A First Aid Kit capable of treating for 21-50 people shall be kept fully stocked at the premises and kept behind the bar. Such kit shall contain:

1 x Guidance Leaflet

60 x Washproof Plasters

6 x Eye Pads with Bandage 8 x Triangular Bandages 12 x Safety Pins

16 x Assorted Sterile Dressings 20 Moist Wipes 3 Pairs Disposable Gloves

#### **Prevention of Public Nuisance**

Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to the premises requesting the public to respect the needs of local residents and to leave the premises and the area quietly.

'Noise' from the premises must not be 'audible or discernible' within any occupied permanent structure where people normally reside or sleep, when assessed with windows and doors closed. 'In this conditions; 'Noise' -is defined as sound which is created by entertainment consisting of either vocal (recorded or live) or instrumental music (recorded or live) or a combination of both. Audible or discernible' -is defined as 'noise' which is distinct above the general hubbub of activity on the site which can be identified by the human ear as originating from discrete sources from the licensed premises'.

The Premises Licence Holder or DPS or the responsible person must immediately comply with any request to adjust noise levels/ frequency spectra made by an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or the Police

Noise or vibration shall not emanate from the premises so as to cause a nuisance.

All doors and windows at the premises shall be kept closed after 2200 hours except during immediate access and egress.

Live or Recorded music shall be restricted to the area marked on the premises plan

Outside tables and chairs shall be rendered unusable by 22.00 hours each day.

Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to any beer garden, patio area, smoking area or similar, requesting the public to respect the needs of local residents and to be quiet

### **Protection of Children from Harm**

The premises shall operate a Challenge 25 Policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of an authorised person' (as defined by Section 13 of the Licensing Act 2003) or the police or an authorised Trading Standards Officer of Herefordshire Council. Prominent, clear and legible signage (in not less than 32 font bold) shall also be displayed at all entrances to the premises as well as at, at least one location behind any bar advertising the scheme operated.

A written register of refusals will be kept including a description of the people who have been unable to provide required Identification to prove their age. Such records shall be kept for a period of 12 months and will be collected on a daily basis by the Designated Premises Supervisor and produced to the police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council on demand.

No adult entertainment or services or activities must take place at the premises (Adult Entertainment includes, but is not restricted to, such entertainment or services which would generally include topless bar staff, striptease, lap-table, or pole-dancing, performances involving feigned violence or horrific incidents, feigned or actual sexual acts or fetishism, or entertainment involving strong and offensive language).

#### **Internet Sales Purchase**

Prior to purchasing alcohol on line the purchaser shall be required to confirm that they are aged 18 years old or over. The website shall contain a statement to the effect 'The company will not deliver alcohol to any person until it has been verified that the person is over 18 years of age'.

The Premises Licence Holder shall ensure that any person who purchases from the site shall register with the site. Such registration details shall include the person's full name, full address and phone number. Records of such checks shall be kept for a period of 12 months and shall be produced on demand of the Police or an 'authorised person' (as defined by Section 13 of the Licensing Act 2003) or an authorised Trading Standards Officer of Herefordshire Council.

The person delivering the alcohol to the premises shall operate a Challenge 25 policy and shall require proof of age prior to the alcohol being handed over. No alcohol shall be handed over to a person under 18. The only acceptable proof of identity shall be a photographic driver's licence, a passport or an Identity Card containing the PASS Hologram. The website shall contain a declaration to this effect.

The terms and conditions of the company website will contain the following: -

- a) The company will not sell alcohol to any person until it has been verified that the person is over 18 years of age.
- b) An age confirmation requirement when registering to purchase.
- c) The only payment acceptable shall be 'PayPal' or bank payment card or any other similar type of payment which requires the person to be aged 18 years old or over to obtain such method of payment.
- d) Reference to the operating of a Challenge 25 policy.
- e) That no parcels will be left by the courier if the person at the delivery address is under 18 years of age.
