Members of the Licensing Panel of the Council's Regulatory Committee considered the above application, full details of which appeared before the Members in their agenda and the background papers.

Prior to making their decision, the Members heard from Mr. Bedford as well as Mr and Mrs. Walker, local residents who objected to the application.

Having carefully considered those matters brought before them, the Committee were of the opinion that the application should be **granted subject** to the conditions appearing below. In reaching their decision, the Members had full regard to both the provisions of the Licensing Act 2003 and the Council's Licensing Policy. The Members imposed conditions in order to promote the four licensing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

REMOVAL OF CONDITIONS

The following conditions were removed:

- That the premises licence is on the premises at all times for any licensable activity
- To remove the need for SIA door supervisors to be on duty Fridays and Saturdays at the minimum ratio of 2 plus 1 per 100 from 20.00 hours on all dates when they are authorised for the retail of alcohol after 00.00
- Last entry time of 00.00
- All windows and doors to be kept closed during entertainment and not propped open
- No under 18's after 21.00
- No entry after 00.00
- SIA door supervisors to ensure that customers leave the outlet quietly

A request to remove the following condition was noted but rejected by the sub-committee:

- Prevention of open containers being removed from the premises

The following conditions replaced the removed conditions:

- No new entry after 00:00
- That the DPS carry out a risk assessment for each function or event and based on that risk assessment provides SIA registered door supervisors
- All windows shall be kept closed after 22:00 hours when amplified sound is provided on the premises
- Children must be accompanied by an adult at all times and shall not be permitted on the premises after 22:30 hours
