Members of the Licensing Panel of the Council's Regulatory Committee considered the above application, full details of which appeared before the Members in their agenda and the background papers.

Prior to making their decision, the Members heard from Mr Granger, the applicant, together with PC Thomas, representing West Mercia Constabulary.

Having carefully considered those matters brought before them, the Committee were of the opinion that the application should be **granted subject** to the conditions below. In reaching their decision, the Members had full regard to the representations (including supporting information) presented by all parties, the guidance issued to local authorities under Section 182 of the Licensing Act 2003, the Herefordshire Council Licensing Policy and the provisions of the Licensing Act 2003. The Members imposed conditions in order to promote the four licensing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

### NON STANDARD TIMINGS

The application for supply of alcohol from 6.00 am from September to January was granted as requested.

# CONDITIONS

- The application was granted in respect of the hours of operation of the licensable activities described in the box above together with the following conditions
- The mandatory conditions of The Licensing Act 2003.
- All conditions offered by the applicant under section P of the application form.
- A responsible person must be available on the premises at all times that they are open to the public. This person must comply with all reasonable requests made by a duly authorised officer of the licensing authority or the West Mercia Constabulary if it is considered by this duly authorised officer that one or more of the four licensing objectives are being compromised.
- Events involving any licensable activity and requiring the use of specialist contractors for the provision of staging and / or sound systems, or being attended by 1000 or more persons require an event management plan to be agreed with Environmental Health four weeks before the start of the event. The requirements of this event management plan must be complied with.

#### PREVENTION OF PUBLIC NUISANCE

- Noise or vibration must not emanate from the premises so as to interfere with the use or enjoyment of any neighbouring premises.
- Amplified music must not be played in the outdoor areas after 2300.
- Fireworks will be discharged before 2300 and advance notice will be given to neighbours.

### PUBLIC SAFETY

- A suitable and sufficient risk assessment must be recorded and maintained for the provision of licensable activities on the premises. The auctions and control measures identified in the risk assessment must be effectively implemented.
- Adequate systems must be in place to control numbers of persons entering the premises to prevent overcrowding and alleviate crowd control problems.
- The maximum number of persons inside the building attending at any one time must not exceed: Ballroom-100; Great Hall-76; Chapel-60; Library-87; Drawing Room-100; Restaurant-100.

#### **PROTECTION OF CHILDREN FROM HARM**

- There must be a lost procedure in place. Notices will display this information to the public.
- That 'Challenge 25' be made a condition for all age restricted sales made on the premises.

# PREVENTION OF CRIME AND DISORDER

- That SIA registered door supervisors are provided for all events on a risk assessed basis to be undertaken by the premise licence holder.
- For all large events (over 499 people) held outside the main castle premises, a separate risk assessment be completed, which will include details of any security measures in place.
